FOREWORD BY THE PRESIDENT



Dear reader,

The results we have achieved at the international and domestic level in 2017 factually confirm that this has been a very successful year for Montenegro and this convocation of the Parliament.

With the implementation of essential reforms, both from the domain of the rule of law and of economic and financial stability, stimulating growth and development Montenegro reaffirms its European orientation. We have demonstrated that, according to all parameters: political stability, economic criteria and constructive role in the region, and despite all challenges, we have kept the leading position in the European integration process.

The previous year of regular parliamentary work was certainly marked by a selective non-participation of the opposition in the activities of the Parliament and its working bodies. A year after the constitution of this convocation, a part of the opposition parties regularly returned to work in the Parliament of Montenegro.

With dedicated and committed work of both the MPs and the staff, the legal system of Montenegro has been significantly improved by harmonising Montenegrin legislation with the EU acquis. More specifically, in 2017 the Parliament of Montenegro held 24 sittings of ordinary and three of the extraordinary session, during which 134 laws were adopted. Seven special sittings of the Parliament were dedicated to the Prime Minister's hour and parliamentary questions. In this period, the working bodies of the Parliament of Montenegro held 244 meetings.

Within the oversight role, working bodies of the Parliament conducted 44 control and consultative hearings of representatives of state bodies and other persons. Active cooperation

with students, the civil sector, the media as well as relevant international organisations has continued, aimed at making them better informed and more involved in the work of the Parliament of Montenegro.

This convocation of the Parliament and us its members were assigned a historic role to ratify Montenegro's NATO membership with our votes. Thereby we fulfilled one of the two promised strategic foreign policy priorities, returned Montenegro historically and culturally to its rightful place – the company of the most developed democracies.

We have obtained international recognition for our accomplishments and encouragement to continue with undertaking further reforms, but I would like to distinguish here the first visit to Montenegro by the President of the European Parliament Antonio Tajani, which was very significant to us. It was another testimony to the extraordinary relations of the Parliament of Montenegro with the European Parliament.

I am confident that all of the above is indicative of a serious, responsible and committed work of the Parliament of Montenegro in the previous year. It is our genuine intention and duty to also work in the next three years in such a way that befits the highest legislative institution and to justify our rating as one of the most open institutions in the region by constantly improving it. There will always be challenges present, but I am sure that Montenegro, and its Parliament, are ready to deal with them in a mature, responsible manner, with full respect for all its differences.

You have before you the 2017 Performance Report of the Parliament of Montenegro.

INTRODUCTION

This document contains information about the work of the Parliament of Montenegro in 2017.

Information on legislative and oversight activities of the Parliament and its working bodies, parliamentary cooperation, transparency of work, administrative capacities, the use of funds allocated by the budget of Montenegro, as well as other activities that marked 2017 are presented in six chapters. At the same time, the appendix include the list of laws adopted by the Parliament in this period, a tabular overview of spending, an overview of requests for free access to information, a list of research papers done in 2017 as well as a tabular overview of conducted trainings and specialisations.


Employees of all organisational units of the Parliamentary Service, in accordance with their responsibilities, were involved in the preparation of this report. Minutes from parliamentary sittings as well as reports and minutes from meetings of working bodies, and other reports were primarily used as resources. Presentation of data in the form of this report was prepared by the Educational Centre in cooperation with other organisational units of the Parliamentary Service.

All references in this text to natural persons in the masculine gender shall be deemed to include the feminine gender.

IN FIGURES

- A total of 221 acts were adopted, including 134 laws;
- 24 sittings of ordinary session and three sittings of extraordinary session were held;
- The Prime Minister was asked 26 and the members of the Government 179 questions;
- Working bodies of the Parliament held 244 meetings, in 245 days, for a total of 242 hours;
- Working bodies considered 733 items of the agenda, including 280 proposals for laws and 707 amendments;
- Working bodies held one control and 43 consultative hearings in their meetings;
- 1222 pieces of information and 500 announcements illustrated with over 5000 photographs were published;
- 142 hours and 33 minutes of programme was produced;
- A total of 295 permanent credentials for journalists and camera crews/photo-reporters were issued, as well as 292 daily credentials;
- 109 individual journalists' questions were processed and answered;
- A total of 94 requests for free access to information were submitted;
- 18 research papers were prepared and published, and around 95 queries by national parliaments of other countries were responded to;
- 144 democracy workshops were hosted, with 3184 students and 180 teachers;
- On 31 December, 164 persons were employed in the Parliamentary Service.



1.3. PRESIDENT AND VICE PRESIDENTS OF THE PARLIAMENT OF MONTENEGRO IN 2017

At the First - Constitutive Sitting of the Second Ordinary (Autumn) Session of the 26th Parliament of Montenegro, held on 24 November 2016, Ivan Brajović was elected President of the 26th Parliament of Montenegro.

At the same sitting, Branimir Gvozdenović and Genci Nimanbegu were elected vice presidents of the 26th Parliament of Montenegro.

At the Third Sitting of the First Ordinary (Spring) Session of the Parliament of Montenegro, held on 30 March 2017, Mr Aleksandar Jovićević was elected Secretary General of the Parliament of Montenegro. At the same sitting, Mr Mersudin Gredić was appointed Deputy Secretary General of the Parliament of Montenegro.

At the Fifth Sitting of the Second Ordinary (Autumn) Session of the Parliament of Montenegro, held on 25 October 2017, Ms Marija Mirjačić was elected Secretary General of the Parliament of Montenegro.

II LEGISLATIVE AND OVERSIGHT ACTIVITY

In the reporting period, i.e. in the period from 1 January 2017 to 31 December 2017, a total of 24 sittings of the ordinary session and three sittings of the extraordinary session of the 26th Parliament of Montenegro were held, where a total of 221 acts were adopted, including 134 laws, of which 79 laws on amendments and supplements to laws (you can find the list of laws on page 69).

In the period from 1 January to 31 December 2017, a total of ten extraordinary sittings of the Parliament were held, of which eight dedicated to the Prime Minister's Hour and Parliamentary Questions. The Prime Minister was asked 26 questions, while the members of the Government were asked 179 questions.

In the same period, the working bodies of the Parliament of Montenegro held 244 meetings, in the course of 245 days, for a total of 242 hours, where 733 items of agenda were considered, including 280 proposals for laws and 707 amendments. In addition to the above, one control hearing and

43 consultative hearings were held at the working bodies meetings. Below are more detailed information on the work of the Parliament and other working bodies. The list of laws adopted in 2017 is set out in Appendix I.

2.1. SITTINGS OF THE PARLIAMENT

In the reporting period, i.e. in the period from 1 January 2017 to 31 December 2017, a total of 24 sittings of the ordinary session and three sittings of the extraordinary session of the 26th Parliament of Montenegro were held, where a total of 221 acts were adopted: 55 laws, 79 laws on amendments and supplements to laws, 12 decisions (of which one decision on the consideration of the Fiscal Strategy of Montenegro 2017-2020 and six decisions on the adoption of the financial plans of independent regulatory bodies), 38 decisions on elections, appointments and dismissals, as well as 37 conclusions.

2.1.1. PROPOSED ACTS

In the period from 1 January to 31 December 2017, the MPs submitted: two proposals for laws, 11 proposals for laws on amendments and supplements to laws, and three proposals for decisions.

In the same period, the Government submitted: 54 proposals for laws, 78 proposals for laws on amendments and supplements to laws, two proposals for decisions, nine reports, and the Proposal for the Montenegro Fiscal Strategy 2017-2020.

In this period, the citizens, via an authorised MP, did not submit proposals for laws.

In the period from 1 January to 31 December 2017, six laws were withdrawn from procedure, as follows: Proposal for the Law on Amendments to the Law on Protector of Human Rights and Freedoms of Montenegro; Proposal for the Law on Amendment to the Law on Higher Education; Proposal for the Law on Amendment to the Law on Administrative Dispute; Proposal for the Law on Supplement to the Bankruptcy Law; Proposal for the Law on Amendments to

the Bankruptcy Law and Proposal for the Law on Amendments to the 2017 Budget Law.

2.1.2. ADOPTED ACTS

In the period from 1 January to 31 December 2017, upon the proposal of MPs, the following was adopted: one law, six laws on amendments and supplements to laws, and three decisions.

In the same period, upon the Government's proposal, the following was adopted: 54 laws, 73 laws on amendments and supplements to the laws and two decisions.

In the period from 1 January to 31 December 2017, 47 laws and two decisions were adopted in summary procedure.

2.1.3. NUMBER OF CONSIDERED AND ACCEPTED AMENDMENTS TO THE PROPOSALS FOR ACTS

In the period 1 January – 31 December 2017, a total of 609 amendments submitted to proposals

for acts were considered at parliamentary sittings, of which 550 were accepted.

The committees submitted 471 amendments, of which 470 became integral part of the proposals for acts, as follows: Legislative Committee 286 amendments; Committee on Political System, Judiciary and Administration 26 amendments; Committee on Security and Defence ten amendments; Committee on International Relations and Emigrants four amendments; Committee on Economy, Finance and Budget 23 amendments (one withdrawn); Committee on Human Rights and Freedoms two amendments; Committee on Tourism, Agriculture, Ecology and Spatial Planning 95 amendments; Committee on Education, Science, Culture and Sports one amendment, and Committee on Health, Labour and Social Welfare 24 amendments.

The MPs submitted 138 amendments, of which 80 were accepted, 27 were not accepted, and 31 of them were withdrawn.

2.1.4. PRIME MINISTER'S HOUR AND PARLIAMENTARY QUESTIONS

In the period from 1 January to 31 December 2017, a total of eight extraordinary sittings of

the Parliament dedicated to the Prime Minister's Hour (three sittings) and Parliamentary Questions (five sittings) were held.

2.2. WORK OF THE WORKING BODIES

In 2017, the working bodies of the Parliament of Montenegro held 244 meetings, in the course of 245 days, for a total of 242 hours, where 733 items of agenda were considered, including 280 proposals for laws and 707 amendments.

During the reporting period, the **Committee on Human Rights and Freedoms** organised a conference on the occasion of the International Human Rights Day on the topic of "Rights of the Child, with emphasis on the protection of children from all forms of violence, in the light of the Campaign of the Government of Montenegro and UNICEF "Stop Violence" (8 December).

During the year, the Committee members also met with President of the Parliamentary Assembly of the Council of Europe Pedro Agramunt (16 March); with a member of parliament of the CDU/CSU faction at the German Bundestag Marian Wendt (4 April), as well as with Ambassador of the State of Palestine to Montenegro Mr Rabii Alhantouli (16 May). 2.2.3. TEMPORARY WORKING BODIES

On 10 October 2017, a Working Group was formed in the Parliament of Montenegro with the task of analysing the implementation of the electoral legislation, and on the basis of the OSCE/ODIHR Election Observation Mission Final Report on the parliamentary elections held on 16 October 2016,



considering and proposing the method of implementation of the recommendations from the said Report. Based on its establishment act, representatives of the parliamentary majority are represented in the Working Group, but it had been emphasised that the Working Group was open to representatives of the parliamentary opposition.

In 2017, the Working Group held 14 meetings. After deciding on the issues such as methodology and publicity of the work, the Working Group considered all the recommendations contained in the OSCE/ODIHR Final Report. In that respect, legal regulations that need to be amended have been identified, i.e. the institutions in charge of their implementation, and accordingly, an Action Plan for the implementation of the said recommendations has been adopted.


With the intention of contributing to strengthening the electoral process, , the Working group issued a public invitation to the interested subjects dealing with the issues of the electoral process to contribute - by their comments, proposals and suggestions - to the implementation of the recommendations contained in the said Report.

During the meetings of the Working Group, in the presence of representatives of the responsible institutions: Agency for Prevention of Corruption,

State Election Commission, Ministry of Interior, Ministry of Culture, Agency for Personal Data Protection and Free Access to Information, Agency for Electronic Media and State Audit Institution, all recommendation individually were explored. Representatives of institutions presented their views on the recommendations, while explaining their proposals, which they submitted to the Working Group, regarding the way in which the recommendations should be implemented. The Working Group also called for a meeting, i.e. held an interview with all other subjects that expressed interest and submitted their proposals in accordance with the methodology established by the Working Group, thus giving them the opportunity to explain their proposals and suggestions in detail.

Simultaneously, the Working Group began a detailed analysis and elaborated solutions proposed for the purpose of amending the law, or drafting a law. After considering presented proposals and suggestion, the Working Group agreed on the Draft Law on Amendments to the Law on Voter Register, and after that also the Draft Law on Amendments to the Law on Financing of Political Entities and Election Campaigns, Draft Law on Amendments to the Electronic Media Law and Draft Law on Amendments to the Law on Election of Councillors and MPs.





III INTERNATIONAL ACTIVITIES

3.1. EUROPEAN INTEGRATION

Montenegro has continued to actively comply with its obligations stemming from the negotiation process with the European Union, and to implement reforms aimed at achieving European standards.

The highest level of cooperation of the Parliament of Montenegro and the European Parliament is achieved through the work of the Stabilisation and Association Parliamentary Committee (SAPC). In the reporting period, the SAPC held two meetings, in Strasbourg on 14 June and in Podgorica on 18 December. Meeting in Strasbourg dealt with topics such as: state of play of the accession negotiations and EU-Montenegro relations, administering of parliamentary elections and the functioning of the Parliament, fundamental rights, social policy and employment, justice, freedom and security. At the meeting in Podgorica, parliamentarians discussed topics such as: state of play of the accession negotiations and EU-Montenegro relations, functioning of the Parliament and electoral reform ahead of the upcoming elections, track record in fight against corruption and organised crime, fundamental rights and freedoms, with focus on media freedom as well as on economy and public finance.

As for the progress in the negotiation process, two negotiation chapters were opened at the June InAs a Co-chair of the EU-Montenegro Stabilisation and Association Parliamentary Committee, President Brajović headed the Standing Delegation at the 13th SAPC Meeting in Strasbourg. Co-chairs Brajović and Kouroumbashev pointed out that each candidate country must be judged on its own merits in the terms of fulfilling the same set of criteria. They stated that Montenegro is currently the most advanced candidate country and that it should become a full-fledged member of the Union as soon as possible. The Co-Chairs stressed that it is critical for progress in the accession process to re-engage in a constructive, parliamentary dialogue. (SAPC, Strasbourg, 14 June 2017)

tergovernmental Conference in Brussels: 1 – Free movement of goods and 22 – Regional policy and coordination of structural instruments, while negotiations for Chapter 30 - External relations have been provisionally closed. Furthermore, at the December Intergovernmental Conference in Brussels held in Brussels, negotiations were opened for the chapters: 2 - Freedom of movement for workers and 3 - Right of establishment and freedom to provide services. Therefore, Montenegro has opened a total of 30 chapters, of which three are temporarily closed. In addition to this, the Committee on European Integration adopted in June the negotiation position for Chapter 17 - Economic and monetary

policy, and the period until the end of 2017 and next year will be dedicated to preparing for the opening of the remaining chapters, and fulfilling the criteria for closing certain chapters.

The parliamentary contribution to the European integration process was continued through the work of the Committee on European Integration, which reviewed several documents from the European integration process by 31 December 2017 (more details on p. 17).

When it comes to parliamentary diplomacy within the EU accession, members of the Parliament of Montenegro regularly participate in meetings organised within the EU presidency. In the reporting period, members of the Committee on European Integration participated in meetings of the Conference of Parliamentary Committees for Union Affairs (COSAC), namely at the meeting of chairpersons and plenary session held during the Maltese presidency (22-23 January and 28-30 May) and at the plenary session within the Estonian Presidency (26 and 27 November). Parliamentarians also participated in other meetings organised within presidency of the EU: Conference for the Common Foreign and Security Policy (CFSP) and the Common Security and Defence Policy (CSDP) (7-9 September); meeting of the chairpersons of economic affairs committees (21 and 22 September) and Conference on Stability, Economic Coordination and Governance in the European Union (SECG) (29-31 October).

Members and staff of the Parliament of Montenegro also participate in activities organised within Assistance programme of the European Parliament to help aspirant countries prepare for EU membership. In this regard, a delegation of the Committee on European Integration paid a study visit to Brussels in March, where it had a series of meetings with senior European officials within the European Parliament.

On the occasion of the 60th anniversary since signing the Treaties of Rome, when the European Economic Community (EEC) and Euratom were established, a delegation of the Committee on European Union Policies of the Italian Senate, headed by Vannino Chiti, visited Podgorica on 27 March 2017. On this occassion, Chairperson of the Committee Adrijan Vuksanović and Senator Vannino Chiti signed the Protocol on Cooperation of the Committee on European Integration of the Parliament of Montenegro and the Committee on European Union Policies of the Italian Senate. The significance of signing of this document was also reflected in the fact that Italy signed the Protocol on Cooperation, apart from Montenegro, only with parliaments of France and Spain and confirmed the commitment of the Parliament of Montenegro to concretise in the forthcoming period cooperation models between the two parliaments. Within the implementation of the project, the Committee delegation paid an official visit to institutions of the Republic of Italy, upon the invitation of the Italian Senate, in the period 5-7 December. The visit included a joint meeting of the two committees dealing with EU affairs, during which the Joint Declaration was adopted.

Inter-parliamentary conference "Independent and Modern Public Administration in the EU and in Enlargement Countries" was organised in September, with the participation of MEPs and members of the enlargement countries' parliaments. The Conference was organised by the EU Pre-Accession Actions Unit in cooperation with the Parliament of Montenegro and Regional School of Public Administration (ReSPA).

3.2. NATO INTEGRATION

At the Seventh Sitting of the First Ordinary Session of the 26th Parliament of Montenegro, held in Cetinje, on 28 April 2017, MPs voted in favour of the Proposal for the Law on Ratification of the North-Atlantic Treaty and the Protocol to the North-Atlantic Treaty on the Accession of Greece and Turkey. Montenegro became the 29th full member of NATO on 5 June 2017 when it deposited its instrument of accession at the Washington ceremony, while Montenegrin flag was raised at NATO Headquarters on 7 June.

On the occasion of Montenegro's membership in NATO and raising of Montenegrin flag in Brussels, President of the Parliament of Montenegro Ivan Brajović hosted an official reception at Villa "Gorica", while the building of the Parliament of Montenegro was lit up in the colours of Montenegrin and NATO flag.

Today, when Montenegrin flag has fluttered in Brussels among the flags of the most powerful countries in the world, this generation of politicians does not feel the taste of victory, but of responsibility and satisfaction that Montenegro - after decades of challenges and dilemmas - has returned home. Montenegro has returned where it had always belonged: to the family of progressive and democratic nations", President Brajović said.

3.3. ACTIVITIES OF THE PRESIDENT OF THE PARLIAMENT

VISITS BY FOREIGN OFFICIALS

President Brajović hosted numerous speakers of parliaments, parliamentarians and representatives of international organisations. Among these, a historic visit of the President of the European Parliament Antonio Tajani should be singled out. Also, having in mind the role and importance of the Parliamentary Assembly of the Council of Europe in strengthening democratic values of a country, President Brajović hosted President of that institution Pedro Agramunto. During the year, the President met with about 40 presidents of states and prime ministers, ministers and representatives of international organisations who came to visit Montenegro. He also had regular meetings with representatives of diplomatic corps.

Visit of High Representative of the Union for Foreign Affairs and Security Policy Federica Mogherini

During the visit, High Representative of the Union for Foreign Affairs Federica Mogherini addressed the Montenegrin parliamentarians, highlighted the incredible progress that Montenegro has made, and stressed that the EU door was open to Montenegro and the whole region. She added that believed that the path towards the European Union could be a powerful motivation to seek unity beyond political disagreements in Montenegro. (1 March 2017)

Speaking of elections, the interlocutors agreed the election results were clear and that there was a legitimately elected government in Montenegro. President Agramunt stressed that the first mistake was made by the opposition, because all the political parties should be in Parliament and not in the street, with the expectation that the dialogue between authorities and the opposition would be continued in the Parliament. The presidents emphasised the role of the Council of Europe at a time when the European continent was facing numerous challenges in terms of values and security. (16 March 2017)

Address by European Commissioner for European Neighbourhood Policy and Enlargement Negotiations Mr Johannes Hahn

Since assuming his office, President Brajović met Commissioner Hahn twice, in December 2016 and June 2017. President Brajović stressed that Montenegro was fully devoted to the EU membership, firmly committed to pursuing its reforms, in order to finalise the accession negotiations in a good manner and thus become the first next member of the EU. The interlocutors noted that the. Parliament must be a key place for political dialogue as a central place of democratic decision-making. (9 June 2017)



Visit by Mr Talat Xhaferi, Speaker of the Assembly of the Republic of Macedonia

They jointly noted that this visit, at the very beginning of the Speaker Xhaferi's office, was great contribution to further strengthening of inter-parliamentary cooperation, within friendship groups and committees. President Brajović assessed the constitution of government in Macedonia as very significant, because internal stability was important for the continuation of necessary reforms in order to secure the European and Euro-Atlantic future. Visit by Antonion Tajani, EP President

This was the first official visit of a President of the European Parliament to Montenegro, but at the same time also the first visit of EP President Antonio Tajani to a non-EU member state. During the visit, Mr Tajani said that Montenegro was important for the stability of the Balkans, as a state of multi-ethnic harmony, devoted to European integration and recognised for its good neighbourly politics. He particularly emphasised the importance of economic cooperation between Montenegro and the Member States of the European Union, which would be paid special attention to in the upcoming period. President Brajović stressed that the first visit by the EP President to Montenegro was a confirmation of the extraordinary relations of the Parliament of Montenegro with the European Parliament. (18 July 2017)

"This is my first official visit to a country outside the EU, since I was elected EP President. I am here in Montenegro to send a strong signal to all partners from the Western Balkans and I say that the EU is present and looks with great care on your European perspective (...) For EU it is important that Montenegro's elections were held in a regular manner, with the respect of all democratic rules. Meeting with Denis Zvizdić, Chairman of the Council of Ministers of BIH


Visit by Vice President of the National People's Political Advisory Congress of PR China Ma Peihua



During the meeting with heads of resident diplomatic missions in Podgorica, President of the Parliament Ivan Brajović presented the activities of the Parliament of Montenegro in the first year since the constitution of the 26th Parliament. He stressed that by committed and dedicated work of all representatives of citizens who participate in the work of the Parliament, greater efficiency has been achieved, there was no backlog of reports that were to be considered, there was no "pending" proposals for laws, while sittings where the prime minister and ministers answer to parliamentary questions were regularly held. He also presented the current and announced future activities related to raising the efficiency of the parliamentary service, which should respond adequately to the challenges of the modern the international community and a country worth staying in. Speaking about parliamentary elections, the Italian Ambassador said that great turnout at the elections also confirmed complete and rational trust in Montenegrin democracy, which was celebrating the tenth anniversary of its Constitution that very year. He said that that the ongoing boycott of parliamentary work, complete or selective - depending on the parties, was the reason for frequent queries and reflection within the diplomatic corps, and that the final report of the observation mission, among other things, recommended a set of measures and a change in norms, in order to further improve standards that already in October 2016 were at the level which is more than appropriate.

VISITS ABROAD

The 2017 was marked by intensive international cooperation. During ten official visits, international conferences and meetings of international organisations, President Ivan Brajović met with heads of states, parliaments and governments, as well as with numerous ministers and representatives of international organisations.

Visit to the Republic of Italy, Rome

On the occasion of adoption of the NATO Accession Protocol for Montenegro, President Brajović paid a working visit to the Republic of Italy. During the visit, he met Laura Boldrini, Speaker of the Italian Chamber of Deputies, a group of senators and Italian Deputy Minister of Foreign Affairs Vincenzo Amendola. President Boldrini praised the positive dynamics and quality in fulfilling the European obligations of Montenegro, stating that the ratification of the Protocol in the Italian Parliament was a fulfillment of common goals. Participation in the OSCE PA Winter Meeting, Vienna

President Brajović was heading a delegation of the Parliament of Montenegro at the Winter Meeting of the OSCE PA. Visit to the Republic of Serbia

During his official visit to the Republic of Serbia, President Brajović had meetings with Speaker of the National Assembly Maja Gojković, President Aleksandar Vučić, Prime Minister Ana Brnabić and First Deputy Prime Minister and Minister of Foreign Affairs Ivica Dačić. They noted that the communication between the Montenegrin and Serbian officials was regular, meaningful and of good quality, as well as that regional stability was a prerequisite for accelerated economic development. Significant attention was paid to the European perspective of Montenegro and Serbia, while President Brajović, on this occasion as well, emphasised our country's advocacy for the "regatta principle", or measuring individual performance of candidates for the EU membership. In Vojvodina, the delegation of the Parliament of Montenegro met with the Province's leadership, as well as with members of the Montenegrin Diaspora. Following the meeting, the exhibition "Collection of Paintings of the Parliament of Montenegro" was opened. There was also an organised visit to Lovćenac. Visit to the Republic of Georgia, Tbilisi

During his official visit to Georgia, President of the Parliament of Montenegro Ivan Brajović had meetings with Speaker of the Parliament Irakli Kobakhidze, President Giorgi Margvelashvili, Prime Minister Giorgi Kvirikashvili, and spoke at the International Parliamentary Conference "EU and Partners - Embracing Diversity for Stronger Unity". They estimated that excellent political cooperation represented a prerequisite for strengthening of cooperation in the field of economy and tourism. In the context of the European integration, President Brajović voiced the willingness of Montenegro, as a frontrunner in the process of accession

Visit to the Republic of Bulgaria, Sofia

President of the Parliament of Montenegro Ivan Brajović headed the Delegation of the Parliament of Montenegro in his first official visit to the Republic of Bulgaria, which had special significance bearing in mind the Bulgarian presidency of the Council of the European Union in the first half of 2018. At the meetings with Speaker of the National Assembly of the Republic of Bulgaria Tsveta Karayancheva, President of the Republic of Bulgaria Rumen Radev, Deputy Prime Minister and Minister of Foreign Affairs Ekaterina Zakharieva and Minister for the Bulgarian Presidency of the EU Liliana Pavlova, the interlocutors expressed expectation that the Bulgarian presidency of the Union, with emphasis on expanding to the Western Balkan countries and their connectivity, would be successful both for that country and for Montenegro. It was emphasised that Bulgaria would strongly advocate for Montenegro to open the remaining three negotiation chapters during their presidency. In addition to President Brajović, the delegation of the Parliament of Montenegro also consisted of members of the MNE - Bulgaria parliamentary Friendship Group, MPs Tarzan Milošević, as the Chair of the Group, and its members Andrija Popović and Mihailo Anđušić. 3.4. ACTIVITIES OF THE VICE PRESIDENTS OF THE PARLIAMENT

Numerous international activities of the vice presidents of the Parliament of Montenegro marked 2017. We would like to highlight the following below:

- On 6 February, Vice President Gvozdenović met with Ambassador of Hungary to Montenegro H.E. Krisztián Pósa, in Podgorica. The meeting assessed that the cooperation between Montenegro and Hungary was at a high level, primarily due to good economic relations, as well as strong support of Hungary to Euro-Atlantic and European integration of Montenegro. Additional incentive for intensifying, primarily economies relations, will be the establishment of direct flights between Podgorica and Budapest in April, given the fact that the Hungarian low-cost airline Wizz Air from April will have flights on relation Podgorica - Budapest during the whole year. Vice President Gvozdenović thanked to Ambassador Pósa for his personal contribution to the establishment of direct flights.
- On 8 February, Vice President Genci Nimanbegu received the delegation of the Foreign Affairs Committee of the Parliament of Albania, headed by its Chairperson Arta Dade. At the meeting, mutual pleasure was emphasised regarding the deve-

- lopment of relations between the two countries, and it was noted that there was a lot of potential for their improvement. Vice President Nimanbegu informed the delegation on the political developments in Montenegro, as well as the progress of our country in integration processes. Members of the Albanian delegation were informed about the long-time requests of Albanians in Montenegro, with regard to the final defining of the status of the Municipality of Tuzi, property restitution to its owners in Valdanos, status of the Ulcinj Salina, as well as equal representation of Albanians in the institutions of the system. They underlined possibilities for a better cooperation primarily in the field of education and culture, where the people with the Albanian nationality as bilinguals could have a very important role.
- On 17 March, Vice President Nimanbegu met with Minister of Finance of the Republic of Kosovo Avdullah Hoti. They voiced mutual satisfaction with the development of relations between the two countries, governments and parliaments, which have been very good, and also discussed the possibilities of further improvements. Vice President Nimanbegu informed the Minister Hoti about the state of play in the Montenegrin political scene, progress in the EU accession process, and especially regarding the NATO accession. The interlocutors concluded that the goal of every responsible

policy was the commitment to the rule of law and willingness to assume responsibility of the access to the integration for the benefit of all citizens.

- On 20 March, Vice President Nimanbegu received Ambassador of Slovenia to Montenegro Mitja Močnik. The interlocutors exchanged opinions on the situation in Montenegro following the boycott of the Parliament by the opposition parties. With regard to the Euro-Atlantic integration, the interlocutors agreed that it was the right path leading to the well-being of all citizens of Montenegro. They voiced their expectation that the countries which were yet to ratify the NATO Accession Protocol for Montenegro would do so as soon as possible. Furthermore, they also discussed the possibilities for better cooperation between the Slovenian and Montenegrin municipalities with regard to economy and tourism.
- On 26 October, Vice President Gvozdenović had a meeting with Ambassador of Palestine to Montenegro H.E. Rabii Al-Hantouli. Vice President Gvozdenović and Ambassador Al-Hantouli talked about the opportunities for strengthening political, economic and cultural relations between Montenegro and Palestine, bearing in mind the potential of interstate cooperation. At the meeting, it was agreed to build upon the existing relations with the Parliament of Montenegro, through the creation of a friendship group as a parliamentary mechanism of providing the opportunity for ad-

- ditional value of bilateral cooperation. The meeting was also an opportunity to exchange views on issues related to the constellation of international global relations, emphasising the importance of preserving peace and stability in the world.
- On 21 November, Vice President Gvozdenović met with Ambassador Maryse Daviet and Political Officer at the OSCE Mission Karen Gainer. The topic of the meeting was the sharing of information with regard to the implementation of the OSCE/ ODIHR recommendations in order to improve electoral legislation. Voicing his gratitude for the institutional contribution of the OSCE and personal efforts by Ambassador Daviet to apply the best world practice and standards, Vice President Gvozdenović emphasised that the OSCE's work was especially appreciated in Montenegro before, during and after the election process, and that he believed that Montenegro would soon become a good practice example for others, when it comes to electoral legislation.

The vice presidents of the Parliament, in their capacity as chairs of the friendship groups of the Parliament of Montenegro in 2017, had several activities with overview given below:

• On 3 July, Montenegro - Macedonia Friendship Group held a meeting with President of the Assembly of the Republic of Macedonia Talat Xhaferi. The interlocutors emphasised good bilateral relations of the two countries at all levels.

Vice President Nimanbegu noted that it would not be possible to achieve strategic integration goals without an active role in regional cooperation and reflection on foreign policy in a regional context. The strengthening of the rule of law, democracy, and institutions of the system represent a common path for all Western Balkan countries and on this path we need to share our experiences and act together to achieve full integration, said Vice President Nimanbegu. The interlocutors agreed that it was important to work on establishing even better economic and trade relations between the two countries in the upcoming period, especially with regard to cooperation in the field of tourism, as well as the improvement of the transport infrastructure between the two countries. The meeting was also attended by members of the Montenegro - Macedonia Friendship Group, MPs Mirsad Murić, Branka Tanasijević and Maja Bakrač, while the Macedonian delegation, in addition to the President Xhaferi, consisted of MPs Xhevat Ademi and Maksim Dimitrievski.

On 7 July, Montenegro - Turkey parliamentary Friendship Group held a meeting with Ambassador of the Republic of Turkey to Montenegro Serhat Galip. On that occasion, the Ambassador pointed out that a new friendship group with the Parliament of Montenegro would soon be formed in the Grand National Assembly of the Republic of Turkey, which would be committed to further improving the relations of the two countries. Pointing out that Montenegro was the brightest point in the Western Balkans region, the Ambassador emphasised that, with Montenegro's membership in NATO, relations between Montenegro and Turkey had reached a new level. Vice President Nimanbegu emphasised the significance that Turkey held for Montenegro, as a friendly country, NATO ally, but also the country with a large number of emigrants from Montenegro. In addition to traditionally good relations at the political level, they also welcomed at the meeting even more intensive economic cooperation between Montenegro and Turkey, and voiced the expectation that it would be further improved. In addition the Chair Nimanbegu and Ambassador Galip, the meeting was attended and actively participated in by members of the Friendship Group, MPs: Andrija Nikolić, Suad Numanović, Marija Maja Ćatović, Branka Tanasijević and Nedžad Drešević, who pointed out, from

the aspect of responsibilities of the parliamentary committees in which they were members, that their engagement would contribute to the implementation of concrete project activities and improvement of the bilateral relations between Montenegro and Turkey.

• On 12 July, Vice President Gvozdenović met with non-resident Ambassador of Israel to Montenegro, based in Belgrade, H.E. Alona Fisher Kamm. The interlocutors agreed in their assessment that bilateral cooperation needed to be intensified at the highest level, and voiced expectation that the Friendship Group with the Parliament of Montenegro would soon be formed in the Israeli Parliament. In the meeting, willingness was expressed to intensify cooperation in the following areas: economy, tourism, healthcare, defence, science, education and sports, and a plan of concrete joint activities would be coordinated in the upcoming period.

• On 12 September, Vice-President Gvozdenović met with a delegation of the National Assembly, headed by President of the National Assembly of the Republic of Slovenia Milan Brglez. Vice President Gvozdenović showed interest in learning about the good practice and experiences of the National Assembly of the Republic of Slovenia in doing parliamentary activities, which would be applicable in the Parliament of Montenegro as well.

President Brglez voiced his pleasure over the fact that a friendship group had been formed in the Parliament and pointed out that such thing represented a significant contribution to strengthening of good and friendly relations of the two countries. In that respect, it was agreed that in the following few months a plan of parliamentary cooperation would be drafted and areas of concern for improvement of relations between Montenegro and Slovenia would be noted.

- On 28 September, Vice President Gvozdenović held a meeting with the non-resident Ambassador of Georgia to Montenegro, based in Budapest, H.E. Zaza Kandelaki. Vice President Gvozdenović and Ambassador Kandelaki exchanged opinions with regard to further development of inter-state relations, especially via the parliamentary cooperation mechanism within friendship groups which exist in both parliaments. Having in mind the newly formed Friendship Group with the Parliament of Georgia, Vice President Gvozdenović pointed out that conditions were created for an improved model of parliamentary cooperation which reflected good and friendly relations with Georgia. In that respect, it was pointed out that the results of cooperation of friendship groups between the parliaments could give an additional impulse and energy to the overall bilateral relations.
- At the meeting of 2 October with representatives of the Parliament of the Federal Republic of Germany, Vice President Nimanbegu emphasised the importance of the International Parliamentary Scholarship (IPS), granted by the Bundestag. Stressing that it was exceptionally important to further promote cooperation in the field of tourism, Ms Kirsten Radomski was interested in economic areas where German investments would be particularly significant for Montenegro. With the emphasis on the contribution already provided by the German Development Bank (KfW), the following were sigled out as areas that would be the most attractive to investors: energy, water supply, transport and wood industry. Vice President Nimanbegu expressed his gratitude for the contribution of the German Embassy in preserving the environment, and especially in protecting the Ulcinj Solana. The meeting was also attended by German Ambassador to Montenegro H.E. Hans Günther Mattern, Head of Human Resources Department in the Bundestag, Ms Daniela Rosenthal, as well as members of the Friendship Group of the Parliament of Montenegro and Parliament of the Federal Republic of Germany Miodrag Bobo Radunović and Mr Ervin Ibrahimović, who participated actively in the meeting.
- Vice President Gvozdenović held on 18 October a meeting with non-residential Ambassador of the Republic of Estonia to Montenegro, based in Tallinn, H. E. Daniel Erik Schaer, Mr Gvozdenović



especially pointed out the significance of the full support of Estonia to the European integration of Montenegro, particularly at the time of Estonian presidency of the Council of the European Union. Therefore, the message conveyed by Ambassador Schaer that Estonia recognised Montenegro as a leader in the European integration process was extremely significant, and also that it remained open for full support and assistance to Montenegro on its path towards achieving its strategic goal of full EU membership. The Ambassador especially emphasised the significance of sharing the parliamentary experiences and establishing direct contact among elected representatives of the people, as the best manner for achieving successful cooperation and common goals.

- Vice President Nimanbegu met French Ambassador Ms Hélène Conway-Mouret on 20 October. On this occasion, they discussed the cooperation of the parliamentary friendship group with the French Senate and National Assembly. Also, they talked about cooperation of Montenegro and France in the light of Euro-Atlantic integration. Vice President Nimanbegu expressed his interest in Montenegro's opportunities to become a member of the Union of the Francophone countries, which would be very significant for the further progress of Montenegro. During the meeting, they also talked about spatial planning. Vice President Nimanbegu stressed that, unfortunately, the system of spatial planning had been centralised for a long period of time. The interlocutors, also, agreed that in was necessary to improve cooperation in the field of tourism.
- Friendship group of the Parliament of Montenegro with the Republic of Italy met on 1 November with a delegation of the Italian Senate. Vice President Nimanbegu pointed on this occasion to traditional ties between the two countries, and the special nature of the relations of the countries that have been connected with the sea. He also stressed that Montenegro, as a young country, was very interested in joining the standards, society and values that developed countries of the European Union had. Mr Nimanbegu emphasised the importance of constructing the Adriatic-Ionian Motorway, calling on the colleagues from Italy to support its construction by lobbying and helping Montenegro and regional integration, despite the fact that this

- project might not currently be on the list of priorities of the European Union. The interlocutors agreed that the two countries had much in common, and that good and friendly relations should be maintained and improved in a number of areas, which should be significantly contributed by the inter-parliamentary friendship groups between Montenegro and Italy. Besides the guests and Vice President Nimanbegu, the meeting was attended by members of the Montenegro Italy parliamentary Friendship Group Andrija Nikolić, Marija Maja Ćatović, Mirsad Murić and Petar Smolović, as well as the Ambassador of the Italian Republic to Montenegro H.E. Vincenzo Del Monaco.
- Meeting of the Montenegro Islamic Republic of Iran parliamentary Friendship Group was held on 2 November. Chair of the Iranian Parliamentary Friendship Group with Parliament of Montenegro Parvaneh Salahshouri stressed that strengthening of parliamentary cooperation was one of the pillars of bilateral relations, with the remark that a significant step forward in improving the overall cooperation of the two countries would be the mutual abolition of visas, as well as the introduction of a regular airline connection between Podgorica and Tehran. Vice President Nimanbegu expressed his satisfaction with the existence of friendship groups, noting that this form of cooperation, manifested through direct communication of parliaments, has been very efficient mechanism for improving the existing friendly relations between Montenegro and Iran. Ms Salahshouri, extended the invitation to the Chair and members of the Friendship Group to officially visit the Islamic Republic of Iran and thus intensify the cooperation at the parliamentary level, which would create, as the interlocutors agreed, stable foundations for strengthening cooperation in the fields of economy, energy, tourism and culture. The meeting was attended by members of the Friendship Group, MPs Aleksandra Vuković, Miodrag Vuković and Nedžad Drešević.
- Vice President Nimangebu held a meeting with newly-appointed Charge d' Affaires of Ukraine to Montenegro Nataliia Fiialka on 6 December. On this occasion, Vice President Nimangebu stressed that strengthening of parliamentary cooperation was a unique way to establish stronger political and economic relations between the two countries. The Interlocutors agreed that it was important to

work on establishing even better economic relations between the two countries in the upcoming period, especially in the area of tourism and agriculture cooperation. Also, the interlocutors agreed that the establishment of friendship groups, as well as the planning of the mutual visits of members of the two parliaments, planned for the first half of next year, directly contributed to the strengthening of bilateral and overall relations between Montenegro and Ukraine.

Vice presidents of the Parliament Mr Gvozdenović and Mr Nimanbegu also took part in meetings of the President of the Republic of Bulgaria Rumen Radev on 11 July with President of the European Parliament Mr Antonio Tajani on 18 July, President of the Republic of Hungary János Áder on 4 October, as well as during the talk held on 15 November with representatives of the OSCE/ODIHR.

- Below is also more information about visits to other countries and the participation of the vice presidents of the Parliament in international meetings:
- On 1 December, Vice President Gvozdenović took part in Trade Fair for Investment Projects REXPO in Zagreb. As one of the keynote speakers Vice President Gvozdenović addressed at the ceremonious openening, together with: Deputy Prime Minister of the Republic of Croatia Predrag Štrormar, Minister of Tourism of the Republic of Croatia Gari Kapeli, and Ambassador of Great Britain to Croatia Andrew Dalglish. Speaking about the need for a joint strategy for attracting investments and tourists from distant markets, Vice President Gvozdenović especially emphasised the potential that the Mediterranean region has in terms of to-

urism. Bearing in mind that 370 million tourists visited a Mediterranean destination this year, and that according to UNWTO's long-term forecast, this number will reach over 500 million in 2030, Mr Gvozdenović said that the whole region should see this as a chance for themselves.

- On 19 December, Vice President of the Parliament Branimir Gvozdenović took part in the 20th meeting of the Contracting Parties to the Barcelona Convention in Tirana. The meeting was an opportunity to recall on the importance of Integrated Coastal Zone Management (ICZM) for the sustainable development of coastal and marine areas, the elimination of pollution and the achievement of a good state of the environment in line with the ecosystem approach. Vice President Gvozdenović emphasised that ICZM contributed to the resistance of marine areas to the developmental pressure caused by the tourism development and accompanying processes of urbanization. He stressed that this pressure is additionally strengthened in the Mediterranean region by the influence of climate change, that is, the rise in sea levels, droughts and floods.
- Vice President of the Parliament Genci Nimanbegu, in his capacity of a member of the Permanent Delegation of the Parliament of Montenegro to NATO PA, took part in several NATO PA activities during 2017 (more information on page: 51)

3.5. PERMANENT DELEGATIONS

Activities within permanent delegations in parliamentary assemblies of international organisations were also continued in 2017 via participation in ordinary sessions, meetings, and forums.

Parliamentary Assembly of the Council of Europe (PACE)

In 2017, 2015, Delegation of the Parliament of Montenegro to the Parliamentary Assembly of the Council of Europe participated in two ordinary sessions of the PACE and in several meetings of its working bodies.

The first regularly winter session of the PACE was held in Strasbourg from 23 to 27 January 2017. In accordance with the PACE Rules of Procedure, the mandates were approved to parliamentarians at the beginning of the session, the leadership was elec-



ted, and the composition of permanent working bodies of the Parliamentary Assembly was determined. As for the Parliament of Montenegro, the mandates to the following MPs were confirmed: Predrag Sekulić, Head of the PACE Delegation, Sanja Vlahović, member of the Delegation, and Marija Ćatović and Ervin Ibrahimović, substitute members of the Delegation.

The winter session was marked by debates on media freedom in Europe, online media and journalism, and the prevention of hate speech on the Internet. Other highlights of the session were the debates on the functioning of democratic institutions in Ukraine, the situation in Lebanon and challenges for regional stability and European security, and the humanitarian crisis in Gaza, progress of PA's monitoring procedure, new generation trade agreements, and supporting the process of Roma inclusion.

Predrag Sekulić, Head of the PACE Delegation, and substitute members Sanja Vlahović and Ervin Ibrahimović took part in the Winter Session.

Summer session of the PACE was held in Strasbourg from 26 to 27 January 2017. In the period 26-28 June, the session was attended by Predrag Sekulić, Head of the PACE Delegation, Sanja Vlahović, member of the Delegation, and Marija Ćatović and Ervin Ibrahimović, substitute members of the Delegation.

The session was marked by a debate on migration in Europe, in particular on the issues of refugee integration, humanitarian and political response to the migrant crisis, and migration as an opportunity for European development. MPs were particularly interested in topics such as: further promoting of transparency and accountability measures within the PA, fight against corruption and promoting integrity in governance. The agenda of the June Session also included discussions on the situation in Belarus, the execution of judgments of the European Court of Human Rights, the fight against terrorism, the political influence on independent media, and the fight against abuse and violence against women.

Tenth anniversary of Monrenegro's membership in the Council of Europe was marked by a set of activities within the June Session. The Prime Minister of Montenegro addressed the Parliamentary Assembly of the Council of Europe on this occasion, and ceremony of the presenting the gift of Montenegro to the Council of Europe was also held.

In addition to participating in regular sessions, delegation members participated in the meetings of the working bodies of the PACE, political group meetings, observation missions and other activities aimed at promoting the values and standards of the Council of Europe. Numerous meetings were also held with representatives of institutions and countries Council of Europe member states, including meetings held during the visit of the representatives of the PACE to Montenegro.

Parliamentary Assembly of the North Atlantic Alliance (NATO PA)

The first parliamentary session of NATO, where Montenegro participated as a full member of the Alliance, was held from 6 to 9 October 2017 in Bucharest. The 63rd Session gathered the representatives of parliaments from 29 member states from the North America and Europe, associate and partner states, observer states, and other relevant representatives, with a goal of discussing common security issues of international nature. On this occasion, the Parliament of Montenegro was represented by Head of Delegation Obrad Mišo Stanišić and member Genci Nimanbegu. Members of the parliamentary Delegation participated for the first time in voting at the meetings of all committees on resolutions and other documents that were on the agenda of the parliamentary session.

In his introductory speech, President of the NATO Parliamentary Assembly Mr Paolo Alli congratulated Montenegro on its full membership of NATO,

welcomed it in the alliance of Euro-Atlantic states, and invited the participants to support by applause this success of both - Montenegro and the Alliance. He pointed out that Montenegro's membership in the North Atlantic Alliance was the result of a devoted and committed work in the previous period, as well as its contributions to international peace, and stressed the firm belief this would continue in the upcoming period.

During the discussions on the Western Balkans, the activities NATO had in this area and the open door policy, NATO Secretary General Jens Stoltenberg pointed out that the impressive results Montenegro has achieved over the last years in meeting the standards and showing full commitment to the Alliance's common goals were its best recommendation for full membership in NATO.

The Spring Session of NATO PA was held in Tbilisi in May of this year, when the Parliament of Montenegro was represented by Obrad Mišo Stanišić, Head of the Delegation, and members Genci Nimanbegu and Tarzan Milošević. The Spring Session gathered approximately 200 parliamentarians from 28 NATO member states, as well as delegates from partner countries and observer countries, with a goal to consider current security issues and draft reports of the Parliamentary Assembly's committees. During the meetings, the delegates were addressed by representative of governments, academic community, NGO sector and NATO.

In 2017, Permanent Delegation of the Parliament participated in several meetings of the NATO PA committees, including the Spring Meeting of the Standing Committee. The Parliament was also represented at this year's Rose Roth Seminars, as

well as at the 17th Annual NATO PA Transatlantic Forum, held in December in Washington. The Forum, hosted jointly by the NATO PA, Atlantic Council of the United States (ACUS) and Institute for National Strategic Studies, gave an opportunity to the participants to discuss on a wide range of key issues shaping the transatlantic partnership in the field of security and defence.

Parliamentary Assembly (OSCE PA)

The Winter Meeting of the OSCE Parliamentary Assembly (OSCE PA) was held in Vienna on 23 and 24 February. The XVI Winter Meeting, which gathered over 250 MPs from 50 member states, was marked by the discussion on the topic of protecting human rights in times of crisis, and forming of platform for joint action of member states aimed at overcoming the current challenges. At the Standing Committee, the rapporteurs presented their findings during their time in observation missions, including the report on parliamentary elections in Montenegro from October 2016. In separate meetings of the three committees, in accordance with their responsibilities, they considered the security challenges from the aspect of growing populism, spread of terrorism, and climate change.

The Parliament of Montenegro was presented by President of the Parliament of Montenegro Mr Ivan Brajović and Vice President of the Parliament of Montenegro Mr Branimir Gvozdenović, in their capacities of permanent members, as well as MPs Aleksandra Vuković and Nikola Rakočević, as substitute members. The permanent member of the delegation also had a series of bilateral meetings with senior officials of this organisation.





The 26th Annual Session of the OSCE Parliamentary Assembly, held in Minsk, from 5-9 July, was focused on the significance of parliamentary dialogue among member states for the purpose of combating all types of threats, primarily in the security sense, and making efforts aimed at de-escalation of the current conflicts. This year's session entitled "Enhancing mutual trust and co-operation for peace and prosperity in the OSCE region" stressed that in times of prominent security threats, it was most important to build trust among states and nations, ensuring peace and security on the principle of mediation and consensus. Meetings of general committees were marked by discussions on resolutions, subsequently forwarded to the relevant committees, the election of new leadership, and presentation of the reports by rapporteurs. Three resolutions of the committees had become a part of the incorporated text of the Joint Declaration, which was adopted at the end of the Session. Delegation of the Parliament of Montenegro was composed of President of the Parliament Ivan Brajović, Head of the Delegation, and MP Nikola Rakočević, alternate member. More than 300 parliamentarians within the OSCE Parliamentary Assembly have considered resolutions pertaining to: crisis in Ukraine, transnational terrorism, conflicts in Nagorno-Karabakh region, climate change, fundamental freedoms and respect of human rights, energy security, multiculturalism, abolition of the death penalty, new voting technologies, and the management of migration and refugee movements.

The Parliament also took part in the seminar "OSCE Security Policy – Female Perspectives", held in Vienna, where Chairperson of the Gender Equality Committee Nada Drobnjak and alternate member of the Parliament of Montenegro's Standing Delegation to the OSCE PA Aleksandra Vuković participated. The conference in Leinsweiler was held in May. It was about geopolitical spheres of influences in the OSCE region. Alternate member of the Parliament of Montenegro's Standing Delegation to the OSCE PA Aleksandra Vuković took part in it.

In May, President Brajović had multiple meetings with OSCE PA top officials, including meetings with Roberto Battelli, OSCE PA Vice President and Special Representative on South East Europe, and

Ambassador Andreas Nothelle, OSCE PA's Special Representative in Vienna (more details on page).

3.6. REGIONAL INITIATIVES

Cetinje Parliamentary Forum

The XIX Cetinje Parliamentary Forum (CPF) on the topic "Parliament and mass communications" was held in Cetinje, on 8 December 2017. The forum gathered representatives of the parliaments of five countries in the region and Montenegro, eminent experts in the field of communications, media representatives, non-governmental organisations representatives, as well as the diplomatic corps and the students of relevant faculties. The Cetinje Parliamentary Forum adopted the Joint Declaration, where the participants welcomed all forms of communication aimed at improving parliamentary cooperation, as well as cooperation between parliaments and citizens whose choice they represent, and stressed the importance of involving media and non-governmental organisations in the work of the CPF, through their contribution to the debate and conclusions The participants agreed that transparency of work and availability of all relevant information to citizens were of great importance for the democratic work of parliaments. The declaration also recognised that that mass communication play an important role in the greater involvement of citizens in politics and democratic processes as a whole, while the importance of digital media was recognised through their availability in providing information, inclusion, understanding, and building trust between citizens and institutions. It was noted that, channels of communication - regardless of whether they are new or traditional media - play a key role in interaction with citizens. All participants agreed that responsibility for truthful, objective and timely information is borne by both decision-makers and all other stakeholders of the process in which the civil sector and the media play a crucial role.

The panel "Democracy in digital era" discussed the imact of digital era and new media on openness and understanding of the parliamentary role and vice versa. The second panel titled "The truth in the post-truth age" initiated a debate on the topic of traditional and new media: who is in charge of the truth and who of the post-truth defined by the Oxford Dictionary as circumstances in which ob-

jective facts are less influential in shaping public opinion than appeals to emotion and personal belief.

"In civilisation, democracy is probably a term that evokes the most trust, but also mistrust. Today it got a competitor: the media are talked about, argued about and discussed with the same passion as democracy. Democracy and mass media are indispensable to each other, like opposition and position. In that conflict, like in the big bang, a new world and a new idea are created. This is primarily thanks to information" I. Brajović, CPF, Cetinje.

South-East European Cooperation Process Parliamentary Assembly (SEECP PA)

As for the regional initiatives, the Parliament of Montenegro took part in the IV Plenary Session of the Parliamentary Assembly of the South-East European Cooperation Process (SEECP PA), held in Zagreb on 9-10 June.

President of the Parliament of Montenegro and Head of the Standing Delegation to the SEECP PA Ivan Brajović and members of the Standing Delegation Milorad Vuletić and Radule Novović took part in the session.

This year's plenary session of the SEECP PA adopted the Final Declaration which emphasises, among other things, the EU integration perspective of the aspirant countries, as one of the most important factors of stability and security

in the Western Balkans region. It was noted that Union's policy of further enlargement significantly contributed to the peace, security, stability and prosperity of both the EU and the South East European region. In its Final Declaration, the Assembly strongly condemned terrorism and radicalism and invited participants to invest efforts in building a sustainable network for cooperation and information sharing in order to efficiently combat terrorist threats. Furthermore, the Declaration encourages goals in the field of economic cooperation, development of joint infrastructure projects and development of entrepreneurship in the Southeast Europe region. The resolutions of the three general committees in charge of economy, justice and social development were also adopted at the Session. This was also the last activity of the Croatian chairmanship of this initiative, and at the end of the plenary session held in Zagreb, the chairmanship of the SEECP PA was officially taken over by the Republic of Slovenia.

During the annual session of the SEECP PA, MP Radule Novović was elected Chairperson of the General Committee on Social Development, Education, Research and Science.

In 2017, a meeting of the SEECP PA General Committee was held (in Ljubljana), where a member of the Standing Delegation Radule Novović participated. The first meeting under Slovenia's chairmanship-in-office of this initiative



was dedicated to presenting the priorities of the SEECP chairmanship organised under the motto "SEE4Future – South Eastern Europe for Future", the activities of the three SEECP PA general committees, and the prospects for further development of this regional cooperation framework.

Adriatic-Ionian Initiative (AII)

The XV Conference of the Speakers of Parliaments of the Adriatic and Ionian Initiative was held 6 and 7 April 2017, in Ioannina, Greece. President of the Parliament of Montenegro Ivan Brajović participated in the conference on behalf of the Parliament.

Particiants of the conference agreed that the role of parliaments in the AII should be strengthened in order to make the most of the potentials provided by the EU Strategy for the Adriatic and Ionian Region (EUSAIR). Also, the regular holding of EUSAIR Forum was welcomed, being an important framework for gathering the most important stakeholders of project cooperation within this region. The need for synchronised action and coordination with other macro-regional strategies was emphasised in order to achieve regular exchange of knowledge and experience and a synergistic effect aimed at better results and quick responses to current and future challenges.

Central European Initiative Parliamentary Dimension (CEI-PD)

Head of the Permanent Delegation of the Parliament of Montenegro to the Parliamentary Dimension of the Central European Initiative MP Miodrag Vuković took part in the annual Meeting of the CEI Parliamentary Assembly held in Minsk, on 27 and 29 November, within the Belarus presidency of the Initiative. This year's CEI PA session was devoted to the topic: "Digital technologies in terms of ensuring geopolitical security". At the meeting, they welcomed efforts aimed at better coordination of actions carried out by CEI countries, EU institutions, the Eastern Partnership countries and other international organisations in order to maintain economic and political stability, as well as the development of innovations and digital technologies that will ensure geopolitical security. The CEI PA session noted the enormous progress

made by member states over the past 28 years in terms of strengthening the internal cohesion of the CEI countries.

At the end of the meeting, the Joint Declaration was adopted, summarising the conclusions from the held meeting of the Parliamentary Assembly of the Central European Initiative.

3.7. FRIENDSHIP GROUPS

Friendship groups are a form of parliamentary cooperation of the Parliament of Montenegro and parliaments of other states, which aims to improve parliamentary and interstate relations. Formed on the basis of mutually expressed interests of the two parties, the cooperation achieved through friendship groups is an additional impulse to the overall bilateral component of international relations.

In line with its good practise and achieved results, the 26th Parlimanet of Montenegro has established 39 friendship groups in 2017. Established to improve relations between parliaments, by networking contacts among parliamentarians, friendship groups provide an effective complementary platform to official diplomacy. Therefore, as a contribution to the implementation and achievement of (the goals) of parliamentary diplomacy, the increased number of friendship groups in comparison to the 25th Parliament, is a confirmation that today they are one of the basic forms of achieving the goals in the international political arena. By establishing friendship groups, the Parliament of Montenegro remains devoted to parliamentary diplomacy, as the most effective and best way of consolidating and improving inter-parliamentary relations and cooperation with the countries of the region, Europe and the world.

The 26th Parliament of Montenegro has established parliamentary friendship groups with parliaments of the following states: the Republic of Albania, the Arab Republic of Egypt, Australia, the Republic of Austria, the Republic of Azerbaijan, the Kingdom of Belgium, the Republic of Belarus, Bosnia and Herzegovina, the Republic of Bulgaria, the Czech Republic, the Republic of Estonia, France, Georgia, the Kingdom of the Netherlands, the Republic of Latvia, the Republic

blic of Lithuania, the Grand Duchy of Luxembourg, the Republic of Croatia, the Islamic Republic of Iran, Iceland, Italy, Israel, the Kingdom of Jordan, the Republic of Kosovo, Kuwait, Hungary, the Republic of Macedonia, the Republic of Malta, the Federal Republic of Germany, the Republic of Poland, Romania, the Russian Federation, the United States of America, the Republic of Slovenia, the Slovak Republic, the Republic of Serbia, the People's Republic of China, Ukraine, and the Republic of Turkey.

3.8. COOPERATION WITH FOREIGN AND INTERNATIONAL ORGANISATIONS

OSCE Mission to Montenegro

In 2017, the cooperation of the Parliament of Montenegro was achieved through a number of activities of committees and parliamentary service.

With the support of the Office for Democratic Institutions and Human Rights (ODIHR), the Mission and the Committee organised a two-day workshop on the topic "Introduction gender aspects in legislation - Parliament of Montenegro", with the aim of implementing one of the measures from the Activity Plan for Gender-Responsive Parliament of Montenegro September 2016 - September 2018, envisaging capacity building and procedures for the assessments of gender impact in the phases of creating and adopting laws, policies and other acts. Within this actovity, the Mission supported translation of the ODIHR's Making Laws Work for Women and Men: A Practical Guide to Gender-Sensitive Legislation.

On 18 and 19 September 2017, the Mission also



supported the organisation of a working visit to the Parliament of Montenegro by the Parliamentary Service of the Parliamentary Assembly of Bosnia and Herzegovina in the field of legislative process, research and documentation, with the aim of strengthening regional and bilateral cooperation and exchange of best practices. Additionally, the Mission supported participation of the parliamentary service and the Secretary General in the VI Annual Conference of the secretaries of working bodies of parliaments and assemblies of Bosnia and Herzegovina: "Strengthening parliamentary engagement in integration through stronger coordination of working bodies for European integration and involving civil society in relevant processes", on 11 and 12 December in Jahorina.

As a continuation of efforts in the previous year, the Mission also provided assisstance to the Parliament in 2017 for organising the training program for the parliamentary service. The program aims to further strengthen and develop a sustainable and modern parliamentary service. The programme consisted of four two-day workshops on the topic: Business Culture, Communication and Presentation, Conflict Management and Change Management.

The Mission also supported a number of mobile workshops within the framework of the Democracy Workshops "Barbara Pramer" programme.

Westminster Foundation for Democracy (WFD)

Cooperation with the Westminster Foundation for Democracy (WFD) continued in 2017 in line with the Memorandum of Understanding, signed in May 2016 and supported by the UK Embassy in Podgorica. The first phase of the project, aimed at establishing a parliamentary budget office (PBO), was completed in March 2017, and the funds to the new phase which will last until April 2018 have been approved.

Parliamentary Budget Office (PBO) is envisaged as a specialised part of the parliamentary service, which will provide assistance to MPs when analysing the budget, overseeing its implementation, analysing key budgetary documents, and laws with fiscal impact. The office was founded following the example of a similar financial oversight office in the Scottish Parliament. So far, its work was exclusively directed towards providing the assistance to the parliamentarians in conducting parliamen-

tary analysis and budget control, responding to the demands of MPs, and strengthening the capacity of researchers. Office staff attend specialised trainings, especially for the development of analytical products following the example of the Scottish Parliament.

This project is a continuation of the support provided by the WFD to the Parliament, mainly focused on organising trainings for parliamentarians and staff, while a special emphasis was put on supporting the advancement of committee work, strengthening regional cooperation in order to improve public finance management, organising bilateral meetings of parliamentary committees with parliaments of the regional countries, as well as regional parliamentary meetings and conferences.

National Democratic Institute (NDI)

In 2017, cooperation of the Parliament of Montenegro and the National Democratic Institute (NDI) was mainly achieved through NDI Western Balkans Legislative Strengthening Initiative (WBLSI), funded by the National Endowment for Democracy (NED). The Initiative aims to assists parliaments in strengthening their law-making, oversight, and representation capacities.

In March, the Initiative organised international conference, in cooperation with the Czech Senate and Chamber of Deputies, on the topic "Legislative initiatives and coalition building in the process of law adoption". The Conference took place in Prague. Also, in November a regional workshop on "Transparency and cooperation of parliaments with civil society" was held in Bratislava. Both events gathered MPs and leading experts from parliamentary services of several countries; they shared their experiences regarding the support provided by research and legislative services, as well as the inter-party cooperation and the engagement of civil society in law-making, as well as the administrative and other support provided to MPs by parliamentary staff.

Within the Initiative, two regional gatherings of research services representatives from the Western Balkans parliaments were organised in Montenegro, one of these in May 2017. The events exchanged information and experiences of the officials dealing with parliamentary researches, and established models for stronger cooperation.



IV TRANSPARENCY OF WORK OF THE PARLIAMENT OF MONTENEGRO

4.1. PARLIAMENT AND MEDIA

In the period January - December 2017, the Department for Public Relations and Protocol of the Parliament of Montenegro issued 295 permanent credentials for journalists and camera crews/photo-reporters, while a total of 292 daily credentials were issued. In the same period, 109 individual questions by the journalists regarding parliamentary activities were processed and answered.

During the said period, a total of 19 press conferences were held in the Parliament of Montenegro.

In the period from January to December 2017, 3,290 pieces of information, announcements and statements illustrated with 3,540 photos were posted on the News page of the parliamentary website.

The Parliament continues the practice of broadcasting the sittings of the Parliament. In the reporting period, a total of 27 ordinary sessions were broadcasted, in duration of 128 hours and 46 minutes, as well as three extraordinary sessions lasting for three hours and 50 minutes. Live broadcast was also provided for the Sixth Session of the Women's Parliament, lasting for 2 hours and 50 minutes, the Seventh Session of the Women's Parliament, lasting for 3 hours and 20 minutes, the Third Session of the Students'

Parliament, lasting for 1 hour and 24 minutes, and for SAPC meeting in the duration of 2 hours and 23 minutes.

4.2. FREE ACCESS TO INFORMATION

The Parliament of Montenegro, in this reporting period as well, continued with the practice of responding to all requests for access to information. Furthermore, the Parliament of Montenegro regularly publishes on its website decisions and other individual acts which are significant for rights, obligations, and interests of third persons, as well as information for which access was granted upon request. In 2017, the requests for access to information were most frequently submitted by the NGOs. In the reporting period, a total of 94 requests for free access to information were submitted to the Parliament of Montenegro, and they were answered to in the following manner: for 38 requests access was granted (for one of these requests, the access to a part of information was partially limited due to privacy protection); for six requests the information was already available on the website of the Parliament of Montenegro (response by announcement); for four requests access was partially granted, in two cases due to the lack of possession of all the requested information and for




one because an access to the information demanded making a new information; for 41 requests access was denied because the Parliament did not possess the requested information; in one case, the access was denied for the interest of exercising the official duty.

Preparation of the response to a request submitted in late December is ongoing. In 2017, 22 requests submitted in 2016 were also addressed.

The appendix of this Report contains a detailed tabular overview with information about submitters of requests for access to information, date of reception and of response, as well as the type of response.

4.3. COOPERATION WITH CIVIL SECTOR



Also, on 15 September, President Brajović met representatives of NGOs - CEDEM, CDT, CEMI, MANS and CA, when they concluded that the Parliament of Montenegro and non-governmental sector had open and constructive cooperation, with unbiased and objective approach in the interest of progress of institutions and Montenegrin society as a whole. They jointly assessed that the Parliament has achieved significantly greater openness and transparency of work, which is



The cooperation of the Parliament of Montenegro and civil society organisations continued in 2017. NGO Young Roma joined the signatories of the Agreement on Cooperation between the Parliament of Montenegro and the non-governmental organisations in Montenegro, signed with almost 70 NGOs in July 2016. At the meeting with representatives of this organisation, President of the Parliament of Montenegro Ivan Brajović congratulated its activists on the award they received from the European Union, for the best project "Through Education to Integration", which refers to the integration of Roma in the Western Balkans and Turkey. The meeting was attended by Vice President of the Parliament of Montenegro Genci Nimanbegu, Chairperson of the Committee on Human Rights and Freedoms Halil Duković, Head of the MPs Group of the Democratic Party of Socialists Miodrag Bobo Radunović, Head of the MPs Group of the Bosniak Party, Coalition "Albanians resolutely" and the Croatian Civic Initiative Ervin Ibrahimović and Head of the MPs Group of the Social Democrats of Montenegro and Liberal Party of Montenegro Andrija Popović.

a good basis for further progress in exchanging views with the civil sector, both through organisations and individually. They also spoke about following good practices from more developed democratic societies, the inclusion of experts that would provide the basis for further improvement of legislative frameworks, the quality of documents, procedures and other elements important for the legislative and control role of the Parliament, whether it is about election or other process, for the benefit of the whole society. The meeting was organised on the 20th anniversary since the adoption of the Universal Declaration on Democracy by the Inter-parliamentary Union, as well as on the tenth anniversary since the decision of the UN General Assembly to pronounce 15 September for International Day of Democracy.

When it comes to cooperation with the civil sector, the Parliament and its relevant working bodies continue to analyse the received initiatives, attitudes and recommendations of non-governmental organisations and, if necessary, invite their representatives to explore certain issues within the scope of work of the working bodies. Committee members also participate

in meetings organised by civil society. More information about this is available in the part relating to working bodies.

4.4. VISITS, EXHIBITIONS AND OTHER EVENTS

During the year, a number of group and individual visits to the Parliament of Montenegro were organised.

Thus, in October students of Maksim Gorki and Vladika Danilo primary schools had the opportunity to learn about the work of the Parliament, its responsibilities and functions, history and activities of working bodies and MP groups. For the same reason, the Parliament was visited in November by students of the Resource Centre for Education and Vocational Training "June 1st" and sixteen students of Knightsbridge Schools International Montenegro from Tivat, in December by primary school students from Bar, Nikšić and Podgorica, students of Secondary Vocational School and Secondary School of Economics and Hospitality from Nikšić, and students of "Spasoje Raspopović" Secondary Vocational School from Podgorica, in the organisation of the NGO Hand of Friendship Foundation.

Participants of the Eighth Session of the Children's Parliament, i.e. 50 representatives of local children's parliaments from 21 municipalities, including representatives of vulnerable groups from all Montenegrin municipalities visited the Parliament in November (more details on page 62.). Participants of the "Barbara Prammer" democracy workshops regularly visit

the parliamentary building (more details on democracy workshops on page 61.)

This year the Parliament also hosted representatives of students population, by organising in May a meeting with representatives of the University of Montenegro, University of Donja Gorica and the Faculty for State and European Studies. The meeting was organised by the Communication Team of the Council for NATO Membership together with students, within InfoDays for students. In October, a group of students from the Faculty for State and European Studies attended the session of the Parliament of Montenegro.

In 2017, members of parliamentary staff from other countries visited the Parliament. Therefore, representatives of the Macedonian parliamentary staff visited the Parliament in April, representatives of the parliamentary staff from several Western Balkans states in May and staff from B&H Parliamentary Assembly in September.

During the year, a number of individual visits were organised, both for domestic and foreign citizens.

As for other activities in 2017, they include the following:

- 24 January President of the Parliament of Montenegro Ivan Brajović congratulated Day of Journalists of Montenegro to journalists, at the dinner hosted on that occasion;
- 5 April Parliament signed an agreement with NGO "Young Roma";
- 9 May a discussion on "What is anti-fascism in





On the occasion of Victory Day and Europe Day - a discussion on "What is anti-fascism in Montenegro today" was held, where government officers and representatives of academic community took part, as well as the President of SUBNOR and anti-fascists of Montenegro. At the gathering they discussed the role of anti-fascism in a civic society, anti-fascism from the perspective of multinational and multi-confessional Montenegro, and challenges it was facing today in Montenegro and in Europe. Special overview of the promotion of anti-fascistic values among the young was given.

In his opening address, President of the Parliament Mr Brajović said that the Parliament of Montenegro had an important role in launching initiatives for addressing the issues of the broadest social significance, and that 9 May was the day with a multifaceted significance. President Brajović emphasised that the task of all individuals with responsible roles in society was to promote the values of anti-fascism, such as solidarity among groups and individuals, social justice, respect for diversity and equality. As especially significant, the President of the Parliament pointed out the need for fostering the culture of memory, because fascism as historically incomparable negative phenomena did not cease to exist, and that the role of institutions and individuals was to defend the proven and achieved values on which the modern society was built. Earlier that day, the President of the Parliament, at the head of the state delegation, laid down a wreath on the monument to partisan fighter on Gorica.

At the initiative of President of the Parliament of Montenegro, addressed to Minister of Education Mr Damir Šehović, Montenegrin schools held a class devoted to the 9th of May - Victory Day and Europe Day.

Montenegro today" was held, where numerous government officers and representatives of academic community took part, as well as President of SUBNOR and anti-fascists of Montenegro;

- 9 May The President of the Parliament laid a wreath at the Monument of the Partisan Fighter in Gorica, on the occasion of V-E Day;
- 5 June President of the Parliament presented certificates to attendees of Democracy Workshops;
- 7 June President of the Parliament organised a reception on the occasion of Montenegro's NATO membership, on the day the Montenegrin flag was raised in Brussels.
- 12 July President of the Parliament presented the 13th July Awards for 2017;
- 14 October Exhibition "Art Collection of the Parliament of Montenegro" was opened in Petrovaradin, as a gift to Montenegrin diaspora and the entire culture public of Serbia on the occasion of visit of the delegation of the Parliament of Montenegro to the Republic of Serbia;
- 31 October President of the Parliament of Montenegro held a lecture to students of bachelor and specialist studies at the University of Donja Gorica, on the occasion of Parliamentarism Day;
- 31 October On the occasion of 111 years since the introduction of parliamentarism in Montenegro,

an exhibition "Art Collection of the Parliament of Montenegro" was opened in "Centar" Gallery, with 19 representative works of Montenegrin and regional painters;

• 20 November - The exhibition of artworks done by children from India and the Center "June 1st" from Podgorica was opened in the parliamentary Hall.

4.5. DEMOCRACY WORKSHOPS

In 2017, "Barbara Prammer" Democracy Workshops have intensively continued the organisation of workshops and development of cooperation with primary schools, as well as with other educational institutions in Montenegro. The cooperation is also continued through the organisation of mobile workshops in Montenegrin primary schools.

During the year, 144 workshops were held with 3,184 students and 180 teachers from 50 primary and one high school (from 15 municipalities). Also, 93 workshops on the topic "Democracy and Parliament" were held, 22 workshops on the topic "European Union", and 29 workshops on the topic "Human Rights". During the workshops, 94 newspaper editions were produces, 50 radio features and 42 TV features were created. Out of the total number of workshops, 29 mobile workshops were held in nine primary schools and seven municipalities, where 630 children participated. This year, democracy workshops hosted the graduate students of the "Mehmed Fatih" Madra-

sah from Podgorica, who presented their work in a video on the subject: "Democracy and Parliament".

Traditional ceremony of presenting certificates to the participants of the workshops was held in June 2017. President of the Parliament of Montenegro Mr Ivan Brajović presented the certificates to the children.

4.6. CHILDREN'S PARLIAMENT

The Eighth Session of the Children's Parliament was held on 20 November 2017. In addition to 50 representatives of local children's parliaments from 21 municipalities, i.e. two representatives coming from each primary and secondary school, including representatives of vulnerable groups of children from all Montenegrin municipalities, the Session was also attended by representatives of MPs groups in the Parliament of Montenegro, the Government of Montenegro, domestic institutions and international organisations dealing with issues of the rights of the child, as well as members of the diplomatic corps.

In his introductory remarks, President of the Parliament of Montenegro Ivan Brajović said that the UN Convention on the Rights of the Child laid down the principle that in all decisions concerning the child, the interest of the child always has to be put first. He added that the Convention encompassed in everyday life the obligations of adults, parents, foster parents, educators, social workers and the society as a whole, so that children and young people could get the same chance of growing up as healthy and stable individuals.

During the continuation of the Session, members of local children's parliaments listened to the presentation given by the children's Montenegrin delegation in Geneva on 3 October of the current year, before the members of the UN Committee on the Rights of the Child, as well as the presentation given by representatives of the Children's Parliament. The concept of this year's Session was different from previous ones, because there were no questions addressed directly to representatives of the Government, so children spoke about their personal experiences and views about certain problems in society, school, local community, family and other areas of importance for the smooth development of children in Montenegro, pointing out their expectations for the upcoming period.

The Eighth Session of the Children's Parliament was organised by the Parliament of Montenegro, in cooperation with the Center for Children's Rights of Montenegro, with support of the UNICEF Office and the Embassy of the United Arab Emirates (UAE), on the occasion of 20 November, the day of the adoption of the UN Convention on the Rights of the Child and the recently implemented reporting before the UN Committee on the Rights of the Child in Geneva.

4.7. STUDENTS' PARLIAMENT

The Third Session of the Students' Parliament, opened by the President of the Parliament of Montenegro Mr Ivan Brajović, was held on 4 April. The participants in the Students' Parliament included 83 students from the University of Montenegro, University "Mediterranean", University of Donja Gorica and the Faculty for State and European Studies. The following responded to the students' questions: Minister of Defence Predrag Bošković, Minister of European Affairs Aleksandar Andrija Pejović, Minister of Culture Janko Ljumović, Minister of Sports Nikola Janović, National Coordinator for NATO Dragan Pejanović, State Secretary for Political Affairs at the Ministry of Foreign Affairs Mr Zoran Janković, H.E. Ambassador of Slovakia to Montenegro Roman Hloben and H.E. Ambassador of Hungary to Montenegro Krisztián Pósa.

Previously that same day, the President of the Parliament met with representatives of the students' parliaments of the said universities, who informed him on the matters of interest for the academic community. The students presented Mr Brajović with the Certificate of Appreciation for demonstrating willingness to open the Parliament of Montenegro to the youth and the discussion on Euro-Atlantic integration.

4.8. WOMEN'S PARLIAMENT







In 2017, two sessions of the "Women's Parliament" of the Montenegrin Parliament's Gender Equality Committee were held.

The sixth session of the Women's Parliament, which was held on 7 April, was dedicated to the implementation of activities on the need for greater involvement of women in public and political life, as well as involvement of young members of national minorities and Roma, in order to strengthen their engagement in politics, which has been recognised in the Action Plan for Chapter 23, adopted by the Government. At the opening of the Women's Parliament, the speakers were Vice President of the Parliament of Montenegro Mr Genci Nimanbegu, Chairperson of the Gender Equality Committee Ms Nada Drobnjak, Minister of Human and Minority Rights Mr Mehmed Zenka, Protector of Human Rights and Freedoms Mr Šućko Baković, and Advisor to the President of Montenegro Ms Sonja Tomović Šundić. Participants in the session included numerous representatives of parliamentary and governmental mechanisms for gender equality issues from the region, as well as representatives of the state institutions, diplomatic corps and local self-governments.

The Seventh Session of the Women's Parliament, dedicated to the implementation of activities on prevention and elimination of violence against women and domestic violence in the course of the global campaign "16 Days of Activism against Violence against Women", was held on 6 December 2017. The Session was opened by the President of the Parliament of Montenegro Mr Ivan Brajović, who said on that occasion that by opening parliamentary doors, we gave support to raising public awareness and increasing political will and resources for preventing and ending

all forms of violence against women. He emphasised that gender-based violence was in the heart of human rights and that in many ways it is a decisive factor in creating a just society, and that the level of tolerance for all aspects of gender inequality and every type of violence reflects our degree of achieved liberties.

Other speakers in the Session were: vice presidents of the Parliament of Montenegro Branimir Gvozdenović and Genci Nimanbegu, Protector of Human Rights and Freedoms of Montenegro Šućko Baković, and President of the Supreme Court of Montenegro Vesna Medenica, as well as Commissioner for the Protection of Equality of the Republic of Serbia Brankica Janković. After this, representatives of the Government of Montenegro answered the questions by representatives of women's associations of parliamentary parties as well as by representatives of civil society.


There was also a presentation of the research on domestic violence and violence against women, conducted within the Program "Support to the anti-discrimination and gender equality policies", funded by the EU Delegation to Montenegro, and implemented by the United Nations Development Programme (UNDP) to Montenegro in cooperation with the Ministry of Human and Minority Rights. The research was presented by Katarina Jovanović, IPSOS Strategic Marketing, Belgrade.

While concluding the Seventh Session of the Women's Parliament, Chairperson of the Gender Equality Committee Nada Drobnjak said that actions were needed to measurably reduce violence against women and domestic violence, and for it to cease to be a threat to women and a part of the lives of many families, and that the Gender Equality Committee would focus on this problem with due diligence in the coming period.

V ADMINISTRATIVE CAPACITIES

5.1. HUMAN RESOURCES

In the reporting period, the strengthening of administrative capacities was continued. In that respect, the Human Resources Plan of the Parliament of Montenegro was adopted, which is also an obligation stemming from Article 149 of the current Law on Civil Servants and State Employees. The Human Resources Plan presents both collective and individual data on employees of the Service of the Parliament of Montenegro, and the requirements for new hiring in 2017. At the end of 2017, there were 164 employees in the Parliamentary Service. That number also covers the following: Secretary General, two deputies Secretary General, Head of the Cabinet of the President, two assistants Secretary General, 11 advisers to the President and vice presidents of the Parliament of Montenegro, and 147 civil servants and state employees.

In the HR area, it is important to note the Human Resources Development Strategy defining the goals and activities that, are mainly focused on establishing internationally recognised stan-

dards in the quality of management and work, and on the creation of conditions for assuming and performing new tasks after Montenegro's acquiring of the status of an EU member.

Furthermore, the parliamentary staff attended a large number of trainings, just like in the previous years. In 2017, the parliamentary staff attended 70 trainings, with a total of 169 attendees. Out of the above number, employees attended 18 trainings organised by the Human Resources Administration, while the remaining 52 were trainings organised by the Parliament of Montenegro in cooperation with its partners, or organised by the local, foreign and international organisations.

5.2. LIBRARY AND RESEARCH

In 2017, the Research Centre prepared 18 research papers, containing a total of 561 pages, responding to all the submitted requests in accordance with the prescribed procedures, including: twelve papers at the request of MPs, five at the request of the Secretary General and one paper at

the initiative of the Centre. The research papers are available on the website of the Parliament of Montenegro, while an appendix of the Report lists all research papers written in 2017. In the reporting period, the Research Centre continued to actively cooperate with the European Centre for Parliamentary Research and Documentation (ECPRD), and it drafted and sent replies, in the form of brief information drafted in English, to 95 requests sent by parliaments - members of the ECPRD network. The Centre regularly compiles weekly news from the EU institutions, which are then sent electronically every Friday to all MPs and MP groups, and on that occasion, the Centre created 42 weekly newsletters in 2017. In the reporting period, work was done to improve and complete the content of the online research platform, which contains the documents produced by the research staff of the Parliament of Montenegro, and the parliaments of Albania, Bosnia and Herzegovina, Kosovo, Macedonia, and Serbia. The basic goal of creating such database was to have a more efficient exchange of information and collected data among the research staff of the above mentioned parliaments, and it was

created with the support of the National Democratic Institute (NDI) within the framework of the Western Balkans Legislative Strengthening Initiative.

5.3. INFORMATION TECHNOLOGY

In 2017, the Parliament of Montenegro implemented a series of activities relating to the following: implementation of the system for making phonographic records from the sessions of the Parliament, implementation of the system for salaries, treasury, and vehicle fleet, the drafting of policies, procedures and rules for information technology, and implementation of a systemic solution for data backup.

Activities have also been initiated which, among other things, should ensure the setting up of daily, weekly, monthly and annual information system data storage, as well as the project of digitalisation of archive documentation, which will significantly affect the quality and efficiency of certain work processes in the Parliament.



VI FINANCES

According to the 2017 Budget Law of Montenegro, the planned funds for the Parliament of Montenegro amounted to 10,349,761.75€. The Budget of the Parliament of Montenegro amounts to 1.20% of the operating Budget of Montenegro or 0.52% of the total Budget of Montenegro.

The funds were allocated for three programmes:

- Programme Enhancing Legislative Infrastructure 5,253,412.49€
- Programme Administration 4,996,349.26€
- Programme Funding of the weekly "Koha Javore" – 100,000.00€

Total expenditures of the operating 2017 Budget of the Parliament of Montenegro amounted to 8,392,921.29€ or 81.09% of the overall funds





ENHANCING LEGISLATIVE INFRASTRUCTURE PROGRAMME



The 2017 Budget of the Parliament of Montenegro allocated funds amounting to 100,000€ for funding of the weekly "Koha Javore". The weekly in the Albanian language is published within the National Council of Albanians in Montenegro, and is funded from the programme 20101-3872 – Funds for funding of the weekly "Koha Javore" allocated to the Parliament of Montenegro in the 2017 Budget of Montenegro. A total of 99,999.9 € or 100.00% of the planned funds of the operating budget for this programme was spent.
