#### Dear readers,

You are reading the most important information about the activities of the Parliament of Montenegro in the period from 1 to 31 July, which is, in the form of monthly bulletin "Open Parliament", prepared by the Center for Democratic Transition (CDT) and the Administration of the Parliament of Montenegro.

The same as the previous month, this month is also marked by intensive parliamentary legislative activity. In July, Parliament adopted a total of 27 laws, while parliamentary committee deliberated 45 law proposals. Through exercising its oversight function, parliamentary committees, among others, deliberated the Annual Report of the Ministry of Defence, Report on the Overall situation in the Army of Montenegro for 2010, Report on the Use of Units of the Army of Montenegro in the International Forces in 2010, as well as Proposal for a Decision on Sending the Army of Montenegro in the UN Peacekeeping Mission in Afghanistan. Parliament also considered the Report on the State of the Energy Sector of Montenegro in 2010, and the Report of the Agency for Insurance Supervision in 2010 along with the Report on the State of the Insurance Market in 2010.

On the proposal of the Government of Montenegro, Parliament, at the tenth and eleventh sitting of the first regular session of the Parliament of Montenegro in 2011, adopted a Proposal to amend the Constitution of Montenegro and a Supplementary proposal to amend the Constitution of Montenegro. Also, we highlight the adoption of the following laws: the Law on Nongovernmental Organizations, the Law Amending the Law on Courts, the Law Amending the Law on Judicial Council, the Law Amending the Law on Public Prosecutor's Office and the Law on the Status of the Descendants of the Dynasty Petrovic Njegos.

We highlight the adoption of the Semi-Annual Performance Report of the Parliament of Montenegro for the period from 1 January to 30 June 2011, prepared by the Parliamentary Administration.

Bulletin "Open Parliament" is published monthly as a part of the project "Open Institutions", funded by the European Union through the Delegation of the European Union to Montenegro.

Due to the holiday season, we will not publish the August edition of the bulletin, and until September we send you the warmest greetings while waiting for your opinions, criticisms and suggestions to make this bulletin even better and more interesting.

# Second Conference of the National Convention of European Integration of Montenegro

The Second Conference of the National Convention of European integration of Montenegro was held on Tuesday, 19th July 2011 in the Great Hall of the Parliament of Montenegro.

On that occasion, Vice President of the Parliament of Montenegro Rifat Rastoder, Prime Minister of Montenegro Igor Luksic, Minister of Foreign Affairs and European Integration in the Government of Montenegro Milan Rocen, Political Director of the Ministry of Foreign Affairs of the Government of Slovakia Peter Michalko, Director of the Slovak Foreign Policy Association (SFPA) Alexander Duleba and Secretary General of the European Movement in Montenegro Momcilo Radulovic addressed the audience.

The goal of the Convention is to engage all social forces in Montenegro to contribute to the acceleration of social, political and economic reforms within the European integration process.

# Meeting of Chairpersons of Committee on Economy, Regional Policy and Infrastructure

eeting of Chairpersons of the Committee on Economy, Regional Policy and Infrastructure was held in Warsaw on 17 and 18 July. The meeting brought together parliamentarians of the EU member states and candidate countries for EU membership and was devoted to various aspects related to the issue of cohesion policy, the Strategy for Europe 2020 and the issue of trans-European transport networks. On behalf of the Parliament of Montenegro, Members of Parliament Aleksandar Damjanovic and Veljko Zarubica attended the meeting, and His Excellency Montenegrin Ambassador to the Republic of Poland Ivan Lekovic was also a member of the Montenegrin delegation.

The meeting highlighted the need for stronger cohesion policy, parliamentary cooperation and enhancement of the trans-European transport networks. The participation of Montenegrin parliamentarians was also welcomed and the message of support expressed to the integration of Montenegro into the European Union.

### Round table "Parliament, the Media and Citizens"

Round table "Parliament, the Media and Citizens" was held on Tuesday, 12 July 2011. The roundtable was attended by the representatives of party caucuses in the Montenegrin parliament, chief editors of media accredited to monitor parliamentary activity, representatives of the Delegation of the European Union in Montenegro and the British Embassy in Podgorica.

The host and the keynote speaker of the roundtable was Vice President of the Parliament of Montenegro Rifat Rastoder who said that the aim of the roundtable is the need to "identify forms of adequate cooperation between Parliament and the media through an open and concrete discussion and exchange of views and experiences," that is "to provide the citizens with the proper presentation of essentials of legal and other acts adopted by the Parliament." Vice President of Parliament Rastoder identified the establishment of stronger ties with the media and an increase in openness and cooperation as a path to a quality, responsible and free journalism and the media.

Deputy Ambassador of the United Kingdom in Montenegro HE Lian Stephens and a representative of Thomson Reuters Foundation Paul Gallagher also welcomed

participants in the roundtable.

The round table was organized by the Parliament of Montenegro within the cooperation with the Westminster Foundation for Democracy (WFD), in partnership with the Foundation of Thomson Reuters (Thomson Reuters) in London and Montenegro Media Institute.

Poland, as the presiding country from 1 July to the end of 2011, is asking for bigger Europe or Europe with more member states and deeper integration, which comprises all the three priorities including secure Europe, Europe in growth and open Europe.

Conference of European Affairs Committees of national

parliaments of member states of the European Union (COSAC) is an important framework for cooperation between national parliaments of EU member states. Given that Montenegro is a candidate country for the EU membership, the Committee on International Relations and European Integration of Parliament of Montenegro has the right to participate in the work of the COSAC as an observer.

The first meeting of the COSAC during the Polish EU Presidency discussed the 16th Biannual Report of COSAC, vis-à-vis conflicts on the EU external borders, preparations for the 46th Regular meeting of COSAC and the priorities of the Polish presidency over the EU.

# Semi Annual Performance Report of Parliament of Montenegro Launched

In order to contribute to better informing of the public about the work of the Montenegrin Parliament, the Administration of Parliament prepared a semi-annual report on the work of Parliament for the period from 1 January to 30 June 2011. The first part of the report presents a summary of parliamentary legislative activity. The report contains a review of oversight activities of Parliament and its working bodies. This year, a Calendar of activities of the Parliament has been developed for the first time, and woring bodies adopted annual reports on their activities in the previous year as well as work plans by the end of the current year. The implementation of work plans has been regularly monitored, contributing that way to better planning and efficiency of palriamenatry work.

In 2011, international activities of Parliament of Mon-

tenegro has also been intensified, primarily as a result of acquiring the candidate country status for EU membership, which is also covered by the report.

The Semi-annual performance report of Parliament also offers vital information relating to the cooperation with the civil society, including the signing of a Memorandum of Cooperation with the Network of Civil Society Organizations for Democracy and Human Rights, and a summary of activities that ensure full openness and transparency of the Parliament of Montenegro, which is, finally, the purpose of the report.

At the end, the report offers a set of annexes, as follows: list of laws and other acts adopted in the first half of the year, an overview of work of parliamentary working bodies by months and an overview of requests for free access to information.

# 20th Annual Session of the OSCE Parliamentary Assembly

The topic of this year's session of the OSCDE Parliamentary Assembly was "Strengthening the OSCE Effectiveness and Efficiency - A New Start after the Summit in Astana".

The permanent Delegation of the Parliament of Montenegro to the OSCE Parliamentary Assembly attended the 20th annual session of the parliamentary dimension, which was held in Belgrade from 6-10 July 2011.

On the first working day, a sitting of the Standing Committee held, which was attended by the Vice President of the Parliament Rifat Rastoder, as the head of the delegation. After the introductory notes from the Chairman of the OSCE Parliamentary Assembly Petros Efthymiou, and the presentation on the activities of the Committee in the past year, the following reports were presented: Report of the Director of the Treasury Robert Battelli about the current financial situation and annual contributions, followed by the approval of the Budget for the 2011-2012 financial year; Report of the Secretary General of the Parliamentary Assembly Spencer Oliver, which highlighted the increasing role of the Secretariat in the past period, and the fact that the OSCE parliamentarians have been assuming a leading role in the election observation missions, as it was the case in recent elections in Bosnia and Herzegovina, Kyrgyzstan, USA, Azerbaijan, Moldova, Belarus, Turkey; Reports on the activities of Parliamentary Assembly from individual observation missions; "Ad Hoc" Committee and Reports of special representatives. The Committee also decided about the schedule of additional items for the inclusion in the agenda of one of three general committees, or plenary sitting. Upon the completion of the sitting of the Standing Committee, inaugural plenary session was held.

On the second working day, first sittings of three general committees were held: Committee on Political Affairs and Security, Committee on Economic Affairs, Science, Technology and Environment and Committee for Democracy, Human Rights and Humanitarian Affairs. The sessions presented draft resolutions, along with reports of individual rapporteurs, followed by a vote on a number of amendments to the resolutions submitted to these three committees.

On the third day of the OSCE Parliamentary Assembly, continuations of sittings of three general committees were held, which discussed the remaining amendments to the draft Resolution "Strengthening the effectiveness and efficiency of the OSCE - A new start after the summit in Astana," as well as additional items and amendments thereof. Additional items included as follows: draft resolutions on issues of national minorities, combating violent extremism and radicalization leading to terrorism, Moldova, the OSCE approach to promoting cyber security, coordination of migration policy within the OSCE, nuclear safety and environmental protection, promotion of policy favouring the Roma population, as well as combating illegal trade in human organs, submitted by the Serbian delegation to the OSCE Parliamentary Assembly.

Plenary sitting was held on the fifth and final day of the OSCE Parliamentary Assembly, which was a continuation of the debate on resolutions adopted at previous sittings of three general committees. General Secretary of the Treasury and Director of the OSCE PA presented their reports and a secret ballot for Vice-Presidents of the Assembly was also conducted. For the second time, parliamentarians re-elected President Petros Efthymiou to one year term of office.

The Belgrade Declaration on "Strengthening the effectiveness and efficiency of the OSCE - A new start after the summit in Astana," was adioted at the end of the sitting, which was supported by more than 230 parliamentarians from 53 countries. The Declaration is a political document consisting of three general resolutions from three committee, and additional items - resolutions on topical issues, submitted by several delegations, which are also recommendations for national parliaments and the OSCE on the issues in the area of economy, security and human rights.


On the proposal of the Government of Montenegro, the Parliament of Montenegro, at its tenth and eleventh sitting of the first regular session in 2011, adopted Proposal for amendments to the Constitution of Montenegro or Supplementary proposal to amend the Constitution of Montenegro. In this regard, the Parliament instructed the Committee on Constitutional Affairs and Legislation to prepare the text of draft amendments to the Constitution.

In the Opinion on Montenegro's Application for Membership in the European Union, one of the recommendations related to strengthening the rule of law through de-politicized and merit-based appointment of members of the Prosecutorial and Judicial Council, the appointment of state prosecutor, as well as through strengthening the independence, autonomy, efficiency and accountability of judges and prosecutors.

Proposal for amendments to the Constitution of Montenegro, among others, proposes the heads of the prosecutor's office and judiciary to be elected by a majority of the total number of MPs in Parliament at the proposal of Judicial, that is, Prosecutorial Council, and the judges and prosecutors to be appointed and dismissed by the Judicial or Prosecutorial Council.

The adopted Supplementary proposal to amend the Constitution of Montenegro proposes the President of the Constitutional Court to be elected by the judges of the

Constitutional Court, and the number of judges of the Constitutional Court to be increased from seven to nine as well as and to grant immunity to the members of the State Audit Institution.



# **PARLIAMENTARY GLOSSARY**

**QUORUM**<sup>1</sup>. indicates the minimum number or percentage of members of a body whose presence and participation in the voting, i.e. decision-making is treated as a prerequisite for validity of the very act of voting or decision-making. A quorum may consist of a simple majority of all members of a body who have the right to decide or a qualified majority (i.e. majority exceeding 50% plus 1) or only a smaller part of the electorate. Usually, at the first meeting or during voting/decision making, quorum is considered to be a major part of the total voting body or electorate, and if that condition is not met, then the new meeting, new voting or new election is scheduled.

At the opening of the sitting of the Parliament of Montenegro, President of Parliament establishes whether there is a quorum. Quorum is required: at the beginning of a sitting, when the minutes are adopted; when agenda is being determined, and when voting. Quorum, however, is not needed during the debate at the sitting. Quorum is determined by the use of the electronic voting system, in a way that each MP is obligated to identify (to apply) himself/herself personally by inserting his/her identification card in the MP's outlet on his seat or based on the record list of the Secretary General of the Parliament. Also, at the request of 10 MPs, establishing a quorum is carried out by taking the roll call.

# Law on Establishing the 13 July as National Holiday

Based on Article 1 and 3 of the Decision Constituting CASNO as the supreme organ of the state power of Federal Montenegro, Presidency of the Montenegrin Assembly adopts the:

### **LAW** ON ESTABLISHING THE 13 JULY AS **NATIONAL HOLIDAY**

### **Article 1**

In order to celebrate with dignity the memory of the day of general people's rebellion against fascists and their supporters in Montenegro, 13 July shall be proclaimed National Holiday of Federal Montenegro, which will be celebrated every year with the highest honours.

#### Article 2

The Law shall enter into force immediately.

### 1 July

• Secretary General of the Parliament of Montenegro Damir Davidovic met with the Head of the Programme for Europe Westminster Foundation for Democracy Alex Romaniuk.
