# FOREWORD BY THE PRESIDENT OF THE PARLIAMENT OF MONTENEGRO

#### Dear Citizens of Montenegro,

The text in front of you is the Performance Report on the work of the 24th Convocation of the Parliament of Montenegro, covering the period from 1 January 2011 until 1 January 2012.

In accordance with the principle of transparency in the work of the Parliament of Montenegro, we use this opportunity to introduce you to the activities of our Parliament during the year 2011 as well as to our future plans, so that we can share with you our success and highlight the challenges that await us.

During 2011, the Parliament of Montenegro adopted 156 laws, as a result of intensive activity on harmonising Montenegrin legislation with the EU Acquis Communautaire and in response to demands for keeping up with modern parliamentary challenges. Given the seven key recommendations issued by the European Commission and after the hard work of the Collegium of the President of the Parliament with 54 meetings held, the Parliament of Montenegro adopted the Law on Amendments to the Law on Election of Councillors and Members of Parliament, which was one of the key conditions for further progress of the country on the demanding path towards the European integration.

In the previous year, the parliamentary bodies further contributed to quality preparation for the plenary sessions by preparing a number of legal acts, which have passed all stages of parliamentary procedures with participation of interested public. Control and consultative hearings have, as usual, proved to be an effective form of oversight over the executive power and, thus, have become one of the basic mechanisms of the Parliament in exercising its control function, which should be one of the key features of modern parliaments.

In the year behind us, the work of the parliamentary service has been further enhanced and the capacities were significantly increased by hiring additional, highly educated workforce, ready and trained to manage complex tasks primarily derived from the European integration process of Montenegro.

Live coverage of plenary sessions as well as the work of parliamentary committees provides full transparency of the entire legislative process.

This year's international activity has yielded two important presidencies: the Presidency of the Adriatic-Ionian Initiative and the South-East European Cooperation Process, on which occasion two significant Conferences of Speakers of Parliament were organised in Montenegro. Conferences of this type proved once again to be an opportunity for further enhancement of regional cooperation as well as planning of future bilateral activities, which would contribute to the exchange of experiences in specific areas of importance for Montenegro.

One more, now traditional, Cetinje Parliamentary Forum took place this year, where the parliamentarians from the countries of South East Europe contributed to the debate on security and defence in the region, as well as to the collective security systems.

This year was marked by continuity with the previous in general improvement in the work of the Parliament and numerous adopted plans for further improvement of the functioning of the Montenegrin Parliament.

I am convinced that Montenegrin citizens recognise the quality of the work of their representatives, who are directly responsible to them, not only for their promises but also to guarantee a better future of Montenegro, which is in the interest of all of us.

### **I INTRODUCTION**

In front of you is the Performance Report of the Parliament of Montenegro for the year 2011. The year behind us was marked by significant number of legislative and oversight activities, a number of novelties in the parliamentary life and we hope that it will be interesting for you to read about those activities in the following Report. This year's Performance Report, like the previous ones, contains detailed information about implemented legislative and oversight activities, publicity of the Parliament's work, parliamentary cooperation and other events relevant to the work of this House. For comparison purposes, some parts contain data for the previous year as well. By publishing this Report, the Parliament continues its practice of presenting relevant information about its work to professional and general public.

Parliamentary staff from different organisational units participated in collecting the data, in line with their area of responsibility. The reports and minutes from the plenary sittings and committee meetings, monthly activity reports, official trip reports and records kept in the organisational units on various issues were used as a source of information. The presentation of data in this Report was prepared by the Section for Research, Analysis, Documentation and Library, in cooperation with the Secretary General's Office.

The Report is divided into several chapters, as for the better presentation of collected information and data. These chapters include the following:

#### 2011 IN FIGURES

- ♦ 25 sittings of the Parliament held, with the duration of 350 hours;
- ♦ 154 laws and two constitutional acts adopted;
- ♦ 207 items on the agenda considered in the Parliament sittings;
- ♦ 1,940 amendments considered in committee meetings and 1,150 amendments in the Parliament sittings;
- ♦ 428 Parliamentary Questions tabled (35 questions to the Prime Minister, 358 questions to the ministers, and 35 supplementary questions);
- ♦ 313 committee meetings held, with the duration of 532 hours;
- ♦ 1,020 items on the agenda considered in committee meetings;
- ♦ 28 consultative and seven control hearings held;
- ♦ 1,260 pieces of information and 2,155 photos posted on the News page of the Parliament Website;
- ♦ 340 hours of programme produced;
- ♦ 49,732 visits from 35 countries made to the live streaming page of the Parliament Website, since the introduction of the service in June 2010;
- ♦ 390 annual accreditations for journalists and camerapersons/photographers from 26 electronic and print media provided, out of which eight are editorial boards outside of Montenegro; 95 daily accreditations provided;
- ♦ Service of the Parliament processed and responded to more than 150 individual questions posed by journalists, concerning parliamentary life;
- ♦ 162 requests for free access to information responded to, including 529 items;
- ♦ 231 informative reviews-briefings prepared; eight research papers produced, and 39 responses to the European Centre for Parliamentary Research and Documentation (ECPRD) requests of other parliaments and institutions provided;
- ↑ 100 remarks heard by representatives of civil sector (proposals, requests, amendment proposals, requests for free access to information submitted directly to the committees, comments on draft legislation, appeals, petitions, etc.) in parliamentary committees, and 110 participations of 60 organisations in committee meetings, including the participation in consultative hearings;
- ♦ 22 out of total 31 measures envisaged by the Action Plan for Strengthening of the Legislative and Oversight Role of the Parliament of Montenegro have been realised; nine measures have been partly realised;
- ♦ 125 were employed in the Service of the Parliament on 31 December 2011, in comparison to 92 employed on 31 December 2010;
- ♦ 90 training sessions conducted for employees of the Service of the Parliament.

- ♦ EPA registry established and EPA records used in the parliamentary service since the beginning of 2011;
- ◇ Parliament of Montenegro Calendar of Activities covering the period until the end of the spring session, i.e. the end of July, adopted in February 2011. The Calendar of Activities covering the period 1 September 31 December 2011 adopted in September;
- Work plans for 2011, containing the plan of oversight activities and annual performance reports for the year 2010 adopted by all committees;
- ♦ The practice of committee secretaries preparing informative review briefing, for each item on the agenda considered in committee meetings, was introduced; guidelines for preparation and the content of the briefing adopted;
- ♦ System of monthly reporting developed in the Service of the Parliament, providing better insight into the work of organisational units and, at the same time, facilitating the preparation of semi-annual and annual reports of the Parliament;
- ♦ The Rules of Procedure of the Section for Research, Analysis, Library and Documentaion, as well as the Rules on producing research papers, together with the Request Form, adopted;
- ♦ Human Resources Development Strategy adopted, together with the Strategic and Training Plan.
- ♦ Memorandum of Understanding between the Parliament of Montenegro and Network of Civil Society Organisations for Democracy and Human Rights signed on 30 March. At the same time, the Form for submission of opinions of the representatives of the civil sector posted on the Parliament Website;
- ♦ The Service of the Parliament created all required prerequisites for introducing the Broadcast service of the Parliament of Montenegro, i.e. the notification system via short SMS messages delivered to mobile phones;
- ♦ Issuance of monthly bulletin "Open Parliament" started, in cooperation with the Centre for Democratic Transition, and with support of the European Commission through the Delegation of the EU to Montenegro;
- ♦ Parliament's Semi-Annual Performance Report (for the period 1 January 30 June) was published in July together with the Information Paper on the legislative and oversight activity of the 24th Convocation of the Parliament of Montenegro until the end of the spring session in 2011;
- ♦ Live coverage of all press conferences from the press position in the Parliament via Parliament Website enabled;
- Decision on amendments to the Rules of Procedure of the Parliament of Montenegro adopted in July. Amendments primarily refer to the compensation for Service of the Parliament aiming at strengthening parliamentary autonomy, i.e. strengthening administrative capacities;
- ♦ Implementation of the project in the area of harmonisation of legislation and legislative impact assessment commenced, in cooperation with the EU Delegation in Podgorica;
- ♦ Memorandum of Understanding with the Westminster Foundation for Democracy and the British Council until March 2013 signed, during which the support in many areas of parliamentary life will be provided;
- ♦ Posting of the voting results of MPs on Parliament Website commenced in November.



## II BASIC INFORMATION

#### 2.1. MEMBERS OF THE PARLIAMENT

The elections for this Convocation of the Parliament have been the first elections since the adoption of the new Constitution. They were held in March 2009, and the 24th Convocation of the Parliament was constituted in April 2009. It consists of 81 Members of Parliament coming from 10 political parties and one Group of citizens.

# 2.3. THE PRESIDENT, VICE-PRESIDENTS, SECRETARY GENERAL AND DEPUTY SECRETARY GENERAL OF THE PARLIAMENT

#### RANKO KRIVOKAPIĆ, THE PRESIDENT

Born in Kotor on 17 August 1961.

A graduate lawyer; Oral Master's Examination in International Relations passed at the Law Faculty in Belgrade.



#### **EMPLOYMENT:**

- ♦ President of the Parliament of Montenegro since July 2003, during the 22nd, 23rd and 24th Convocation;
- After the Referendum on the state legal status of Montenegro in October 2006, he was elected as the President of the Constituent Assembly of the Republic of Montenegro and as the Chairman of the Constitutional Committee of the Constituent Assembly of the Republic of Montenegro, until the proclamation of the Constitution in 2007;
- Elected as MP to eight convocations. First time, he was elected in 1989 in the Parliament of Montenegro; in the Parliament of the Federal Republic of Yugoslavia, he was elected from 1993 until 1997, and to the Parliament of the State Union of Serbia and Montenegro, he was elected from 2003 to 2006.

#### **POLITICAL ENGAGEMENT:**

- ♦ Political career started in the late 80s. He was a member of the Presidency of the Reform Forces for Montenegro in 1990;
- ♦ President of the Social-Democratic Party of Montenegro (SDP);
- One of the founders of the Social-Democratic Party (1990), which has been a full member of the Socialist International (SI) since 1996;
- ♦ Member of the Presidency of the Party of European Socialists (PES).

**FOREIGN LANGAUGES:** Fluent in English.



#### RIFAT RASTODER, THE VICE-PRESIDENT

Born in Radmanci (Bihor) near Berane on 11 July 1950. Resides in Podgorica. The Vice-President of the Social Democratic Party of Montenegro, journalist and publicist.



#### **EMPLOYMENT:**

- ♦ Since 1998 he has been on the duty of the Deputy Speaker of the Parliament of Montenegro;
- ♦ He was elected MP and The Vice-President of the Parliament of Montenegro in the last six convocations. In several mandates he also performed the function of the president of the SDP MP Group, as well as the function of the Chairman of the Committee on Human Rights;
- ♦ He has been professionally engaged in journalism since 1980. He is one of the most commissioned journalists, commentators and editors of programme blocks and features of RTV MNE, and since 1986 he has been with the Pobjeda Daily;
- Since 1990 he has been one of founders and associates of several independent media;
- ♦ Proclaimed the best journalist in 1990; a member of Association of Independent Journalists of Montenegro;
- ♦ Co-author of "Crvena Mrlja" (Red Smear) (1990), author of "Usud imena" (Fate of the Name) and "Pravo na Ime" (Right to a Name), several feuilletons and studies on human and minority rights, freedom of media, etc;
- ♦ Distinguished sportsman one of the first Montenegrin masters of karate, competitor, coach and referee in the sport:
- One of the founders of alternative theatre in Montenegro (student's experimental stage under AKUD "Mirko Srzentić" and DODEST Theatre Podgorica).

#### **POLITICAL ENGAGEMENT:**

- ♦ One of founders and the Vice-President of the Civic Movement: "The Public against Fascism" (1990); a member of the Presidency of the Civic Forum of Montenegro (1990); one of the initiators of the Reform Movement for Montenegro (1990);
- ♦ One of the founders of the Social Democratic Party of Montenegro.

**NATIONALITY:** Bosniak.

MARITAL STATUS: Married, father of two.

FOREIGN LANGUAGES: Fluent in Russian, communicates in English.



#### ŽELJKO ŠTURANOVIĆ, THE VICE-PRESIDENT

Born in Nikšić on 31 January 1960.

He graduated from the Faculty of Law in Podgorica in 1983, as the top student of the class.



#### **EMPLOYMENT:**

- ♦ The Vice-President of the Parliament of Montenegro since the constitution of the 24th Convocation;
- ♦ On 10 November 2006 he was appointed the Prime Minister of the Government of the Republic of Montenegro. He performed this duty until 29 February 2008;
- During the period from 2 July 2001 to 10 November 2006 he was the Minister of Justice in two terms of office:
- ♦ He worked in the Steel Factory Nikšić after he graduated.

#### **POLITICAL ENGAGEMENT:**

- From 1993 he was an MP in two terms of office in the Council of Citizens of the Parliament of SRY, and in the second term of office he was the chief to the DPS MPs Club of Montenegro;
- ♦ Since 1993 he was a member of highest bodies of the Democratic Party of Socialists;
- ♦ On 5th Congress of DPS of Montenegro on 19 May 2007 he was elected the Vice-President of the Democratic Party of Socialists of Montenegro.

Born in Kotor on 17 November 1978.

# III LEGISLATIVE AND OVERSIGHT ACTIVITY

Very dynamic legislative and oversight activity of the Parliament of Montenegro has been determined by the need to fulfil the obligations primarily related to the harmonisation of our legislation with international standards and the EU Acquis Communautaire.

During 2011, the Parliament was committed to implementing the Action Plan for Strengthening of the Legislative and Oversight Role of the Parliament of Montenegro for the period from December 2010 until November 2011, as evidenced by the four quarterly reports on its implementation, prepared by the Service of the Parliament. The reports contain the narrative part, with a brief description of activities implemented during the reporting period, as well as the tabular review, with indicators and status, and degree of realisation. In addition, monthly reports on the implementation of the Action Plan have been regularly submitted to the Ministry of Foreign Affairs and European Integration, which prepares and submits an integrated report to the European Commission.



The Committee on International Relations and European Integration implemented a measure envisaged by the Action Plan for Strengthening of the Legislative and Oversight Role of the Parliament, which refers to the monitoring and control of implementation of the recommendations from the European Commission Opinion on Montenegro's application for EU membership, and the Analytical Report accompanying the Opinion. At the end of March, at a joint meeting with the National Council for European Integration (NCEI), this committee deliberated on Government of Montenegro's first monthly report on the implementation of obligations under the Action Plan for Monitoring the Implementation of Recommendations given in the Opinion of the European Commission. In May, it was agreed that monthly reports of the Government be regularly reviewed in future.

The novelty in the work of the working bodies is that parliamentary committees, in accordance with the Action Plan for Strengthening of the Legislative and Oversight Role of the Parliament of Montenegro for the period from December 2010 until November 2011, adopted work plans for 2011. In April, the Security and Defence Committee adopted a special Plan for carrying out its oversight role in 2011. In addition, for the purpose of increasing the efficiency of their performance, for the first time the committees prepared and adopted annual performance reports for the year 2010. All these documents are available on the Parliament Website.



It is also important to mention the role of the Parliament of Montenegro in the fight against corruption. Anti-corruption struggle of Parliament, through its legislative function, consists in adopting laws, which to the greatest possible extent contributes to improving public administration environment, transparency and accountability of the government sector. In accordance with the Programme for Combating Corruption and Organised Crime and Action Plan for its implementation, activities in the Parliament were dynamic and demonstrated the willingness of the legislative body to put an end to these negative social phenomena. In this regard, the Committee on Political System, Judiciary and Administration adopted and published the Innovated Report on the Implementation of the Resolution on the Fight against Corruption and Organised Crime, which covers this issue in more detail.


#### 3.1. SITTINGS OF THE PARLIAMENT

During the reporting period, from 1 January until 31 December 2011, 21 regular and four extraordinary sittings of the 24th Convocation of the Parliament of Montenegro were held; 240 acts, of which 97 laws, 57 amendments to laws, two constitutional acts, 37 decisions (21 decisions on election and appointment), 27 conclusions and 20 reports, were adopted. For comparison purposes, in 2010, 19 regular sittings of the Parliament of Montenegro were held, where two constitutional acts, 106 laws, 46 amendments to laws and 61 other acts were adopted (a list of laws and other acts adopted in 2011 is provided in the Annex 1).




#### 3.1.1 PROPOSED ACTS

In the reporting period MPs submitted one proposal for amendment of the Constitution of Montenegro, two constitutional acts, 32 proposals for laws on amendments to laws, seven decisions, one declaration and two resolutions. In the same period, the Government of Montenegro submitted 106 proposals for laws, 54 proposals for laws on amendments to laws, two decisions and one proposal for amendment of the Constitution of Montenegro. The citizens did not submit any proposals for laws through an authorised MP in the year 2011.


#### 3.1.2 ADOPTED ACTS

On the proposal of MPs nine laws<sup>8</sup> and five decisions<sup>9</sup> were adopted. During the same period, 97 laws, 50 amendments to laws and two decisions were adopted on the proposal of the Government.



#### 3.1.3 TYPE OF PROCEDURE

135 laws were adopted by the standard procedure, while 21 laws were adopted by the summary procedure.

# 3.1.4 THE NUMBER OF CONSIDERED AND ACCEPTED AMENDMENTS TO THE PROPOSAL FOR A LAW

Out of total 1,150 considered amendments to proposals for laws 723 amendments were adopted on the sittings of Parliament. The number of amendments submitted by working bodies was 403, of which 400 amendments were adopted (Constitutional Issues and Legislative Committee - 359 amendments<sup>10</sup>; Committee on Political System, Judiciary and Administration, - 18 amendments; Security and Defence Committee – seven amendments; Committee on Economy, Finance and Budget – 14 amendments<sup>11</sup>; Committee on Human Rights and Freedoms – four amendments; Committee on Health, Labour and Social Welfare - one amendment). MPs submitted 728 amendments to proposals for laws, of which 305 were adopted, 283 were not adopted, and MPs receded from 140 amendments<sup>12</sup>. The Government submitted 19 amendments, of which 18 amendments are part of the proposal for a law and the Government receded from one amendment.

#### 3.1.5 PRIME MINISTER'S HOUR AND PARLIAMENTARY QUESTIONS

In the reporting period, five special sittings devoted to the Prime Minister's Hour and Parliamentary Questions were held. A total of 35 questions were tabled to the Prime Minister, 358 questions were tabled to the members of Government, as well as 35 supplementary questions. In 2010, 18 questions were tabled to the PM, 190 questions were tabled to the members of Government as well as 38 supplementary questions.



- ♦ Social-Democratic Party MP Group 32 questions;
- ♦ New Serb Democracy 65 questions and 13 supplementary questions;
- ♦ Movement for Changes MP Group 39 questions and four supplementary questions;
- ♦ Bosniak Party MP Group nine questions;
- ♦ Albanian MP Group 19 questions and one supplementary question.





#### 3.1.6 CALENDAR OF ACTIVITIES OF THE PARLIAMENT

The Calendar of activities of the Parliament of Montenegro for the period until the end of spring session, i.e. the end of July, was adopted in February 2011. In addition, the Collegium of the President of the Parliament of Montenegro adopted, in September, the Calendar of activities for the period 1 September– 31 December 2011, which is posted on the Parliament Website<sup>14</sup>. The parliamentary calendar determines days in a month intended for plenary sessions, meetings of working bodies, and MP days intended for the work of MPs in their Groups and with the public.





#### 3.2. WORK OF THE WORKING BODIES

Committees of the Parliament of Montenegro have performed very actively during 2011. Over this period, 313 meetings of the working bodies were held, during 310 working days, which lasted a total of 532 hours and 36 minutes. 1,020 items on the agenda were considered at those meetings, of which 525 proposals for laws and 1,940 considered amendments.



In 2011, the oversight role of the committees has strengthened, through various mechanisms, including consultative and control hearings. Thus, during the reporting period, 28 consultative and seven control hearings were held, in comparison to 13 consultative and two control hearings held in 2010.

Article 67 of the Rules of Procedure of the Parliament of Montenegro stipulates that "representatives of the proposer of an act and submitters of amendments to the act proposal considered in the sitting shall take part in the work of the Committee", as well as that "representative of the Government, representatives of scientific and professional institutions, other legal entities and non-governmental organisations, as well as individual professional and scientific workers shall take part in the work of the committee, if invited, having no right to decide". In accordance with the Article, an increased participation of Government representatives and other segments of society in the meetings of working bodies have been noted.

The following table shows a detailed overview of data on consultative and control hearings, as well as other oversight activities of the working bodies in the year 2011.

#### OTHER OVERSIGHT ACTIVITIES OF COMMITTEES

In addition to consultative hearings, committees also organise thematic meetings and meetings outside the Parliament of Montenegro, town hall meetings and roundtables on current issues, as well as other similar activities. The following is a brief overview of some of those activities, which took place in the reporting period:

- ♦ Committee on Human Rights and Freedoms, in cooperation with the OSCE mission, organised the town hall meeting on the topic: "Rights of the Child implementation of the Law on Preschool Education and the Law on Protection against Domestic Violence", in Cetinje on February 28. Also, the Committee held the town hall meeting at the Department for education and rehabilitation of persons with hearing and speech disorders, in Kotor on 30 September, on the topic: "Rights of the Child Implementation of the Law on Education of Children with Special Educational Needs". In addition, the town hall meeting was held in Berane on 28 October on the topic "Implementation of the Anti-Discrimination Law";
- ♦ Security and Defence Committee held a meeting on 9 May, at which it deliberated on the Information Paper on acting of the Supreme State Prosecutor's Office of Montenegro in the case of "Balkan Warrior". Beside members of the Committee, the meeting was also attended by Supreme State Prosecutor Ms. Ranka Čarapić;
- ♦ Committee on Gender Equality, in cooperation with the OSCE Mission to Montenegro and UNDP office in Montenegro, organised on May 27 a presentation of the publication "Survey on Knowledge and Application of the Law on Gender Equality in the Institutions of Montenegro". Also, a roundtable discussion on the "Participation of Women in Political and Public Life − Challenges and Opportunities" was organised by the Gender Equality Committee, Ministry for Human and Minority Rights and the OSCE Mission to Montenegro on 27 June 2011;
- ♦ Committee on Political System, Judiciary and Administration, pursuant to the Resolution on the Fight against Corruption and Organised Crime, unanimously accepted the Report on implementation of the Resolution on the Fight against Corruption and Organised Crime at the meeting held on 20 July 2011;
- ♦ Committee on Health, Labour and Social Welfare held on 25 March a meeting on the occasion of the World Tuberculosis Day, while, on 15 April, the Committee organised a roundtable in cooperation with German Foundation Konrad Adenauer on the topic "Parliament and social policy − current social policy challenges in Montenegro and in Germany";
- ♦ Administrative Committee held on 31 May the first public debate on the topic "How to determine an NGO representative in the Election and Appointment Procedure", which was attended by seven non-governmental organisations;
- ♦ Committee on Tourism, Agriculture, Ecology and Spatial Planning held on 9 February a thematic meeting on the occasion of application submitted by MANS in relation to the Information Paper on the destruction of surplus ammunition on the temporary range "Prage" nearby Nikšic; on April 6, the Committee held a thematic meeting at which the draft Law on Utility Services was presented;
- ♦ Committee on International Relations and European Integration reviewed, at the meeting held on 2 November 2011, the activities performed by working bodies of the Parliament for the period January September 2011, all in relation to findings and recommendations in the European Commission Analytical Report. Also, on 14 November, the Committee held a town hall meeting in Bijelo Polje and Kolašin on the "Role of the Parliament of Montenegro in the process of European integration".




# IV PARLIAMENTARY COOPERATION

The Parliament of Montenegro is the member of the most important regional and international parliamentary associations – Parliamentary Assembly of the Council of Europe (PACE), Parliamentary Assembly of the Organisation for Security and Cooperation in Europe (OSCE PA), the Inter-Parliamentary Union (IPU), Association of Secretaries General of Parliaments, Parliamentary Assembly of the North Atlantic Treaty Organisation (NATO PA), Parliamentary Assembly of the Mediterranean – PAM and Euro-Mediterranean Parliamentary Assembly (EMPA). The Parliament of Montenegro also has good cooperation with the parliaments of EU Member States, parliaments in the region and with the parliaments of other countries, through regular parliamentary friendship groups and other forms of bilateral cooperation.

A very intensive cooperation with other parliaments is maintained through regional initiatives – Central European Initiative, Southeast European Cooperation Process and the Adriatic-Ionian Initiative, that the Parliament of Montenegro is a member of, and which parliamentary dimensions it has been chairing in the period 2010 - 2011.

The past year has been marked by active international activity of parliamentary committees, which is in large part a result of acquiring the candidate status for EU membership. In 2011, 44 delegations of working bodies, which consisted of one to seven members, went abroad under official, work or study visit (one visit was a joint visit of two working bodies) and they are as follows: 15 trips by the delegation of the Committee on International Relations and European Integration, nine trips by the delegation of the Security and Defence Committee, eight trips by the delegation of the Committee on Economy, Finance and Budget, three trips by the delegation of the Committee on Political System, Judiciary and Administration, two trips by the delegation of the Committee on Human Rights and Freedoms, three trips by the delegation of the Committee on Tourism, Agriculture, Ecology and Spatial Planning, one trip by the delegation of the Gender Equality Committee, one trip by the delegation of the Commission for Monitoring and Control of the Privatisation Procedure, two trips by the delegation of the Administrative Committee. For comparison purposes, 10 trips of the international nature took place in the previous year.

This chapter contains information on activities of the Parliament in the field of Euro-Atlantic integration, outgoing and incoming visits, events organised by international parliamentary organisations and regional initiatives, as well as information on cooperation of the Parliament with foreign and international organisations.





#### 4.1. EUROPEAN INTEGRATION

International cooperation has been particularly intensified after acquiring the candidate status for EU membership, and, thus, for the first time in April, the President of the Parliament participated at the Conference of Speakers of the Parliaments of the EU, which aimed to promote the role of parliaments and oversight of coordination of interparliamentary activities.

In addition, after Montenegro was granted the candidate status, representatives of the Parliament of Montenegro, as observers, for the first time had the opportunity to participate in the meetings of committee representatives of national parliaments of EU Member States, which were organised during Hungarian and Polish presidency of the Council of the European Union. This opportunity allowed the realisation of regular political dialogue between Montenegrin MPs and their counterparts from the national parliaments of the European Union, as well as exchange of views regarding the current policies of the European Union.

The meeting of the EU – Montenegro Stabilisation and Association Parliamentary Committee, held on 17 and 18 May 2011 in Podgorica, presents the second in a series of meetings of the Joint EU – Montenegro Stabilisation and Association Parliamentary Committee, which was established after the entry into force of the Stabilisation and Association Agreement between the European Community and Montenegro, pursuant to the Article 125 of the Agreement. The Declaration and Recommendations were adopted at the second meeting.

The third meeting of the EU – Montenegro Stabilisation and Association Parliamentary Committee was held in Brussels on 3 and 4 October 2011. The Declaration and Recommendations were adopted on that occasion, acknowledging the achieved progress in various areas within the process of Montenegro's accession to the EU, and identifying areas in which it is necessary to make additional efforts in the future, to meet European standards necessary for full membership in the European Union.

#### 4.2. VISITS OF REPRESENTATIVES OF OTHER STATES AND PARLIAMENTS

During the reporting period, a number of visits and meetings had been arranged between the representatives of the Parliament of Montenegro and numerous delegations and officials in the framework of bilateral cooperation with other countries and parliaments, as well as with representatives of foreign and international organisations.

The following delegations visited the Parliament of Montenegro during 2011: European Parliament, Parliamentary Assembly of the Council of Europe, Parliamentary Assembly of NATO, Parliamentary Assembly of OSCE, Parliament of the Republic of Macedonia, German Parliament, National Assembly of Hungary, EU COWEB, Ministry of Foreign Affairs of the Islamic Republic of Iran to Europe, Ministry of Foreign Affairs of Greece, Ministry of Foreign Affairs of the United Kingdom of Great Britain and Northern Ireland, Ministry of Foreign Affairs of the Russian Federation, Ministry of Foreign Affairs of the Republic of Azerbaijan, Ministry of Foreign Affairs of the Republic of Cyprus, Ministry of Foreign Affairs of BiH, Croatian Parliament, Bavarian Parliament, Senate of the Czech Republic, Statistical Office of the EU (EUROSTAT), Parliament of the Netherlands; and meetings with representatives of the Parliament of Montenegro had the ambassadors of the United States, Canada, People's Republic of China, the United Arab Emirates, Bosnia and Herzegovina, Slovenia, Norway, Belgium, United Kingdom, Republic of Cuba, the Russian Federation, Ukraine, NATO countries, South Korea, President of the Czech Republic, Deputy Prime Minister of Kosovo, as well as representatives of the European Commission, North Atlantic Alliance (NATO), State Department, National Democratic Institute (NDI), United Nations Development Programme (UNDP), UNICEF, SIGMA mission, International Monetary Fund, European Bank for Reconstruction and Development, Centre for the internal management of Berlin, Hadži Nadžija Karabegović Agušević Fund (HNKA), Services for the Western Balkans of the Department for EU External Relations, Department for Montenegro and Albania of the Directorate-General Enlargement of the European Commission, Regional Cooperation Council, German Konrad Adenauer Foundation, European Broadcasting Union (EBU), Global Organisation of Parliamentarians Against Corruption (GOPAC), ERSTE Foundation and German Agency "Müllers Freunde", Women's Division of the Washington Office of Public Policy, American organisation- Democracy International, Council of Europe Group of Experts on Action against Trafficking in Human Beings (GRETA), Venice Commission's Expert Mission, Westminster Foundation for Democracy (WFD).



#### ACTIVITIES OF THE PRESIDENT OF THE PARLIAMENT OF MONTENEGRO, RANKO KRIVOKAPIĆ



In 2011, President of the Parliament of Montenegro, Ranko Krivokapić, hosted a number of officials and representatives of parliaments, foreign and international organisations, including:

- Official visit of the President of Parliament of the Republic of Macedonia, Trajko Veljanoski, to Montenegro on 27 and 28 January. During the visit, it was agreed that parliaments have a significant role in rapprochement and also help the joint efforts of the two countries to be a part of the European family; that Montenegro and Macedonia will cooperate in the integration process in order to achieve, as soon as possible, a common European and Euro-Atlantic aspirations. Within the visit of the President and the delegation of the Assembly of the Republic of Macedonia, a special meeting of the Parliamentary groups of friendship between Montenegro and Macedonia was held;
- ♦ Meeting with the Deputy Director General for Enlargement of the European Union, Stefano Sannino, during his official visit to Montenegro in February. The interlocutors expressed satisfaction with the acquisition of candidate status for EU membership, a positive opinion on Montenegro's readiness for EU membership, as well as a broad consensus in Montenegrin Parliament on the European integration of Montenegro;
- Meeting with the European Commission President, Jose Manuel Barroso, on 8 April. During the meeting, it was agreed that Montenegro is a positive example in the Western Balkans in terms of meeting the European criteria and the speed in democratic development, which might be an incentive to all countries where these challenges are still ahead;
- Meeting with President of the Czech Republic, Vaclav Klaus, during his official visit to Montenegro in April. During the meeting, it was pointed out that the Czech Republic strongly and unreservedly supports Montenegro's European course, and that the process quality of fulfilling obligations along this course is more important than the date of full membership;
- Meeting with Foreign Minister of the Russian Federation, Sergey Lavrov, in April. During the visit, the interlocutors exchanged views on current international and regional issues and bilateral relations between the two countries, with special emphasis on economic cooperation. Krivokapić and Lavrov commonly stressed the willingness for further promotion of key directions for cooperation between Montenegro and the Russian Federation, in accordance with the traditional friendship ties;



- Meeting with the U.S. Deputy Assistant Secretary of State, during which it was emphasised that the rule of law is a key challenge for the country, and that the quality and dynamics of the overall integration policy will depend on the further results in this area. The President of the Parliament of Montenegro reminded the visitors of the substantial assistance and support that the United States continuously provide to Montenegro, which provide an important incentive for the overall democratic process in our country;
- Meeting with NATO Member States Ambassadors, held in May, during which the ambassadors expressed their interest in the results of the overall reform process, the affirmation of Montenegro's membership in NATO with an emphasis on public support, the competence of the Security and Defence Council and the issue on the adoption of electoral legislation;



- A joint meeting with the EU Member States Ambassadors to Montenegro in March, June, September and December, to exchange views on current foreign policy issues, with an emphasis on the process of Montenegro's accession to the European Union;
- Meeting with Bulgarian President, Boyko Borisov, during his official visit to Montenegro in July. On that occasion, the interlocutors exchanged views on the long road ahead of Montenegro on negotiations, which Bulgaria has already overcome, as well as the mechanisms and models of cooperation between small countries, their role in the Western Balkans and the possibilities of cooperation in key areas for the region, such as energy and infrastructure;
- Meeting with Minister of Foreign Affairs of Germany, Guido Westerwelle, in August, during which the interlocutors expressed confidence that relations between Montenegro and Germany would still be characterised by very good cooperation, support and mutual understanding;
- ♦ Meeting with President of Slovenia, Danilo Turk, in September, during which it was discussed about the current political situation, and during which Slovenian President expressed special interest in the process of Montenegro's accession to the EU, focusing on election law and the next stage of its process;
- Meeting with President of the European Court of Human Rights in Strasbourg, Jean-Paul Costa, in September. The interlocutors assessed that Montenegro is objectively ready for the next stage of integration, which is best shown through the following results continued political stability, broad social and political consensus on European integration, progress in meeting European standards, a positive example of good neighbourly relations and regional cooperation, and the total constructive approach in dealing with all the European partners;
- Meeting with President of Slovakia, Ivan Gasparovič, during which the interlocutors talked about political situation, the process of Montenegro's accession to the EU with a focus on the next stage of integration, regional cooperation and relations, as well as current cooperation programme between the two countries;
- Meeting with the commander of NATO joint forces in Naples, Admiral Samuel, Locklear, in September. The interlocutors exchanged views on current international and regional issues and Montenegro's progress into NATO integration;



- ♦ Meeting with the delegation of the Chinese People's Political Consultative Conference (CPPCC) headed by Mr. Chen Kuiyuan, Vice-President of CPPCC, in September. During the meeting, the interlocutors exchanged views on parliamentary cooperation and the political and economic situation;
- ♦ Meeting with the Commissioner for Enlargement and European Neighbourhood Policy, Stefan Fule, in May and October. During these meetings, Fule praised the efforts of Montenegro to the European integration process that led to the recommendation to open accession negotiations with Montenegro;
- ♦ Visit of the President of Croatian Parliament, Luka Bebić, who paid an official visit to Montenegro on 17 and 18 November. During the visit, President Krivokapić said that the President of Croatian Parliament contributed significantly to the development of relations between the two countries, and not only between the parliaments. In addition, they discussed about cooperation in the economic areas that must be strengthened, as well as making up for missed opportunities in this area that would have its repercussion on the further improvement of the overall cooperation between the two countries;
- Meeting with the delegation of the Venice Commission's Expert Mission, representatives of the European Commission and EU member states experts in November, regarding the exchange of views on the Draft amendments to the Constitution of Montenegro;
- Meeting with the Ambassador of the United Kingdom of Montenegro, H.E. Catherine Knight- Sands, Executive Director of the Westminster Foundation for Democracy (WFD) Linda Dafild, and the British Council Regional Director Tony O'Brien. A reception took place on the occasion of signing the Memorandum of Cooperation between the Parliament of Montenegro, Westminster Foundation for Democracy and the British Council;
- Meeting with a delegation of the Senate of the Parliament of the Czech Republic, led by Chairman of the EU Affairs, Luděk Sefzik, in November. During the meeting, the interlocutors exchanged views on the process of harmonising national legislation with the EU, the dynamics of this process and further challenges on the road to the EU;
- Meeting with Ukrainian Prime Minister, Mikola Azarov, in December. The possibilities for cooperation between Montenegro and Ukraine in the field of culture, tourism and transport infrastructure were highlighted on this occasion.

# ACTIVITIES OF THE VICE-PRESIDENT OF THE PARLIAMENT, ŽELJKO ŠTURANOVIĆ

♦ Vice President of the Parliament, Željko Šturanović, met with the President of the National Assembly of the Republika Srpska, Igor Radojičić, in May. Deputy Šturanović introduced to Mr. Radojičić the structure and functioning of the Parliament of Montenegro as well as its current activities towards the EU;





- Vice President of the Parliament, Željko Šturanović, received the Ambassador of the Republic of Korea, H.E. Kim Jong-Hae in his farewell visit in September. During the meeting, the interlocutors agreed that there is a need to intensify parliamentary cooperation between the two countries;
- Vice President of the Parliament, Željko Šturanović, met with the President of the Supreme Court and the National Judicial Council of the Republic of Hungary Andras Bake in September. The meeting was attended by the President of the Supreme Court of Montenegro Vesna Medenica. The interlocutors expressed satisfaction that, due to the overall framework of good cooperation between the two countries, the cooperation among highest judicial instance gained on its quality and intensity;
- Vice President of the Parliament of Montenegro, Željko Šturanović, received the delegation of the Bavarian Parliament's Committee on Relations with the Federation and Europe, in October, headed by the Committee Chairperson Ursula Menlo. The meeting was attended by German Ambassador to Montenegro H.E. Pius Fischer. Members of the Bavarian Parliament delegation paid their acknowledgement to Montenegro on the achieved results towards European and Euro-Atlantic integration;
- Vice President of the Parliament of Montenegro, Željko Šturanović, met, in October, with the Special Representative of the OSCE Parliamentary Assembly and Head of the Vienna Liaison Office of the OSCE PA Ambassador, Andreas Nothelle, and OSCE PA Special Representative on South East Europe, Roberto Battelli (Slovenia). During the meeting, the interlocutors agreed on the growing importance of the oversight role of the Parliament, noting that an overall awareness of its importance, as part of a regular procedure in the work of Parliament, changes.

# ACTIVITIES OF THE VICE-PRESIDENT OF THE PARLIAMENT, RIFAT RASTODER

- Vice President of the Parliament and President of the Group of Friendship of Montenegrin Parliament with Iranian Parliament, Rifat Rastoder, received Iran's Deputy Foreign Minister for European Affairs Ali Ahani in January;
- Vice President of the Parliament of Montenegro, Rifat Rastoder, and MPs Radivoje Nikčević, Aleksandar Damjanović and Amir Hollaj spoke with the Deputy Head of the Unit, Montenegro and Albania, of the Directorate General for Enlargement of the European Commission, Vassilis Maragos, as well as with representatives of the EU Delegation to Montenegro, in April. The conversation was mostly focused on the harmonisation of the electoral law with the Constitution of Montenegro;
- Vice President of the Parliament of Montenegro, Rifat Rastoder, along with members of the parliamentary friendship group with the Parliament of the Republic of Croatia received the Primorsko-Goranska County delegation, headed by country prefect, Zlatko Komadina, in July. The interlocutors exchanged views on





- current international and regional issues as well as bilateral relations, with special emphasis on economic cooperation;
- Vice President of the Parliament of Montenegro, Rifat Rastoder, received the delegation of the Department for evaluation of OSCE projects, Franklin De Vrieze and Kamila Ilyumzhinova. The OSCE representatives were interested in the effects of projects implemented in the Parliament of Montenegro, organised under the auspices of the OSCE, as well as new forms of cooperation to further strengthen the overall administrative capacities in the Parliament of Montenegro;
- ♦ Vice President of the Parliament of Montenegro, Rifat Rastoder, received representatives of an American organisation Democracy International, Gregory Minjack and Lincoln Mitchell, in October, who, on behalf of the USAID, worked on the analysis of the success of projects implemented by the National Democratic Institute NDI in cooperation with the Parliament of Montenegro. On this occasion, the role of this organisation in strengthening administrative and total capacities of parliament was highlighted;
- Vice President of the Parliament of Montenegro, Rifat Rastoder, received the Chairman of the House of Representatives of Bosnia and Herzegovina, Dr Denis Bećirović, with his associates, in December. The interlocutors stated that, in the forthcoming period, Montenegro is expected to have an intense and demanding work towards the EU, and that the experience of Montenegro will be of great benefit to Bosnia and Herzegovina.

#### 4.3. VISITS TO OTHER STATES AND PARLIAMENTS

In 2011, President Ranko Krivokapić and representatives of the Parliament of Montenegro paid a visit to the representatives of other states and their parliaments, including the National People's Congress, Slovakia's Parliament, the Parliament of Austria, the Baltic parliament, the National Assembly of the Republic of Serbia, the U.S. Congress, and the Parliament of Sweden.

#### ACTIVITIES OF THE PRESIDENT OF THE PARLIAMENT

- ♦ President of the Parliament of Montenegro, Ranko Krivokapić, paid a two-day official visit to the United Kingdom of Great Britain and Northern Ireland in June, at the invitation of both Houses of the Parliament of the United Kingdom the House of Lords Speaker of the UK Parliament, the Baroness Helene Valerie Hayman, and the House of Commons Speaker of the UK Parliament, John Bercow. In addition to meetings at the high level, the President of Montenegrin Parliament had a separate meeting with prominent members of the House of Lords, meetings with the EU committees of both Houses of the UK Parliament and meetings with members of the friendship group of the Parliament of Great Britain with Montenegro;
- ♦ President of the Parliament of Montenegro, Ranko Krivokapić, participated in the Seventh Plenary Session of the Parliamentary Assembly of the Union for the Mediterranean that took place in Rome in March, during which he held a speech at the session on the "Union for the Mediterranean and the current developments in the region". On this occasion, Krivokapić met with Italian Foreign Minister, Franco Frattini, and expressed once again gratitude to Minister Frattini as the then Vice-President of the European Commission for his initiative, which contributed to the decision on visa liberalisation, for which the citizens of Montenegro and the region received an important message that they truly belong to Europe;
- ◊ President of the Parliament of Montenegro, Ranko Krivokapić, participated in the Conference of Speakers of the EU Parliaments, which took place in Brussels in April. In the introductory part of the Conference, and after opening remarks by the host President of the Belgian Chamber of Representatives, Andre Flahaut, President Krivokapić had a special opportunity to speak about the European course of Montenegro. President Krivokapić also had a series of bilateral meetings with the President of the German Bundestag, Norbert Lammert, President of the National Assembly of Hungary, Laszlo Kever, which at that time presided over the EU Council, and Speaker of the House of Representatives of Malta Michael Frendo;
- President of the Parliament of Montenegro, Ranko Krivokapić, participated in the Thirteenth Meeting of Parliament Speakers of the regional partnership of ten countries (Austria, Czech Republic, Hungary, Slovakia, Poland, Slovenia, Bulgaria, Romania, Croatia and Montenegro) in Central and Eastern Europe", which took place in Bratislava in May. On that occasion, President Krivokapić gave presentation on the topic: "Infrastructure development and tourism in the region". In addition, President of the Parliament of Montenegro had a series of bilateral meetings with the host Speaker of the Slovak Parliament, Richard



- Sulik, Speaker of the Chamber of Deputies of the Parliament of the Czech Republic, Miroslava Nemcova, and Speaker of the Polish Senate, Bogdan Borusewicz;
- President of the Parliament of Montenegro Ranko Krivokapić, participated in a two-day Sixth Conference of Speakers of the Parliaments of Small European Countries, held in Malta in October. President Krivokapić gave presentation on the following topics: "Parliamentary Diplomacy", "Dealing of small parliaments with increasing challenges in the legislative and overall performance" and "Setting up a database and information for sharing - sharing information, resources and experience";
- President of the Parliament of Montenegro, Ranko Krivokapić, chaired, together with the President of the National Assembly of Hungary, Laszlo Kever, the Fifth Conference of Speakers of Parliaments of Western Balkan Countries, held in Budapest in October;
- ♦ President of the Parliament of Montenegro, Ranko Krivokapić, met with officials of the European Union during his visit to Brussels in the period 24 26 November, regarding the consideration of further EU enlargement process and progress of Montenegro towards the EU;



- President of the Parliament of Montenegro, Ranko Krivokapić, gave a keynote speech at the United Nations session on "Enhancing the relationship between national institutions and civil society". The event, organised by the Inter-Parliamentary Union and the UN, and opened by the President of the 66th Session of the UN General Assembly, H.E. Nassir Abdulaziz Al-Nasser, was attended by representatives of UN member countries, senior UN officials and representatives of international organisations and civil society;
- President of the Parliament of Montenegro, Ranko Krivokapić, during his visit to the United States, in December, had a series of high-level meetings in the House of Representatives and the Senate of the U.S. Congress. On this occasion, he met with the President pro tempore of the U.S. Senate, Daniel Inouye, Senator and Republican candidate for the previous presidential elections, John McCain, Defence Subcommittee Chairman Congressman, Bill Young, Chairman of the Subcommittee on Europe and Eurasia, Congressman Dan Burton, Congressmen Elsey Hastings and Michael Michaud and Senator Susan Collins. During the visit to Washington, President Krivokapić had talks at the World Bank (WB), the State Department and Pentagon. Also, President Krivokapić gave a lecture at the Centre for Strategic and International Studies in Washington, on European and Euro-Atlantic integration;
- President of the Parliament of Montenegro, Ranko Krivokapić, in December, paid an official visit to the Kingdom of Sweden at the invitation of the Speaker of Swedish Parliament Per Westerberg and the Government of Sweden. During the visit, the President of the Parliament of Montenegro met with the Minister responsible for European Affairs in the Government of Sweden, the chairmen of the parliamentary committees of Swedish Riksdag, the leaders of parliamentary parties, officials of the Ministry for Foreign Affairs and the authorities of Stockholm. On that occasion, both sides expressed readiness to deepen and intensify the cooperation between Montenegro and the Kingdom of Sweden.



#### **ACTIVITIES OF VICE-PRESIDENTS OF PARLIAMENT**

- ♦ The Vice-President, Rifat Rastoder, participated in the Parliamentary Forum, which took place in Istanbul from 9 to 13 May, organised by the Inter-Parliamentary Union (IPU) and the Grand National Assembly of Turkey, and supported by the United Nations (UN). The theme of the Forum was "The Development Policy of the least developed countries in the UN."
- ♦ The Vice-President, Rifat Rastoder, participated at the conference "Human Rights and MPs", which took place in Belgrade in October, on the occasion of International Day of Democracy, and organised by the National Assembly of Serbia and the OSCE Mission to Serbia.

#### 4.4. PERMANENT DELEGATIONS

Parliamentary Assembly of the Inter-Parliamentary Union (IPU): President of the Parliament of Montenegro, Ranko Krivokapić, gave a keynote speech at the United Nations session on "Enhancing the relationship between national institutions and civil society". The event, organised by the Inter-Parliamentary Union and the UN, and opened by the President of the 66th Session of the UN General Assembly, H.E. Nassir Abdulaziz Al-Nasser, was attended by representatives of UN member countries, senior UN officials and representatives of international organisations and civil society.

President of the Parliament sent a formal request for membership of the Parliament of Montenegro in the 12 + Group of the Inter-Parliamentary Union.

Delegation of the Parliament of Montenegro to the Parliamentary Assembly of NATO: The spring session of the Parliamentary Assembly of NATO took place in Varna, Bulgaria (27 - 30 May). During the session, participants focused their discussion on the draft reports prepared by the rapporteurs whose adoption was followed at the annual autumn session, and the discussion following the presentation of the representatives of Bulgarian Government and scientific institutions. Topics that preoccupied the attention of parliamentarians included: the new strategic concept; the mission of NATO, especially the mission in Afghanistan; new challenges in Afghanistan; information security; China's growing influence; the Situation in Belarus and Ukraine; Afghanistan in a regional context; missile defence; economy in the Western Balkans; energy security; food and water safety; effects of the global recession, with particular focus on security and defence issues in this context, etc.

The 57th Annual Session of NATO Parliamentary Assembly was held in Bucharest (7 – 10 October). This time, participants of the event discussed the draft reports presented during spring session, on the following topics: the mission of NATO, with special reference to the ISAF mission; new challenges in Afghanistan; information security; the new strategic concept; the growing influence of China; economy in the Western Balkans, the situation in Belarus and Ukraine; Afghanistan in a regional context; missile defence; energy security; effects of the global recession in the context of security and defence policy; food and water safety, etc.

Delegation of the Parliament of Montenegro took part in the 76th Rose-Roth seminar in Tbilisi, Georgia (23 - 25 March), as well as in the work of the 78th Rose-Roth seminar on the topic "Transition in Afghanistan 2011-2014", held in London - United Kingdom (21 – 22 November).

Montenegrin delegation to the NATO PA is composed of Chairman, Dragan Đurović, members Borislav Banović and Vasilije Lalošević and alternate members, Raško Konjević and Đorđe Pinjatić.

Parliamentary Assembly of the Organisation for Security and Cooperation in Europe (OSCE PA): Montenegro was admitted to the OSCE after the decision made at the Permanent Council session on 22 June 2006, and it was the first membership of Montenegro in an international organisation after the restoration of statehood. Montenegro signed the Helsinki Final Act (Final Act of the Conference on Security and Cooperation in Europe) on 1 September 2006.



During 2011, Montenegrin parliamentary delegation participated in the 10th Winter Meetings in Vienna, the Republic of Austria (24 – 25 February). The Session was driven by debate on the situation in the Mediterranean and on the topic of "Immigration, integration and multi-ethnic dialogue in the OSCE". The Joint Statement on the occasion of events in North Africa (Mediterranean) was adopted at the Session. The delegation also participated at the 20th Annual Session in Belgrade, Serbia (6 - 10 July) in which MPs re-elected President Petros Efthymiou for the second term, for the period of one year. Belgrade Declaration on "Strengthening the effectiveness and efficiency of the OSCE - A new start after the Summit in Astana", voted by more than 230 parliamentarians from 53 countries, was adopted. The Declaration presents recommendations for national parliaments and OSCE on the economic, security and human rights issues. The Montenegrin delegation participated in the 10th Fall Meetings in Dubrovnik, Republic of Croatia (7 – 10 October). The meetings were held on the topic "Regional Development in South East Europe: challenges, opportunities and prospects" and included discussions on issues of economic cooperation, Euro-Atlantic integration and promotion of long-term stability in South-eastern Europe.



Special Representative of the OSCE Parliamentary Assembly and Head of the Vienna Liaison Office of the OSCE PA, Andreas Nothelle, and OSCE PA Special Representative on South East Europe, Roberto Batelli (Slovenia), visited Montenegro on 6 October and had meetings with Deputy Prime Minister Duško Marković and Vice-President of the Parliament Željko Šturanović. The meeting with the Vice-President of the Parliament was also attended by Head of the OSCE Mission to Montenegro H. E. Sarunas Adomavicius.

Montenegrin parliamentary delegation is composed of the President of the Parliament, Ranko Krivokapić, Head of the delegation, Goran Danilović, member, the Vice President of the Parliament Rifat Rastoder, Deputy Head of delegation, and Aleksandar Bogdanović and Slaven Radunović, alternate members.

Parliamentary Assembly of the Council of Europe (PACE): Montenegrin parliamentary delegation in the Parliamentary Assembly of the Council of Europe participated in all four regular PACE sessions held in Strasbourg in 2011. At the first regular session of PACE, it was discussed, i.a., on the inhuman treatment of people and illicit trafficking in human organs in Kosovo, the protection of journalists' sources, as well as a series of reports concerning the countries of former Yugoslavia. On the first day of the session, under the procedural issues, mandates of the Montenegrin delegation were confirmed. Central topics of the second regular PACE session were related to the violation of human rights and a threat to democracy in terms of the indebtedness of countries and abolishing the death penalty. At the third regular session, MPs discussed the following topics: Living together in Europe in the 21st century; Budgets and priorities for the financial year 2012-2013, and a



Reform of the Parliamentary Assembly; while at the Fourth regular session, it was discussed on the topics in the field of human rights and freedoms with special emphasis on children's rights.

As part of the regular PACE sessions, Montenegrin Parliamentary delegation actively participated in the work of the Assembly, committees, the Socialist Group, and in the meetings of the Committee for Monitoring. The members of Montenegrin delegation had discussions in the plenary. In the period between PACE regular sessions, the members of Montenegrin Parliamentary delegation took part in many committee meetings held in Paris and Florence (Committee on Economic Affairs and Development and the Committee on Social Affairs, Health and Family Affairs) and at the fifth meeting of the PACE parliamentarians network in the fight against child sexual abuse - campaign "One in five." Also, Montenegrin Parliamentary delegation was very active in terms of bilateral cooperation during PACE sessions and when not in session, such as in meetings with the Venice Commission, with the Co-Repporteurs of the Committee on Monitoring PACE, in Strasbourg and during a visit to Montenegro, as well as meetings with the Ambassador of Ukraine to Montenegro.



Montenegrin Parliamentary delegation has three permanent and three alternate members. The Head of Delegation is MP Valentina Radulović-Šćepanović, and members are MPs Džavid Šabović and Obrad Gojković. Alternate members are MPs: Zoran Vukčević, Ervin Spahić and Snežana Jonica.

The MP Valentina Radulović-Šćepanović has been continuously in the delegation of the Parliament of Montenegro since 2004, first as an alternate member, and as of 11 April 2011 as a member and the Head of delegation. After taking office as the Head of delegation, the Socialist Group of PACE has nominated her for one of its Vice-presidents and a member of the Secretariat (by rotation), while the Collegium of the Parliament of Montenegro appointed her, in November 2011, as the representative of Montenegrin Parliament in a campaign of the network of parliamentarians in the fight against sexual violence against children, known as Campaign "One in Five".

#### 4.5. REGIONAL INITIATIVES

A significant contribution to parliamentary cooperation in the region during 2011 had the **Cetinje Parliamentary Forum**, as an indigenous regional initiative of the parliamentary cooperation between the countries of South East Europe on the path of European integration, initiated by the Parliament of Montenegro, in cooperation with the Parliament of the former State Union of Serbia and Montenegro in February 2004. The XII Cetinje



Parliamentary Forum on "Parliamentary Oversight of Defence and Security", organised by the Parliament of Montenegro in cooperation with the United Nations Development Programme (UNDP) and the Centre for the Control of Small Arms and Light Weapons in South East Europe (SEESAC) was held in Cetinje (6 May). This forum brought together representatives of parliaments of the region - Bosnia and Herzegovina, Montenegro, Croatia, Macedonia, Serbia and Slovenia.



**Central European Initiative (CEI):** From its start, the CEI's goal has been to foster political and socio-economic development in the region aimed at avoiding new division lines in Europe. To this end, the CEI is oriented to assist in strengthening the capacities of countries remaining outside of the EU to consolidate their institutional and economic background and bring them closer to the EU.

The Parliament of Montenegro participates in the work of the Parliamentary Dimension of the CEI through a permanent three-member delegation composing of Miodrag Vuković (Head of Delegation), Vasilije Lalošević and Damir Šehović.

During the presidency of the Republic of Serbia in 2011, the delegation of the Parliament of Montenegro participated in two parliamentary meetings of the Initiative - Parliamentary Committe CEI - PD (20 - 21 May) and Parliamentary Assembly (10 - 11 November). The meetings led discussions on the role of parliament in the area of sustainable development and environmental protection, as well as on prospects for the Initiative. In light of the prominent need for intensive communication of Parliamentary and Government dimension of CEI, the delegation of enlarged Parliamentary Troika, composed also of the Head of Montenegrin delegation, met with foreign ministers of the enlarged Government Troika and, on that occasions, repeated the need for more regular inter-communication on activities of two dimensions, strengthening cooperation in areas of common interest and cooperation with European Union institutions.

**The South East European Cooperation Process (SEECP):** The Parliament of Montenegro took over the Chairmanship-in-Office of the SEECP Parliamentary dimension from the Turkish Grand National Assembly at the Eighth Conference of Speakers of Parliament which took place in Antalya on 7 June 2010. The Parliament chaired it until the Ninth Conference of the SEECP Speakers of Parliament which took place in Bečići on 14-15 June 2011, when the presidency was formally handed over to the National Assembly of the Republic of Serbia.

During Montenegrin Chairmanship-in-Office, the scope of parliamentary activities of the Initiative has significantly increased, through the organisation of meetings in Montenegro and strengthening communication with other regional organisations and initiatives. A Working Group comprising of MPs and National Coordinators of member states was formed, with the aim of finding the best modalities for the institutional restructuring of the Initiative and the creation





of the SEECP Parliamentary Assembly. The members of the Working Group of the Parliament of Montenegro are Aleksandar Bogdanović and the SEECP National Coordinator Andrej Orlandić.

During the Chairmanship-in-Office, Parliament of Montenegro has independently organised two meetings of the Working Group, Conference of the Presidents of SEECP Parliaments and, in cooperation with the Regional Secretariat for Parliamentary Cooperation in South Eastern Europe, a meeting of national coordinators and the visit of the Working Group to the annual session of the Baltic Assembly.

Programme of the Conference, as the last parliamentary meeting during the Chairmanship-in-Office, included the topic "The relations between Parliaments and Governments in the process of EU integration - Strengthening the role and the capacities of the Parliament as a response to the framework set by the Lisbon Treaty", and the presentation of the conclusions of the Working Group.

Representatives of the Parliament continued to participate actively in the activities of the Working Group, despite the fact that the Montenegrin presidency of the SEECP finished in June 2011.

Adriatic-Ionian Initiative (AII): The objective of starting the Initiative in 2000 was to improve development and strengthen security in the Adriatic-Ionian area, intensify cooperation among the countries in the region and provide incentives for countries in transition towards the integration process and the European Union. The Adriatic-Ionian Initiative is realised hrough two forums: a forum for the exchange of political opinions, and a forum for multilateral cooperation in several areas (traffic, marine, tourism, education, environmental protection and cultural heritage, development of small and medium enterprises, the fight against all forms of organized crime, rural development).

During the Montenegrin Chairmanship-in-Office of the Initiative, which lasted from May 2010 until May 2011, the Parliament of Montenegro organised the Conference of the Speakers of Parliaments of the Initiative Member States, which took place in Budva on 12 April 2011. Two topics:"The Mediterranean region - Cradle of Multiculturalism" and "Sustainable Development of Energy Sector in the Adriatic-Ionian Region" were discussed at the Conference. The conference participants emphasised that the role of legislative bodies in their countries is very important for the area of European integration and European affairs. With the renewal of ties between the countries of the region and the restoration of mutual confidence, the region moves to meet the basic requirements for European integration, as it was announced at the Conference.



#### 4.6. COOPERATION WITH FOREIGN AND INTERNATIONAL ORGANISATIONS

In 2011, the implementation of the Programme of Cooperation between the Parliament of Montenegro and Westminster Foundation for Democracy continued, and the cooperation was renewed by signing the new Memorandum of Understanding in November 2011. A new quality to the cooperation will certainly bring support of the British Council, which is the third signing party of the Memorandum. In this project, during 2011, a number of activities were conducted including the seminar, the first of which was dedicated to strengthening technical support to the work of parliamentary committees and was held in February, while the other one was held in December on the topic: "Strengthening the role of parliament in monitoring the budget". In July, in partnership with Thomson Reuters Foundation, a roundtable was organised on the topic: "Parliament, media and citizens", while the regional workshop on the effective, oversight and legislative function of parliamentary committees in the Western Balkans was held in November as a part of the same programme. The cooperation programme included study visits to the Parliament of Northern Ireland and the House of Commons of the United Kingdom, with the support of NiCO.

**Friedrich Ebert Foundation**, in cooperation with the European Movement in Montenegro, organised three seminars on the topic: "The process of negotiation with the European Union - experiences of the Republic of Croatia", held in Bečići and Miločer, in October and November. With support of the Foundation, and in cooperation with the Institute "Alternativa", a roundtable on the topic: "The first year of implementation of the Law on Parliamentary Oversight of the Security and Defence Sector" was held in December.

With the support of the Centre for Democratic Control of Armed Forces (DCAF) and the OSCE, the Third Regional Conference on "Parliamentary Control of Intelligence and Security Services within the System of Confidential Data" held in September. DCAF organised a study visit for the Security and Defence Committee in Geneva in September, and the International Conference "Strengthening the Oversight of Intelligence and Security Services in the Western Balkans" in December. Also, DCAF organised the seminar on the topic: "Democratic Control of Armed Forces and Application of the OSCE Code of Conduct on Politico-Military Aspects of Security", which was held in December.

In the second half of 2011, the Parliament of Montenegro performed series of activities pertaining to the preparation of the "Democratic Workshops" project for primary school children, which will be funded by the **ERSTE Foundation**, and in cooperation with the Parliament of Montenegro. The project objective is to stimulate interest among young people in politics and democratic processes, which will enable them, through interactive features, to get familiar with the work of MPs and Parliament as an institution. A public invitation for the expression of interest of non-governmental organisations to participate in the project was published in July 2011. In November, the representatives of Montenegrin Parliament, ERSTE Foundation and the Agency "Müllers Freunde" from Austria, after the interviews held with representatives of organisations that have submitted a project proposal, the NGO Forum MNE was chosen to participate in the final stage of the application process. Further activities for the project realisation will continue in the year 2012.

The **OSCE mission to Montenegro** ended the four-year long project "Capacity Building of the Parliament of Montenegro" in 2011, funded by the Austrian Development Agency. Before completion of the project, the Mission has continued to organise town hall meetings of committee members with citizens, and created guidelines for self-organising discussions. The Parliament was provided support in analysing the implementation of the Law on Gender Equality, and training for the staff of the Section for Research, Analysis, Library and Documentation was also organised. Besides this project, the Mission supported a translation of relevant documents for the needs of the Section for Research, Analysis, Library and Documentation.

Long-term cooperation with the National Democratic Institute (NDI) has ended in early 2011, after the completion of the programme in Montenegro and closing of the NDI Office in Montenegro. Within the parliamentary programme, this organisation has carried out numerous activities over ten years, aimed at



strengthening the legislative and oversight functions of the Parliament, as well as strengthening of administrative capacities, which contributed to the introduction of significant innovations in the work of the Parliament. However, cooperation with NDI continues through projects of a regional programme for Central and Eastern Europe, such that under the NDI Initiative to strengthen legislative institutions in the Western Balkans and the WFD Programme for strengthening parliaments in the Western Balkans, a Regional Workshop on effective, oversight and legislative function of parliamentary committees in the Western Balkans was organized in November.

**UNDP Office**, together with the Gender Equality Committee of the Parliament of Montenegro and the OSCE Mission to Montenegro, organized a presentation of the results in May, "Survey on knowledge and application of the Law on Gender Equality".

Within the project "National Convention on European Integration of Montenegro", which was organised with the support of **SLOVAKAID**, the Second Conference of National Convention on European Integration of Montenegro was held in July.

Long-term cooperation of the Parliament of Montenegro with the **German Organisation for International Cooperation (GTZ)** has continued throughout June, by organising the two-day seminar within the project "Public Dialogue on Improving Energy Efficiency."



## V PUBLICITY OF THE PARLIAMENT'S WORK

In order to achieve a higher degree of transparency and publicity of the work of the Parliament of Montenegro, a significant progress has been made during 2011.

The content of the Parliament Website has gotten more complete, with regular updates and live broadcasts of the parliamentary sittings and, partly, meetings of the working bodies. Apart from the regular presentation of performance and financial reports, one of the novelties also includes publishing of data on individual MPs voting results on laws adopted during the 24th Convocation, as well as publishing of the monthly bulletin "Open Parliament".

The following text presents other detailed information about the cooperation of the Parliament with media and the civil sector organisations, data regarding requests submitted to the Parliament in accordance with the Law on Free Access to Information, and data on visits, exhibitions and other events related to the programme "Open Parliament."

#### 5.1. PARLIAMENT AND MEDIA

The Department for Public Relations, International Affairs and Protocol of the Parliament of Montenegro issued, in 2011, 390 annual accreditations for journalists and cameramen/photographers from 26 electronic and print media, of which eight editorial boards have been outside Montenegro. There were 95 daily accreditations issued. In the same period, the Service of the Parliament processed and responded to more than 150 individual questions asked by journalists.

There were 1,260 pieces of information and 2,155 photos published on the News page of the Parliament of Montenegro Website, www.skupstina.me. The Website has been updated with information about individual MPs voting results in the last three years. Parliamentary questions and answers tabled and answered during the Prime Minister's Hour and Parliamentary Questions have been made available. The Children's Parliament was given a special space on the Website, where information from all three sittings was published. The public can become familiar with data related to the public procurement. In a series of novelties that have been introduced, an electronic bulletin "Open Parliament" occupies as part of the project Open Institutions, which the Service of the Parliament has been realising with the CDT, and is financially supported by the EU Delegation to Montenegro.

One of the most important forms of the publicity of work is the TV broadcast of the plenary sittings. The TV broadcasting began in 2010, with Parliament's own technical and administrative capacities. The TV signal was made available to interested broadcasters and cable operators for further distribution. In 2011, 340 hours and 15 minutes of the programme were realised.

As of 17 June 2010, sittings of the Parliament of Montenegro can also be broadcasted live over the Website. Since the introduction of the service, there were 49,732 live streaming site visits from 35 countries.



### 5.2. FREE ACCESS TO INFORMATION

In 2011, the Parliament of Montenegro received 162 requests for free access to information, which contained 529 items, i.e. sub-requests. The Parliament of Montenegro responded to all submitted requests, either with a decision (114), notification (46) or conclusion (2).

For 75 submitted requests for free access to information, the access was granted either by direct insight, the information transcription or by providing a copy. In 2011, the Parliament of Montenegro denied 39 requests for free access to information, because it did not possess the required information.


Notifications are sent to the requestors in cases when the required information has already been published and available to the public. Such requests were a total of 46 in 2011.

Montenegrin Parliament responded to two requests for free access to information by Conclusion, because it had previously decided on the same request.

Most requests for access to information were submitted by NGOs. Requests are mostly related to financial transactions, i.e. copies of MPs payroll statements, copies of documents containing information on the amount that was spent from the budget of the Parliament of Montenegro to pay for travel costs, accommodation, then the data on per diem for MPs travelling abroad and around Montenegro, public procurement, realisation status of the Action plan activities, etc.

A detailed table of data on requestor for free access to information, date of the request submitted and date of the response, with data from the previous year, is given in Annex II.

#### 5.3 OPEN PARLIAMENT

#### **COOPERATION WITH CIVIL SECTOR**

Cooperation between the Parliament of Montenegro and civil sector has been constantly improving and enhancing, which can be seen through the increased participation of representatives of civil sector in meetings of working bodies, especially when it comes to consultative hearings. The realised cooperation with civil sector is of great importance, and emphasis has been put on the important role of the civil society in contributing to and strengthening of regional cooperation on social and political issues.

It is important to highlight that the Memorandum of Cooperation between the Parliament of Montenegro and the Network of Civil Society Organisations for Democracy and Human Rights was signed on 30 March 2011. At the same time, with the signing of the Memorandum, the form has been posted on the Parliament Website that can be filled in by representatives of civil sector, including individuals, who can thus give their opinion and suggestions, that are then forwarded to the authority or organisational unit referred to in the completed form. It is also important that the principles of cooperation of the Parliament with other interested NGOs are also defined by Memorandum. Civil society organisations can also address the working bodies directly. In the last year, there were about 100 addressings to the working bodies by representatives of civil sector (suggestions, requests, amendment proposals, requests for free access to information, comments on draft acts, appeals, petitions, etc.), and more then 100 participation of the approximately 60 organisations in meetings of working bodies, including participation in consultative hearings (Appendix III). The practice of committees organizing town hall meetings and roundtables outside the parliament building has been continued in 2011. These meetings allow the general public to become familiar with new laws and get direct answers to questions that interest them.

During the first half of 2011, the Parliament has continued to cooperate with civil sector organisations on various projects.

Publishing of monthly bulletin "Open Parliament", in cooperation with the Centre for Democratic Transition (CDT), supported by the European Commission through the EU Delegation in Podgorica, began in 2011. It is an electronic newsletter published on the Parliament and CDT Website, in Montenegrin and English, and delivered to nearly 900 addresses, including European Parliament, international community, academia, government institutions, foreign media representatives, MPs, diplomatic missions, political parties, businesses, local government, and local media.

Implementation of the Internship project for final year students of faculties, which began in September 2003, continued throughout 2011, also in collaboration with the Centre for Democratic Transition. Five students of the 9th generation had a chance to get familiar on the spot with the work of parliamentary services, and directly participate in the work of the Section for Research, Analysis, Documentation and Library by performing research.

Five visits of the members of Montenegrin Association of Political Science Students (MAPSS) were organised last year, and will be continued in the future. They got familiar with the organisation and structure of the Parliament, its powers and functions, and activities of the working bodies and MP Groups.

Preparations for the "Democratic Workshops" project began in 2011. The project is for primary school children, and it will be carried out in cooperation with ERSTE Foundation and the Austrian Parliament, and a local NGO. Open invitation to NGOs to express interest in participating in the project was published on 6 July. In December, the delegation of the Parliament paid a visit to the Austrian Parliament, where they were introduced to the manner of functioning of the workshops, the aim and significance of this project.



On 5 April, the Parliament of Montenegro held the First Conference of the National Convention of the European Integration of Montenegro. The project "National Convention of the European Integration of Montenegro" is organised in cooperation with the NGO European Movement in Montenegro, Slovak Foreign Policy Association, and Government of Montenegro, with the support of the Ministry of Foreign Affairs of the Republic of Slovakia and SLOVAKAID. With this project, as was then said by the NGO representatives, organisations and individuals from civil sector "will have the possibility to make an effect on a large number of decisions, guidelines and documents with the aim of the process reform, transition and European future of Montenegro, in a fair and transparent manner".

On the occasion of 20 November, Date of Adoption of the Convention on the Rights of the Child, the Parliament of Montenegro held the Session of the Children's Parliament, which was organised in cooperation with the NGO Centre for Children's Rights. During the third session, children from 40 Montenegrin schools asked MPs and the ministers a total of 59 questions. The project objective is to make it easier for younger population to understand democratic values of society.

### VISITS, EXHIBITIONS AND OTHER EVENTS

During 2011, numerous individual and group visits of citizens to the Parliament of Montenegro, as well as exhibitions and other events, were organized on various occasions:

- ♦ 11 February As part of the programme "Open Parliament", the Deputy Secretary General Slobodan Dragović received representatives of MAPSS. He introduced students to the organisation and structure of the Parliament, its powers and functions, and activities of the working bodies and MP Groups;
- **18 February** The second group of students of MAPSS visited the Parliament;



♦ 3 March - The participants of the seminar for journalists, parliamentary reporters, which was organized as part of the programme of cooperation with the Westminster Foundation for Democracy (WFD) and in cooperation with trainers from Thomson Reuters Foundation and the Media Institute of Montenegro, visited the Parliament;



- ♦ **9 March** The President of the Parliament, Ranko Krivokapić, received the best students of the Faculty of Political Science, majoring in politicology;
- ♦ 11 March The third group of students of MAPSS visited the Parliament;
- ♦ 1 April Education Centre students from Plužine visited the Parliament. The visit was organised within the project "Open Parliament";
- ♦ 1 April The President of the Parliament, Ranko Krivokapić, received the President of the Student Parliament of the University of Montenegro (UCG), Petar Golubović, and members of the student organisation, and signed the letter of support for their project Coca-Cola Summer Job 2011. President of the Parliament supported the UCG project "Seasonal Jobs in Tourism Fair, saying that students" mission is very important;
- ♦ 13 May The President of the Committee on International Relations and European Integration of the Parliament, Miodrag Vuković, received students of the Faculty for State and European Studies and Dean Đorđije Blažić. The students visited the parliamentary building, and at the same time the Deputy Secretary General Slobodan Dragović informed them about the work of the Parliament, its powers and functions, history and activities of the working bodies and MP Groups;
- ♦ 6 June The Vice President of the Parliament, Rifat Rastoder, received a group of European students of law and political science, and members of the international organisation European Public Law Organisation – EPLO;



- ♦ **21 June** –A group of 15 American Marshall Memorial Programme participants visited the Parliament, and were introduced to it's organisation and responsibilities;
- ◊ 7 November The President of the Parliament Ranko Krivokapić, the UK Ambassador to Montenegro H.E. Catherine Knight Sands, Executive Director of Westminster Foundation for Democracy (WFD) Linda Dafild, and Regional Director of the British Council, Tony O'Brien, signed the Memorandum of Understanding between the Parliament of Montenegro, Westminster Foundation for Democracy and the British Council. The signees expressed desire for continued cooperation and readiness to support the process of strengthening the Parliament, through the support to MPs and its Service in regards to the legislative and oversight role of the Parliament and human resources development in the parliamentary service, during the process of accession to the EU;



- ♦ 21 November On 20 November, the Day of Adoption of the Convention on the Rights of the Child, the 3rd Session of the Children's Parliament was held. Montenegrin students from 40 schools asked MPs and ministers a total of 59 questions;
- ♦ 25 November JU-Secondary Catering Service School students from Bar visited the Parliament of Montenegro. They got familiar with the work of Montenegrin Parliament, its powers and functions, as well as its history and activities of the working bodies and MP Groups. The high school students from Bar visited the plenary room and other rooms where the sessions are held and meetings organized. They also visited the offices of MP Groups. The visit was organized as part of the Programme "Open Parliament";
- ♦ 1 **December** The fourth group of students of MAPSS visited the Parliament;
- ♦ **9 December** On the occasion of 10 December International Day of Human Rights, the Committee for Human Rights and Freedoms and the Service of the Parliament of Montenegro, as part of the Programme "Open Parliament", organised the visit of children from Public institution Children's home "Mladost" Bijela and the Public institution Centre for Education and Training "1. Jun" Podgorica, to the Parliament. The Committee for Human Rights and Freedoms recognised the need for children's participation and gave them a chance to voice their opinions and views on matters that concern them directly, which is guaranteed to them by the UN Convention on the Rights of the Child;



- ♦ 13 December President of the Parliament, Ranko Krivokapić, opened an exhibition of political cartoons by Darko Drljević, the winner of prestigious international awards for cartoon and comics. The exhibition consisted of 25 portraits of Montenegrin politicians and 50 daily political cartoons;
- ♦ 21 December At the last meeting of the Committee for Human Rights and Freedoms in 2011, the Committee and Service of the Parliament organised an art exhibition of works by students of the Public institution Centre for Education and Training "1. Jun", the institution for education of children and youth with disabilities, under the slogan "I Exist Too". The motive for the exhibition was a successful implementation of activities defined in the Plan of the Committee for Human Rights and Freedoms, prepared on the basis of the Analytical Report and Opinion of the European Commission and the Action plans of the Parliament and the Government of Montenegro, and based on the adoption of the Performance Report of the Committee for 2011. Students of the Institution Centre "1 June", together with their teachers, made 50 art works. The Embassy of the United Arab Emirates helped with the works, and the setting was presented in several Montenegrin cities.



## VI EXPERT, ADMINISTRATIVE AND TECHNICAL SUPPORT

In 2011, the Parliament of Montenegro has taken important steps to improve administrative capacities and efficiency in its work, in order to strengthen the legislative and oversight role. During this period, some specific steps have been taken in strengthening the staff levels; a high level of commitment to the human resources development, training of the staff and other activities that contribute to greater efficiency in the work of the Service continued throughout the year 2011.

In order to provide better support to MPs in performing their legislative and oversight function, the practice of secretaries of committees preparing an expert opinion in the form of informative review-briefing for each proposal for a law was introduced. This informative review contains: introductory information on the proposed act; a brief comparative review of the experiences of other countries, if possible; findings on the review of compliance with relevant regulations of the European Union submitted by the Government; findings on the review of the Fiscal Impact Form submitted by the Government, and a list of all representatives of civil sector which contacted committees. In this regard, the guidelines for preparation and content of the informative review were introduced. The guidelines define the procedure for preparation and submission of informative reviews. In February, training for secretaries on preparation of informative reviews (in cooperation with Westminster Foundation for Democracy -WFD and the UK House of Commons) was organised. Since the introduction of this practice until the end of the year, committee secretaries prepared a total of 231 informative reviews. Expert analyses of proposed acts should be added to this number, made by the service of the Cinstitutional Issues and Legislative Committee. Due to their specific responsibilities and commitment, the service of the Committee does not prepare informative reviews, but it makes expert analyses to every proposed act placed on the Committee's agenda for consideration.

Special attention was paid to the harmonisation of legislation with the EU acquis, through consideration of all proposals for laws that are harmonised with the EU acquis in the Committee on International Relations and European Integration, and through Committee staff performing more detailed control of compliance tables that the Government provides. After examining the submitted documents that accompanied the proposals for laws, numerous substantive and technical changes have been made in relation to the documentation that confirms compliance with European legislation and other international agreements.

The Parliament of Montenegro, in cooperation with the EU Delegation in Podgorica, applied for a 10-month expert assistance, divided into several missions in the area of harmonising legislation and its impact assessment. The goal is to strengthen the capabilities of the Parliament to oversee the proposed laws and their compliance with the EU acquis. A team of experts was selected in August and the implementation of the project commenced in September. Three experts, in the area of legal harmonisation, oversight over application of laws and analysis of the impact of laws, stayed in the Parliament of Montenegro during September during their first visit, which was aimed at achieving an agreement with regard to specific activities and the schedule of work under this project. After finalising the inception report, the EU Delegation experts stayed in Montenegro on two occasions, when introductory activities under all three programme components were carried out. The visits of the experts will continue in the future, and the focus will be on practical work with staff in the areas defined by the project.

#### 6.1. HUMAN RESOURCES

Much attention, in 2011, was devoted to the human resources development, professional trainings of staff in the Service of the Parliament and MP Groups, through various forms of trainings and activities that aim to contribute to the efficiency in the work of the Parliament of Montenegro.



Adoption of the Three-year Human Resources Development Strategy with the Strategic Plan for the period from January 2011 until January 2014 and the Training Plan, and preparation of Human Resources Guidelines and Management Development Programme in the Service of the Parliament, presents the continuation of intensive activities aimed at strengthening the administrative capacities. The Strategy defines the vision and mission, principles and values, and strategic objectives of the human resources development, with indicators and activities. The Training Plan identifies the need for trainings, including the preparation of monthly training plans that enable the strategic planning of human resources development in the Parliament of Montenegro. In addition, the final version of the New Employee Handbook was prepared.

The Human Resources Management Bureau at the same time continuously keeps records of all trainings and evaluates conducted trainings, 12 of which from the 2011 Training Plan, 41 trainings organised by the Human Resources Management Authority of Montenegro (UZK) and their 2011 Training Plan and Programme, and two trainings organised and conducted by Human Resources Management Authority, but that were not part of the 2011 Plan and Programme curriculum. In addition, employees in the Service of the Parliament participated in 36 trainings that were provided through cooperation with other national, foreign and international organisations. A detailed chronological review of trainings carried out is provided in the Appendix IV. Filling vacancies inside the Service of the Parliament, in accordance with the Rulebook on Organisation and Systematisation of the Parliamentary Service, has continued in 2011.

There were 125 employees in the parliamentary service on 31 December 2011, compared to 154 employees, as prescribed by the Rulebook and in comparison to 92 employees on 31 December 2010.

#### 6.2 LIBRARY AND RESEARCH

Another form of significant contribution to the quality of professional support to MPs by parliamentary service are research papers prepared and produced in 2011, by the newly created Section for Research, Analysis, Documentation and Library. In 2011, eight research papers were produced and made available on the Parliamentary Website. Also, the Section prepares weekly newsletter from the EU institutions that is electronically distributed to all MPs, MP Groups and employees in the parliamentary service every Friday. The Rules of Procedure of the Section for Research, Analysis, Library and Documentation were adopted in early 2011, when its application started. At the same time, the Rules on producing research papers, together with the Request Form, were also adopted.

The Service of the Parliament regularly responds to all requests received from other members of the European Centre for Parliamentary Research and Documentation (ECPRD) network. During 2011, the staff prepared and provided 39 responses to ECPRD questionnaires in the form of brief information.

In 2011, MPs and parliamentary staff were able to use EBSCO online database, which contains over 22,000 journals in law, politics, economics, technology, medicine, sports, etc. Over 10,000 journals are available in full text and, in addition, it is possible to browse a large variety of publications that offer summaries, news reviews and encyclopaedic information.



#### **6.3 DOCUMENT MANAGEMENT**

From the beginning of 2011, the Parliament of Montenegro has begun applying the internal Rules on Office Operations, which set a solid base for future introduction of IT system for monitoring of legislation. The new Rules provide for more efficient document management and reduction in number of registry books; also, they precisely define the e-mail recording procedure, enable recording and archiving of documents according to their content, instead by the session during which they were in the procedure, as it was previously done.

In addition, the application of the Classification Plan has commenced at the beginning of 2011. The Plan provides classification of legislation according to negotiating chapters and better tracking of amendments to laws and their compatibility with the EU acquis. In accordance with the Plan, the classification codes are assigned to all documents that are received at the Registry Office. All proposals for laws submitted by the Government (a total of 163 in 2011<sup>18</sup>) were classified according to their content by negotiating chapters to which they belong, which would enable more efficient preparation of MPs during the negotiation process with the EU.

A Draft Decision on Abbreviations for Parliamentary Documents was prepared, and in this respect the Working Group was formed to determine the abbreviations for laws published in the Official Gazette of Montenegro, since its first edition after the adoption of the new Constitution in October 2007. The Working Group completed the task and produced the abbreviations within the envisaged timeframe. In this regard, regular determination of abbreviations has been continued with, and the final defining of this issue within the consideration of amendments to the Rules of Procedure of the Parliament of Montenegro is in progress.

The Service of the Parliament began with the application of registers of the Records of Parliamentary Acts (EPA). Accordingly, any act that is received at the Registry Office of the Parliament is assigned the EPA reference code that consists of a combination of Arabic and Roman numerals. The Arabic numeral represents the ordinal number of the parliamentary act that is received at the Registry Office in the course of one Parliamentary Convocation, while the Roman numeral represents the number of Convocation.

Under the license received from the relevant Publications Office of the European Union for translation and use of Eurovoc Thesaurus, the Parliament translated descriptors into Montenegrin. Eurovoc is a multidisciplinary, multi-language glossary covering all EU activities, notably the European Parliament, and contains terms in 22 languages of EU Member States, as well as Croatian and Serbian. Using the same descriptors for the laws and acts adopted by the Parliament of Montenegro will offer the possibility of easier comparison with the relevant EU and other countries' regulations, which can be especially important in the process of harmonisation with the EU legislation and in the accession negotiations. During the reporting period, a set of internal documents that enabled effective monitoring of the legislative procedure and document archiving was adopted. A preparation for the use of translated Eurovoc descriptors for indexing, not only acts of the Parliament, but also those of the Government, which will be included in the information and legal system of the Official Gazette of Montenegro, is in progress.

#### **6.4. INFORMATION TECHNOLOGY**

The Parliament's IT Sector, in addition to its regular activities on maintaining current information - communication system of the Parliament, continued with its development and improvement during 2011.

Scanning of all documentation related to the legislative process and its publication on the Parliament Website began in 2011; the preparation of all electronic voting listings of the 24th Convocation of the Parliament and their publication started at the same time. All electronic voting listings from 2009 and 2010 were published in 2011. Publishing of listings from 2011 on the Parliamentary Website is planned to be published until the start of the 2012 Spring Session. These activities have significantly enhanced the transparency of the Parliament's work.



SMS Broadcast service - service of notification via SMS, which completely replaced the system of notification by telegram, was introduced on 1 December 2011. With this system, apart from faster informing of MPs and staff, some significant financial savings were also achieved. In order to improve internal communications, the Sector built Intranet portal currently in test phase, with its own capacities.

The Sector coordinated the activities of the Working Group composed of staff of the Parliament, on drafting of the initial project task for the development of information system to support the legislative process. Drafting the project task, the existing information system and the legislative process have been described in detail, so the conditions for the more quality design of tender-project documentation and tender announcement have been created.

The set of internal rules has been prepared - policies related to information system of the Parliament (Information System Security Policy, Use of Internet Policy, Mail server Use Policy, Antivirus Policy for Computers). These rules have the status of the draft.

In order to provide better working conditions, according to the decision of the Administrative Committee of the Parliament on "the acquisition of MPs' rights to use and dispose of official notebooks", 40 notebook computes were therefore purchased and distributed in 2011, so that all MPs of the 24th Convocation use an official notebook.



## VII FINANCE

The Budget Law of Montenegro for 2011 envisaged the funds for the Parliament of Montenegro in the amount of 5,519,530.08 €, as follows:



2011 Budget structure according to programmes





Structure of the execution of the budget of the Parliament of Montenegro for 2011 for the Programme: Improvement of the Legislative Infrastructure











