# FOREWORD BY THE PRESIDENT OF THE PARLIAMENT OF MONTENEGRO

Dear citizens,

The Parliament of Montenegro presents its Performance Report from January to December 2016. In this Report, the parliamentary staff prepared a detailed overview of activities from the previous calendar year. Numbers, tables, graphs, acts and everything else that this Report contains represent a sort of an annual ID of the Parliament of Montenegro.

The year behind us represented a special challenge in the work of the Parliament. The 2016 was an election year, with two parliamentary convocations, three presidents and a mandatory pre-election vacuum.

The new 26th Parliament was formed in November 2016, when the leadership of the Parliament was elected and the forming of working and other bodies began. Regular activities continued both domestically and internationally. The Parliament has begun to implement the plan which will continue in 2017: even more efficient work in part regarding the adoption of legal acts and oversight activities, greater focus on the public, more systematic approach to organisation of work, timelier implementation of internal control mechanisms, and improvement of the work environment. A good practice of international parliamentary diplomacy continues, aimed at strengthening the reputation of its institutions and the country of Montenegro as a whole, as a vanguard for implementation of projects from the field of economy, culture, science and all other aspects of interest to our citizens.

A systematised overview of activities, shown in the Performance Report, may be a good indicator of weaknesses which need to be worked on, as well as an indicator of good practice which should be continued.

In the coming period, there will be demanding, intensive and hard work before the Parliament of Montenegro, but a basis for all further steps of the administration will be high quality, precision, and comprehensiveness of response to the tasks.

I am convinced that we have a clear vision of how to move forward, because we work with dedication on concrete solutions and new models which will ensure management of the most complex tasks, improve and increase the overall efficiency of our work. At this stage of the European integration we need high quality, modern, educationally strong administration which would respond in the best possible manner to the challenges before us. We continue with enhancing the transparency of work, cooperating with the media, opening doors and encouraging participation of civil society in decision-making. The Parliament of Montenegro must be a central place for a dialogue, the citizens' trust and the strengthening of democracy.

I also believe that this year's report will contribute to an even greater openness of work of the Parliament and understanding of the role of the highest legislative body of the state of Montenegro.

### I INTRODUCTION

In 2016, the Parliament of Montenegro held 16 sittings of the ordinary session and five sittings of the extraordinary session, where a total of 209 acts were adopted, of which: 121 laws, 15 decisions, 38 decisions on elections and appointments, 33 conclusions, and two resolutions;

In 2016, a total of six of special sittings of the Parliament of Montenegro were held. Four special sittings of the Parliament were dedicated to the Prime Minister's hour (two sittings) and to the Prime Minister's hour and parliamentary questions (two sittings).

The Seventh - Special Sitting of the First Ordinary (Spring) Session in 2016 was dedicated to the tenth anniversary of Montenegro's declaration of independence, while at the Eleventh - Special Sitting of the First Ordinary (Spring) Session in 2016, in accordance with Article 89 of the Rules of Procedure of the Parliament, the MPs were addressed by Mr Ilir Meta, Speaker of the Parliament of the Republic of Albania, as a guest.

On 7 November 2016, the First - Constitutive Sitting of the Second Ordinary (Autumn) Session of the 26th Parliament of Montenegro in 2016 was held, where the President and vice presidents of the 26th Parliament of Montenegro were elected, as well as the Chairperson and members of the Administrative Committee.

The Prime Minister of Montenegro was asked 21 questions, while the members of the Government were asked 70, with 5 supplementary questions;

In the same period, working bodies held a total of

214 meetings, in 215 days, for a total of 272 hours and 48 minutes; wherein 745 items of agenda were considered, including 267 proposals for laws as well as 975 amendments.

In addition, working bodies held 10 control and 32 consultative hearings.

#### The Parliament in 2016 in figures

- A total of 209 acts were adopted, of which: 121 laws, two resolutions, 15 decisions, 33 conclusions and 38 decisions on elections and appointments;
- 16 sittings of ordinary session and 12 sittings of extraordinary session of the Parliament were held, in duration of 336 hours and 40 minutes;
- The Prime Minister was asked 21 questions and the members of the Government were asked 70, with 5 supplementary questions;
- 214 meetings of working bodies of the Parliament were held, in 215 days, for a total of 272 hours and 10 minutes; wherein 745 items of the agenda were considered, including 267 proposals for laws and 975 amendments.
- 10 control and 32 consultative hearings were held;
- 3 518 pieces of information, announcements and statements illustrated with 5 475 photos were posted on the News page of the website;
- 342 hours and 3 minutes of programme was produced;
- 268 permanent credentials for journalists and camerapersons/photographers were issued, as well as 163 daily credentials;
- 100 individual journalists' questions concerning parliamentary activities were responded to;
- 88 requests for free access to information were submitted;
- 9 research papers were prepared and published, and around 75 queries by national parliaments of other countries were responded to;
- 213 democracy workshops were hosted, wherein 4,622 students from 75 primary schools participated;
- On 31 December 2015, 155 persons were employed in the Parliamentary Service.



The Collegium of the President of the Parliament, this year as well, adopted the 2016 Legislative Work Plan of the Parliament of Montenegro and the 2016 Action Plan for Strengthening the Legislative and Oversight Role of the Parliament of Montenegro. In accordance with the previous practice, the working bodies adopted annual work plans for 2016.

In 2016, Montenegro has continued the implementation of activities aimed at achieving further progress in accession negotiations with the European Union. In the reporting period, the Committee on European Integration considered, inter alia, the Fourth Quarterly Report on the overall activities within the process of Montenegro's integration in the European Union, for the period July – December 2015. The Committee supported the reports and proposed to the Parliament to adopt thereof.

Within the Stabilisation and Association Process, the Stabilisation and Association Parliamentary Committee (SAPC), composed of member of the European Parliament and Parliament of Montenegro, follows the application of the Stabilisation and Association Agreement. In the reporting period, SAPC held one meeting, where a declaration was adopted.

Intensive international cooperation marked 2016 through numerous bilateral and multilateral meetings and numerous regional and international gatherings.

Detailed information on legislative and oversight activities of the Parliament and its working bodies, parliamentary cooperation, transparency of work, administrative capacities, the use of funds allocated by the budget of Montenegro, as well as other activities that marked 2016, are given below. Appendixes include the list of laws adopted by the Parliament in this period, the number of parliamentary questions per MP, a tabular overview of spending, an overview of requests for free access to information, a list of research papers done in 2016 as well as a tabular overview of conducted trainings and specialisations.

Employees of all organisational units of the Parliamentary Service, in accordance with their responsibilities, were involved in the preparation of this report. The resources were primarily minutes from parliamentary sittings as well as reports and minutes from meetings of working bodies, monthly reports of organisational units, and other reports.

Presentation of data in the form of this report was prepared by the Educational Centre in cooperation with other organisational units of the Parliamentary Service.

# III LEGISLATIVE AND OVERSIGHT ACTIVITY

In 2016, the Parliament of Montenegro held a total of 16 sittings of ordinary session and 12 sittings of extraordinary session, adopting a total of 209 acts, of which 121 laws, 15 decisions, 38 decisions on elections and appointments, 33 conclusions, and two resolutions.

In 2016, a total of six sittings of extraordinary session of the Parliament were held, of which two devoted to the Prime Minister's Hour, two devoted to the Prime Minister's Hour and Parliamentary Questions, the Seventh - Special Sitting of the First Ordinary (Spring) Session in 2016 devoted to decade of proclamation of Montenegro's independence, while, in line with Article 89 of the Rules of Procedure of the Parliament, Speaker of the Parliament of the Republic of Albania Mr Ilir Meta addressed the MPs at the Special Eleventh Sitting of the Parliament of Montenegro in 2016.

21 questions were referred to the Prime Minister, and 70 to members of the Government, with 5 supplementary questions.

In the same period, working bodies held 214 meetings, for a total of 215 days, 272 hours and 48 minutes; where 745 items of agenda were considered, including 267 proposals for laws as well as 975 amendments.

In addition, working bodies held 10 control and 32 consultative hearings.

Collegium of the President of the Parliament adopted in this year also the 2016 Legislative Work Plan of the Parliament of Montenegro and the 2016 Action Plan for Strengthening the Legislative and Oversight Role of the Parliament of Montenegro.

Security and Defence Committee, in line with the Law on Parliamentary Oversight of Security and Defence Sector, adopted the 2016 Plan of Parliamentary Oversight.

More detailed information on the work of the Parliament and its working bodies is presented below. The Appendix I contains a list of laws adopted in 2016.

#### 3.1. SITTINGS OF THE PARLIAMENT

In the reporting period, i.e. in the period 1 January 2016 – 31 December 2016, the 25<sup>th</sup> and 26<sup>th</sup> Parliament of Montenegro<sup>4</sup> held 16 sittings of ordinary session and 12 sittings of extraordinary session, during which the Parliament adopted 209 acts, namely: 44 laws, 77 laws on amendments to the laws, 15 decisions (of which six with regard to consideration of financial plans), 38 decisions on elections, appointments and dismissals, 33 conclusions and two resolutions.

#### 3.1.1 PROPOSED ACTS

In the period 1 January -31 December 2016, MPs submitted: one proposal for law, 34 proposals for laws on amendments to laws, two proposals for decisions, three proposals for resolutions, the Proposal for amending the Constitution of Montenegro and the Proposal for initiating the procedure to determine whether the President of Montenegro has violated the Constitution.

In the same period, the Government submitted: 32 proposals for laws, 60 proposals for laws on amendments to laws, four proposals for decisions, and three reports. By constituting the 26th Parliament of Montenegro, the Government re-submitted seven proposals for laws, 11 proposals for laws on amendments to laws, one draft decision and two reports.

Defence and Security Council submitted two proposals for laws.

In this period, citizens did not submit proposals for laws via authorised MPs.

In the period 1 January – 31 December 2016, four laws were withdrawn from procedure, namely: the Proposal for the Law on Amendments to the Law on deployment of the Armed Forces of Montenegro units to the international forces and participation of members of civil defence, police and public administration employees in peacekeeping missions and other activities abroad, the Proposal for the Law on Amendments to the Law on National and Other Holidays, the Proposal for the Law on Amendment and Supplements to the Law on Territorial Organisation of Montenegro, and the Proposal for the Law on Amendments and Supplement to the Law on Public Sector Salaries.

#### 3.1.2 ADOPTED ACTS

In the period 1 January -31 December 2016, upon the proposal of MPs, the following was adopted: one law, eight laws on amendments to laws, one decisions and two resolutions.

In the same period, upon the Government's proposal, the following was adopted: 43 laws, 69 laws on amendments to the laws and five decisions.

Two decisions were adopted upon the proposal of the Defence and Security Council.

In the period 1 January – 31 December 2016, 12 laws and one decision were adopted under simplified procedure.

# 3.1.3 NUMBER OF CONSIDERED AND ACCEPTED AMENDMENTS TO THE PROPOSALS FOR ACTS

In the period 1 January – 31 December 2016, a total of 801 amendments to proposals for acts were considered at parliamentary sittings, of which 636 were accepted.

Committees submitted 416 amendments, of which 415 have become integral parts of the proposals for acts, namely: the Legislative Committee 303 amendments; the Committee on Political System, Judiciary and Administration 31 amendments; the Security and Defence Committee five amendments; the Committee on International Relations and Emigrants 12 amendments; the Committee on Economy, Finance and Budget 16 amendments; the Committee on Human Rights and Freedoms one amendment; the Gender Equality Committee one amendment; the Committee on Tourism, Agriculture, Ecology and Spatial Planning 26 amendments; the Committee on Education, Science, Culture and Sports four amendments and the Committee on Health, Labour and Social Welfare 30 amendments.

MPs submitted 284 amendments, of which 120 were accepted, 85 were not accepted and MPs abandoned 79 amendments.

The Government submitted 101 amendments, which have become integral parts of the proposals for acts.



#### 3.1.4 VOTES OF CONFIDENCE/VOTES OF NO-CONFIDENCE

Motion for confidence in the Government of Montenegro was considered at the Sitting of the First Extraordinary Session in 2015 of the 25th Parliament. Pursuant to Article 106 of the Constitution of Montenegro, the Government of Montenegro raised the issue of confidence in it before the Parliament. The Parliament granted confidence to the Government of Montenegro.

#### 3.1.5 PRIME MINISTER'S HOUR AND PARLIAMENTARY QUESTIONS

In 2016, a total of four special sittings of the Parliament devoted to the Prime Minister's Hour (two sittings) and the Prime Minister's Hour and Parliamentary Questions (two sittings) were held.

21 questions were put to the Prime Minister, namely:

- MP Group of the Democratic Party of Socialists two questions;
- MP Group of the Democratic Front one question;
- Special MP Group four questions;
- MP Group of the Socialist People's Party two questions;
- MP Group of the Social Democratic Party three questions;
- MP Group of the Positive Montenegro two questions;
- MP Group of the Bosniak Party two questions;
- MP Group of the Albanian parties (FORCA, DP), HGI and LPCG two questions; and
- MP Group of the Albanian Alternative three questions;

70 questions were put to members of the Government, namely:

- MP Group of the Democratic Front 21 questions;
- Special MP Group 11 questions;
- MP Group of the Socialist People's Party 24 questions;
- MP Group of the Social Democratic Party one question;
- MP Group of the Positive Montenegro four questions;
- MP Group of the Albanian parties (FORCA, DP), HGI and LPCG two questions; and
- MP Group of the Albanian Alternative seven questions;

# 3.1.6. LEGISLATIVE WORK PLAN, ACTION PLAN FOR STRENGTHENING THE LEGISLATIVE AND OVERSIGHT ROLE AND CALENDAR OF ACTIVITIES OF THE PARLIAMENT

The Collegium of the President of the Parliament of Montenegro adopted at the beginning of 2016 the 2016 Legislative Work Plan of the Parliament of Montenegro, the 2016 Action Plan for Strengthening the Legislative and Oversight Role of the Parliament of Montenegro and the Calendar of Activities of the Parliament, for the period 1 January - 31 July 2016.

2016 Legislative Work Plan of the Parliament of Montenegro contains an overview of proposals for laws that were to be considered during 2016. It comprises 167 proposals for laws, including 35 proposals for laws whose adoption was planned for the purpose of harmonising with the European Union legislation. In addition to proposals for laws, this document comprises the review of reports which some bodies, in accordance with the law, submit to the Parliament as well as proposals for financial plans of independent regulatory bodies which are considered together with the proposal for the budget law. The parliamentary service is preparing information on the Legislative Work Plan, and they are available at the web page of the Parliament.

Information note on implementation of the plan by the end of the First (Ordinary) Session i.e. by the end of July 2016 was prepared and published in September, while at the beginning of 2017 the information note for the overall 2016 will be published.

In line with the previously established practice initiated by the 2010 Action Plan, aimed at contributing to projected, systematic and coordinated activities of all stakeholders involved in the parliamentary work, the Collegium of the President of the Parliament adopted the 2016 Action Plan for Strengthening the Legislative and Oversight Role of the Parliament of Montenegro.

The 2016 Action Plan contains 64 activities and measures, with explanations, holders, deadlines of implementation and success indicators. Activities and measures envisaged by this Action Plan are grouped into three parts - strengthening the legislative and oversight functions of the Parliament of Montenegro; strengthening of administrative and professional capacities of the Parliament; and further improvement of openness and transparency of the Parliament towards citizens and civil society organisations.

The report on implementation of the Action Plan will be prepared and published in early 2017.

#### 3.2. WORK OF THE WORKING BODIES

In 2016, working bodies held 214 meetings, for a total of 215 days, 272 hours and 48 minutes; wherein 745 items of agenda were considered, including 267 proposals for laws as well as 975 amendments.

### 3.2.1 CONTROL AND CONSULTATIVE HEARINGS

Within the oversight role, working bodies of the Parliament regularly conduct control and consultative hearings of representatives of state bodies and other persons, on various topics. The working bodies held 10 control and 32 consultative hearings.

### **CONTROL HEARINGS**

At the 111th meeting of 10 February, the Committee on Political System, Judiciary and Administration conducted control hearing on the topic: "Past application in practice and the effects of new institutes from the CPC (plea agreement, witness collaborator, etc.), their scope and limitations, as well as the application of the Law on the Special Public Prosecutor - effects and problems, with particular reference to the model of the election of the chief of the special investigative team". The control hearing was organised with the aim of collecting information and expertise regarding legislative solutions related to institutes of plea agreement and witness collaborator, as well as norms of the Law on the Special Public Prosecutor related to the election of the chief of the special investigative team. The meeting was attended by responsible representatives: Ivica Stanković, Supreme State Prosecutor, Milivoje Katnić, Chief Special Prosecutor, Zoran Pažin, Minister of Justice, Marijana Laković-Drašković, Director General of the Directorate of Justice.

On 22 February 2016, the **Committee on Economy, Finance and Budget** held a control hearing of Branimir Gvozdenović, Minister of Sustainable Development and Tourism, and Zoran Mrdak, Director of the Public Enterprise for National Parks of Montenegro, regarding the negative opinion of the State Audit Institution on the financial audit and audit of regularities of the Public Enterprise for National Parks of Montenegro.

On 18 April 2016, the Committee held a control hearing of Branimir Gvozdenović, Minister of Sustainable Development and Tourism, and Biserka Dragićević, Acting Secretary of the Secretariat for Development Projects, for the purpose of determining facts and circumstances with regard to validity of the issued guarantee, in line with Annex to the Contract, on completing construction works on the hotel "As" in Perazića Do. With regard to the said control hearing, the Committee proposed five conclusions and the Parliament adopted them.

On 27 April 2016, a control hearing of Pavle Goranović, Minister of Culture, and Žarko Mirković, Director of the PI Musical Centre of Montenegro, was held with regard to the negative opinion on the financial audit and conditional opinion on audit of regularities of the 2014 Financial Report of the PI Musical Centre of Montenegro by the State Audit Institution.

A control hearing of Budimir Šegrt, Minister of Health, with regard to the state of affairs in the health system of Montenegro and the allocated amount of funds for medical devices was held on 2 June 2016. A control hearing of Raško Konjević, Minister of Finance, and Miomir M. Mugoša, Director of the Tax Administration, with regard to the opinion of the State Audit Institution on audit of success of the "Efficacy of Tax Administration in Implementing Measures for Tax Debt Collection" was held on 20 June 2016.

On 20 April 2016, the Committee on Health, Labour and Social Welfare held a control hearing of representatives of the Ministry of Interior, Ministry of Defence, Ministry of Justice, Ministry of Finance, and Protector of Property and Legal Interests of Montenegro. The reason for holding the subject control hearing was the Report on audit of success "Expenditures from the budget of Montenegro for litigations arising from labour relations" of the State Audit Institution SAI, No 40113/16-023-13/25 of 31 March 2016. On this occasion, the Committee adopted six conclusions.



At its 53rd meeting held on 1 July, which was closed to the public, the **Security and Defence Committee** held a control hearing of the Supreme Public Prosecutor, Minister of Interior, and Director of the National Security Agency with regard to the unsolved murders in Montenegro, and it considered the information on the security situation in the Kotor Municipality and the activities undertaken by the authority bodies in that respect. Upon invitation, the meeting was attended by the following: Supreme Public Prosecutor Ivica Stanković, Minister of Interior Goran Danilović, Director of the Police Administration Slavko Stojanović, Assistant Director, Head of the Criminal Police Sector Milovan Pavićević, and Director of the National Security Agency Dejan Peruničić, with his associate.

At its 61st meeting of 29 February, the **Committee on Human Rights and Freedoms** held a control hearing of the Coordinator of the Coordination Committee for Monitoring the Implementation of the Strategy for permanently resolving the issue of displaced and internally displaced persons in Montenegro with special regard to the Camp Konik I and II, Minister of Labour and Social Welfare Zorica Kovačević, on the topic: "Implementation of the Strategy for permanently resolving the issue of displaced and internally displaced persons in Montenegro with special regard to the Camp Konik" was held.

In September 2016, the **Temporary committee on monitoring the investigation of cases of endangering security of journalists and media outlets in 2016** held a control hearing of Supreme Public Prosecutor Ivica Stanković and Chief Special Prosecutor Milivoje Katnić. You can find more information in part of the report on temporary working bodies.

## **CONSULTATIVE HEARINGS**

At its 115th meeting held on 2 March 2016, the Committee on Political System, Judiciary and Administration held a consultative hearing of the applicants to the Public Notice for election of two members of the Prosecutorial Council from among the reputable jurists. The candidates who applied to the Public Notice and were heard were the following: Bošković Zoran, Delić Milan, Dragović Slobodan, Đurović Srđan, Živković Zoran, Laković Bego Novak, Murati Jakup, Murić Velija, Radojičić Zoran, Radulović Branislav, Rakočević Velimir, Ratković Vesna, and Smolović Borka.

At its 72nd meeting held on 15 March, the Committee on International Relations and Emigrants provided a positive opinion on the proposal of the Government for appointing Hamdi Hasani as Ambassador Extraordinary and Plenipotentiary of Montenegro to the Kingdom of Saudi Arabia on a non-residential basis, based in Podgorica. At its 74th meeting held on 2 June, the Committee provided a positive opinion on Boro Vučinić, a candidate for the position of Ambassador Extraordinary and Plenipotentiary of Montenegro to the Republic of Croatia, on a residential basis, based in Zagreb. At its 75th meeting, the Committee provided a positive opinion on Ljiljana Tošković, a candidate for the position of Ambassador Extraordinary and Plenipotentiary of Montenegro to the Republic of Poland, on a residential basis, based in Warsaw. At its 79th meeting held on 24 June, the Committee provided a positive opinion on Igor Jovović, a candidate for the position of Ambassador Extraordinary and Plenipotentiary of Montenegro to the Russian Federation, on a residential basis, based in Moscow. At its 81st meeting held on 19 July, the Committee provided a positive opinion on Dušan Mrdović, a candidate for the position of Ambassador Extraordinary and Plenipotentiary of Montenegro to the Republic of Albania, on a residential basis, based in Tirana. At its 83rd meeting held on 26 July, the Committee held a consultative hearing where it provided a positive opinion on Bojan Šarkić, a candidate for the position of Ambassador Extraordinary and Plenipotentiary - Head of Montenegro's Mission to the European Union, on a residential basis, based in Brussels.



At its 84th meeting held on 26 July, the Committee provided a positive opinion on Milorad Šćepanović, a candidate for the position of Ambassador Extraordinary and Plenipotentiary - Head of Montenegro's Permanent Mission to the United Nations and other international organisations in Geneva, on a residential basis, based in Geneva. At its 86th meeting held on 15 September, the Committee considered the proposal of the Government on Nebojša Kaluđerović, a candidate for the position of Ambassador Extraordinary and Plenipotentiary of Montenegro to the United States of America, on a residential basis, based in Washington, and it provided a positive opinion thereon. At its 87th meeting held on 16 September, the Committee provided a positive opinion on Aleksandar Moštrokol, a candidate for the position of Ambassador Extraordinary and Plenipotentiary of Montenegro in Hungary, on a residential basis, based in Budapest. At its 88th meeting held on 16 September, the Committee provided a positive opinion on Ferhat Dinoša, a candidate for the position of Ambassador Extraordinary and Plenipotentiary of Montenegro to the Republic of Kosovo, on a residential basis, based in Prishtina.

The **Committee on European Integration** held 19 consultative hearings of the Chief Negotiator for negotiations between Montenegro and the EU Aleksandar Andrija Pejović and other representatives of the Ministry of Foreign Affairs and European Integration, and on that occasion it considered:

At its 56th meeting held on 28 July, the **Security and Defence Committee** held a consultative hearing of the military and diplomatic representative of Montenegro Lieutenant Colonel Mitar Klikovac prior to his assuming the office. Following the comprehensive discussion, the Committee expressed its full support to the activities presented by Lieutenant Colonel Mitar Klikovac as priorities for military and diplomatic cooperation of Montenegro with the United States of America, Canada and Iceland, with assessment that it would contribute to the full promotion of the Army of Montenegro and military diplomacy.

At its 43rd meeting held on 27 April 2016, the **Anti-corruption Committee** held a consultative hearing of the Director of the Agency for Prevention of Corruption, on the topic: "Exercise of jurisdiction of the Agency for Prevention of Corruption". The Committee assessed that the Agency for Prevention of Corruption has successfully implemented obligations stemming from the Law on Prevention of Corruption in its previous work.

## **Security and Defence Committee**

- The working visit of the Committee to the Sector of the Border Police, organised by the Ministry of Interior, was implemented on 25 March. Within the visit to the Sector of the Border Police, members of the Committee toured the border police office in the Port of Bar as well as the Joint Border Crossing Sukobin Murićan, learning about the manner of functioning and regular check procedures performed by the Department of Border Security Ulcinj. Bearing in mind that the work of the border police has an essential importance for security of the state and its citizens, and particularly in the context of current security challenges, members of the Committee noted the importance of implementing activities regarding suppression and prevention of illegal migrations, cross border crime, as well as continuation of cooperation with border police services of neighbouring countries. In addition to the above, considering that securing state borders implies permanent strengthening of its oversight system, the Committee voiced full support to the activities regarding the strengthening of infrastructural, material-technical, and staff capacity of the Sector of the Border Police;
- The Committee's visit to the Directorate of Emergency Management of the Ministry of Interior was implemented on 28 March. The interest of the Committee members was focused on activities implemented during enforcement of laws and other regulations from the subject field, the issues of resources of the protection and rescue system, international cooperation, as well as the issues of funding. A part of the meeting was dedicated to the visit of the Aviation and Helicopter Unit in Golubovci during which the Committee members were informed on the capacities and the manner of operations of this organisational unit. The Committee members also visited the Operational and Communication Centre 112 which monitors and registers occurrences and events from the field of security, as needed undertakes and organises emergency and more extensive operative measures, and coordinates and directs the work of organisational units of the Police Administration;



- The Committee members Obrad Mišo Stanišić and Luigi Lubo Shkrela took part in the Round Table "Perspective of the Army of Montenegro as a NATO member", held on 4 April, organised the Atlantic Council of Montenegro with the support of NATO and Communication Team of the Council for NATO Membership;
- The Committee member Luigi Lubo Shkrela took part in the Interparliamentary Conference for the Common Foreign and Security Policy and the Common Security and Defence Policy, which took place in The Hague, the Kingdom of the Netherlands, in the period 6-8 April, within the parliamentary dimension of the Netherlands chairing the Council of the EU in 2016;
- On 16 June, Deputy Chairperson of the Security and Defence Committee Snežana Jonica and member of the Committee Luigi Lubo Shkrela met with members of the German Bundestag Alexander Neu and Inge Höger;
- The Committee member Luið Ljubo Škrelja took part in the workshop and annual discussion on the OSCE Code of Conduct on Politico-Military Aspects of Security, which was organised by the OSCE and took place in Vienna, the Republic of Austria, on 21 and 22 June;

Furthermore, the meeting was attended by the Head of the General Staff of the Army of Montenegro Admiral Dragan Samradžić and Colonel Ilija Daković;

Inquiry Committee for collecting information and facts on the events relating to the actions of competent state authorities in the protection of state property and public interest during the sale of assets of the JSC Tobacco Plant Podgorica in bankruptcy

Two officials of the Committee Secretariat did professional and administrative tasks for the needs of the Inquiry Committee for collecting information and facts on the actions of competent state authorities in the protection of state property and public interest during the sale of assets of the JSC Tobacco Plant Podgorica in bankruptcy. During 2016, the Inquiry Committee held 2 meetings, which lasted altogether one hour and, in accordance with the Law on Parliamentary Investigation, it submitted the Report with proposed measures to the Parliament of Montenegro.

# Committee on monitoring the application of the Law on Election of Councillors and MPs in the part relating to the media

The Committee held a total of three meetings (the third meeting started on 20 September, during which objections to the conduct of the media were being considered, was adjourned after two hours and 30 minutes, and the announced continuation did not happen), during three days, lasting a total of 5 hours and 5 minutes. In line with Article 67 of the Rules of Procedure of the Parliament of Montenegro, 11 persons participated in the meetings of the Committee (nine representatives of the electronic media and two representatives of the civil sector).

# Committee on monitoring the investigation of cases of endangering security of journalists and media outlets in 2016

The Committee held three meetings, for a total of 5 hours and 20 minutes. Committee on monitoring the investigation of cases of endangering security of journalists and media outlets held two meetings in August. The first, constitutive, where the co-chairs of the Committee were elected, and the second where the decision on the control hearing was unanimously adopted. In August the meetings lasted 2 hours and 30 minutes. In September 2016, the Committee on monitoring the investigation of cases of endangering security of journalists and media outlets held a meeting, during which it conducted control hearing of Supreme State Prosecutor Ivica Stanković and Chief Special Prosecutor Milivoje Katnić). The meeting lasted 2 hours and 50 minutes. In line with Article 67 of the Rules of Procedure of the Parliament of Montenegro, two persons participated in the work of the Committee (Supreme Public Prosecutor and Chief Special Prosecutor)



Meeting of the Committee on monitoring the investigation of cases of endangering security of journalists and media outlets in 2016



Committee on monitoring the application of laws and other regulations important for building trust in the election process held 7 meetings. The meetings lasted 16 hours and 55 minutes.

The first meeting unanimously adopted the model of co-chairs as the most adequate manner of work of this temporary working body of the Parliament of Montenegro. Milutin Simović was elected co-chair from among parliamentary majority, while Draginja Vuksanović was elected co-chair from among the opposition MPs/ parliamentary minority. During the second meeting of the Committee, the participants discussed monitoring provisions of the Law on Voters' Register within the jurisdiction of the Ministry of Interior. At their third meeting, the Committee discussed monitoring provisions of the Law on Voters' Register and the Law on Election of Councillors and MPs within the jurisdiction of the State Audit Institution. The fourth meeting of the Committee considered the applications of provision of the Law on Funding of Political Parties and Election Campaigns within the jurisdiction of the Agency for Prevention of Corruption. The fifth meeting considered the information of the Ministry of Interior with regard to conclusions adopted at the second meeting of the Committee of 23 August and the Action Plan for implementation and monitoring of electoral legislation of the Ministry of Interior from within the purview of Directorate for Administrative Interior Affairs. The sixth meeting of the Committee considered the Report of the State Election Commission on implemented activities regarding application of provisions of the Law on Voters' Register and the Law on Election of Councillors and MPs. The seventh meeting of the Committee considered the Report on the enforcement of the Action Plan for the implementation of the electoral legislation within the jurisdiction of the Ministry of Interior. At the meeting, the participants discussed mutual cooperation and coordination between the Ministry of Interior and the State Election Commission.

### 3.3. CONSIDERATION OF THE IMPLEMENTATION OF CONCLUSIONS

In 2016, the Committee on Political System, Judiciary and Administration sent the Proposal for Conclusions (15) to the Parliament with regard to consideration of the 2015 Performance Report of the Prosecutorial Council and Public Prosecution Office and with regard to the 2015 Annual Performance Report of the Judicial Council and the overall state of the judiciary.

At the 129th meeting of the Committee, held on 29 June 2016, the Committee unanimously decided to refer a proposal of conclusions (eight) to the Parliament with regard to the 2015 Performance Report of the Prosecutorial Council and the Public Prosecutor's Office. On 30 June 2016, at its Tenth Sitting of the First Ordinary (Spring) Session in 2016, the Parliament of Montenegro adopted the Conclusions (eight) with regard to consideration of the 2015 Performance Report of the Prosecutorial Council and Public Prosecution Office.

With regard to the 2015 Annual Performance Report of the Judicial Council and the overall state of the judiciary, the Committee unanimously decided to refer a proposal of conclusions (seven) to the Parliament. At its Tenth Sitting of the First Ordinary (Spring) Session in 2016, the Parliament of Montenegro adopted the Conclusions (seven) with regard to consideration of the 2015 Performance Report of the Prosecutorial Council and the Public Prosecutor's Office.

At its 47th meeting, the Anti-corruption Committee considered special performance reports on the Supreme Public Prosecutor's Office and Special Public Prosecutor's Office for the period 1 January to 1 July 2016, in line with the Decision reached by the Anti-corruption Committee at their 44th meeting.

In 2016, the Committee on Economy, Finance and Budget was focused on following the implementation of parliamentary conclusions in accordance with the 2016 Action Plan for Strengthening the Legislative and Oversight Role of the Parliament of Montenegro. The Committee considered the implementation of six parliamentary conclusions. Namely, at the 128th meeting, held on 1 February 2016, the Committee considered the implementation of six conclusions (Official Gazette of Montenegro, No 46/15) adopted with regard to control hearing held on the subject: "Implementation of policy, or law in the field of concessions, with reference to implementation of conclusions of the Parliament of Montenegro adopted regarding consideration of 2013 Performance Report of the Commission for Concessions (Official Gazette of Montenegro No 31/14 of 24 July 2014)".



Starting from the opinions, attitudes and evaluations in relation to the level of implementation of six parliamentary conclusions, the Committee noted that the conclusions 1, 2 and 3 were implemented, 5, 6 were in the implementation phase, while conclusion 4 was not implemented.

At its 64th meeting of 25 May 2016, in addition to consideration of the 2015 Status Report on Personal Data Protection and Access to Information in Montenegro, the Committee on Human Rights and Freedoms also followed the implementation of the Conclusions by the Parliament of Montenegro adopted with regard to consideration of the 2014 Status Report on Personal Data Protection and Report on the Access to Information in Montenegro (Official Gazette of Montenegro, No 3/16). In addition to consideration of the 2015 Annual Performance Report of the National Preventive Mechanism against Torture, at its Second Meeting of 28 December 2016, the Committee on Human Rights and Freedoms dealt with the implementation of the Conclusions of the Parliament of Montenegro adopted with regard to consideration of the 2014 Annual Performance Report of the National Preventive Mechanism against Torture (Official Gazette of Montenegro, No 3/16).

At its 117th meeting of 1 March, the Committee on Health adopted the Proposal for a decision on considering the position of persons with disabilities in Montenegro with regard to consideration of the implementation of the conclusion No 1, being a part of the Conclusions of the Committee No 00-63-12/15-63/2 of 28 December 2015 (at its 113th meeting with regard to the 110th meeting devoted to marking International Day of Persons with Disabilities, the Committee adopted two conclusions). On 3 March 2016, the Committee sent this Proposal for the Decision to the Parliament of Montenegro, for putting it into procedure. The proposed decision refers to the obligation of the responsible state administration body to submit annually a report on the position of persons with disabilities in Montenegro to the Parliament of Montenegro.



# IV PARLIAMIENTARY COOPERATION

### 4.1. EUROPEAN INTEGRATION

In 2016, Montenegro has continued to actively fulfil obligations related to process of negotiating with the European Union, and the implement reforms aimed achieving European standards.

In 2016, four negotiation chapters have been opened at intergovernmental conferences on accession to the EU, namely: 11 - Agriculture and rural development, 12 - Food safety, veterinary and phytosanitary policy, 13 – Fisheries and 19 - Social policy and employment. Thus Montenegro has opened 26 negotiation chapters in total, of which to have been temporarily closed (25 – Science and Research and 26 – Education and Culture).

Parliamentary contribution to the process of European integration has been continued through the work of the Committee on European Integration, which in 2016 considered a total of four draft negotiation positions, for chapters 1- Free movement of goods, 11 - Agriculture and rural development, 12 - Food safety, veterinary and phytosanitary policy and 22 - Regional policy and coordination of structural instruments. Also, the Committee considered four reports on the following negotiation chapters: 5 - Public procurement, 10 - Information society and media, 20 - Enterprise and industrial policy and 30 - External relations. Within its responsibility to consider information on negotiation process, the Committee also considered a number of other reports of the responsible ministry, by organising consultative hearings (see 3.2.1).

The highest level of cooperation of the Parliament of Montenegro and the European Parliament is archived through the work of the Stabilisation and Association Parliamentary Committee (SAPC). In the reporting period, the SAPC held one meeting in Podgorica, on 19 and 20 May. Declaration with recommendations was adopted at the meeting, and the current state of the accession negotiations and relations between the European Union and Montenegro was discussed, as well as the monitoring of the recommendations adopted at the previous meeting, the rule of law and the implementation of the electoral legislation, fundamental rights with a focus on gender equality and children's rights, environmental protection and energy, and the fight against corruption in connection with economic development.

The EC's Report on Montenegro, published on 9 November, and covering the period October 2015 - September 2016, gives an overall assessment of progress in negotiations with the EU. Concerning Montenegro's ability to assume the obligations of membership, the Report says that Montenegro has achieved good progress in fields, such as: free movement of goods, agriculture and rural development, safety of food, veterinary and phytosanitary policy, energy, environment and climate change, foreign relations and financial control, while in the future it should be particularly focused on protection of competition and economic and monetary policy.

When it comes to parliamentary diplomacy within the EU accession, members of the Parliament of Montenegro regularly participate in meetings organised within the EU presidency. In the reporting period, members of the Committee on European Integration participated in meetings of the Conference of Parliamentary Committees for Union Affairs (COSAC), namely at the meeting of chairpersons and plenary session held during the Dutch presidency (7-8 February and 12-14 June) and at the meeting of chairpersons held during the Slovak presidency (10-11 July). Members of Parliament also participated in other meetings organised within the Presidency of the Netherlands and Slovakia: Conference on Stability, Economic Coordination and Governance in the European Union (17 February and 16 - 18 October); Meeting of Chairpersons of Committees on Energy (3 and 4 April); Inter-Parliamentary Conference on Common Foreign Policy and Security Policy (CFSP) and on Common Security and Defence Policy (6-8 April and 2-4 September).



Members and staff of the Parliament of Montenegro also participate in activities organised within Assistance programme of the European Parliament to help aspirant countries prepare for EU membership. In the reporting period, the representatives of the Parliament participated in inter-parliamentary meetings on the following topics: Immigration Policy of the European Union and Asylum Policy; Interaction of political groups, parties, and the government in the process of European integration; Combating Discrimination against Persons with Disabilities.

### 4.2. VISITS OF OTHER STATES' REPRESENTATIVES

## ACTIVITIES OF THE PRESIDENT OF THE PARLIAMENT

- On 11 January, President of the Parliament of Montenegro Ranko Krivokapić received Joseph Muscat Prime Minister of Malta. During the meeting with President of the Parliament of Montenegro Ranko Krivokapić, Prime Minister of Malta Joseph Muscat expressed his pleasure with the existing bilateral relations and expressed desire for further promotion of relations between Montenegro and Malta.
- On 20 January, President of the Parliament of Montenegro Ranko Krivokapić received Minister of Foreign Affairs of Armenia Edward Nalbandian. The interlocutors exchanged opinions on current political situation, frozen conflicts of the Republic of Armenia and recent developments on the Montenegrin political scene.
- On 22 January, President of the Parliament of Montenegro Ranko Krivokapić received in a farewell visit H.E. Frantisek Lipka, Ambassador of Slovakia to Montenegro. During the meeting, President Krivokapić and Ambassador Lipka assessed that relations of Montenegro and Slovakia have been traditionally good and strong, particularly in the field of providing support to the European and Euro-Atlantic integrations.



- On 3 February, President of the Parliament of Montenegro Ranko Krivokapić hosted Philip M. Breedlove, Supreme Allied Commander in Europe. The interlocutors estimated that Montenegro's accession to NATO Alliance was mutually beneficial. Montenegro was estimated as a country which, among other things, provided a significant contribution to regional stability with its good international relations and especially good neighbourly relations, while NATO contributed to Montenegro in various domains, but mostly in promotion of security and stability.
- On 4 February, President of the Parliament of Montenegro Ranko Krivokapić met Angelina Eichhorst, Director for Western Europe, Western Balkans and Turkey at the European External Action Service.
- On 10 February, President of the Parliament of Montenegro Ranko Krivokapić hosted Roman Hloben newly appointed Ambassador of the Slovak Republic. President of the Parliament of Montenegro Ranko Krivokapić welcomed Ambassador Hloben, pointing out that the Slovak Republic was a very important factor in achieving historic goals of Montenegro renewal of independence and NATO membership. Ambassador Roman Hloben expressed his pleasure with becoming the Ambassador to Montenegro in the year when Montenegrins celebrated the tenth anniversary of their renewed independence. Sebastian Kurz, Austrian Ministers of Foreign Affairs, was the guest of President Krivokapić on the same day. The interlocutors assessed the maintaining the constant political course was necessary for progress and successful European integration, while building trust in the election system was a step which should be undertaken on that path.
- On19 February, President of the Parliament of Montenegro Ranko Krivokapić hosted Miro Kovač, Minister of Foreign and European Affairs of the Republic of Croatia. The interlocutors assessed that the continuously good relations needed to proceed, namely by strengthening cooperation in the fields of culture, tourism, economy, and education.
- On 3 March, President of the Parliament of Montenegro Ranko Krivokapić hosted Petr Pavel Czech General, Chairman of the NATO Military Committee. The interlocutors assessed that hard work in the field of strengthening democracy and rule of law was a basis for achieving full-fledged membership in NATO. Chairman of the NATO Military Committee Petr Pavel stressed the progress of Montenegro in the Euro-Atlantic integration, but also the goals that should be fulfilled.
- On 4 March, President of the Parliament of Montenegro met the Delegation of the European Affairs Committee of the lower house of the French National Assembly, headed by Chairperson of the Committee Danielle Auroi.
- On 9 March, President of the Parliament of Montenegro Ranko Krivokapić met Dirk Lange, Head of Unit D1 for Montenegro at the Directorate of the European Commission for Neighbourhood Policy and Enlargement Negotiations, and Clive Rumbold, Deputy Head of Western Balkans Division at European External Action Service. President of the Parliament of Montenegro Ranko Krivokapić informed his interlocutors on the course of the Parliamentary Dialogue which was greeted by the European Commission and the European Parliament, and launched with a view to creating conditions for fair and free elections.
- On 8 April, President of the Parliament of Montenegro Ranko Krivokapić met Ambassador Marcel Pesko, Director of the OSCE Conflict Prevention Centre. For the most part, the meeting was dedicated to current political developments, Parliamentary Dialogue, i.e creation of conditions for fair and free elections. On the same day, President Krivokapić received delegation of the Parliamentary Group for Cooperation with South East Europe from the German Bundestag headed by Peter Weiss. The delegation from the German Bundestag was also hosted by members of the Committee on European Integration as well as by Vice President of the Parliament Milutin Simović.
- On 18 April, President of the Parliament of Montenegro Ranko Krivokapić received attendees of the prestigious leadership development program of the German Marshall Fund, hosted by the Centre for Civic Education. The interlocutors concluded the Parliament of Montenegro had influenced positively on democratic order by its previous work, particularly when it comes to transparency in work and inclusion of the civil society, which has been recorded in the official documents of the European Union and civil society organisations.



- On 28 April, President of the Parliament of Montenegro Ranko Krivokapić received the delegation of the Committee on European Union Policies of the Italian Senate headed by Senator Vannino Chiti. The interlocutors concluded that Montenegro and Italy had traditionally good relations, founded on common values.
- On 6 May, President of the Parliament of Montenegro Ranko Krivokapić met Alexander Vershbow, NATO Deputy Secretary General. During the meeting, they shared opinions on the current political situations, with accent on the need for implementing fair and free forthcoming parliamentary elections.

- On 3 June, President of the Parliament of Montenegro Darko Pajović received Ambassador of Hungary to Montenegro Krisztian Posa. The interlocutors agreed that relations of the two countries were traditionally friendly, and stressed that there was potential for their further development, particularly in the field of economy.
- On 6 June, President of the Parliament of Montenegro Darko Pajović met Ambassador of the Republic of Romania to Montenegro Ferdinand Nagy. Ambassador Nagy said that Romania supported Montenegro's full membership to Euro-Atlantic Alliance and was a partner for its European path.
- On 7 June, President of the Parliament of Montenegro Darko Pajović received US Ambassador to Montenegro Margaret H.E. Ann Uyehara. President Pajović expressed gratitude for the support of the US Embassy to Montenegro, which had been a significant partner in the process of Montenegro's Euro-Atlantic integration.
- On 9 June, President of the Parliament of Montenegro Darko Pajović received Head of the EU Delegation to Montenegro H.E. Mitja Drobnič. Mr Pajović announced that the Parliament of Montenegro would continue good relations and cooperation with the EU Delegation. On the same day, President of the Parliament of Montenegro Darko Pajović received H.E. President of the Republic of Malta Ms Marie-Louise Coleiro Preca. President Pajović emphasised that the two countries may have useful exchange of experiences, particularly in the field of environment protection and that cooperation in tourism should be improved.



- On 10 June, President of the Parliament of Montenegro Darko Pajović received H.E. Ambassador of Austria to Montenegro Johann Fröhlich. Mr Fröhlich stressed that Austria had been following Montenegro's progress on its path of Euro-Atlantic integration with great interest. The Austrian Ambassador was especially interested in the work plan of the Montenegrin Parliament in the upcoming period. President Pajović said that the intention was for the parliament to maximally speed up its work dynamics, especially having in mind that a large number of laws and other acts was in the parliamentary procedure, waiting to be adopted.
- On 13 June, President of the Parliament of Montenegro Darko Pajović met Ambassador of the Slovak Republic to Montenegro Roman Hloben. President Pajović thanked Ambassador Hloben for congratulating him on the appointment and for his words of support, informing him about the plan of activities he had already initiated in the Parliament, aimed to return the Parliament on the course of the legislative power to which it belongs. On the same day, President of the Parliament of Montenegro Darko Pajović met with Ambassador of the Republic of Italy to Montenegro H.E. Vincenzo Del Monaco.
- On 15 June, President of the Parliament Darko Pajović met Ambassador of the Great Britain H.E. Ian Whitting. The interlocutors voiced mutual pleasure over bilateral relations of the two countries, while President Pajović thanked for the British help to Montenegro in European and NATO integration. On the same day, President Pajović met Head of the Montenegro Unit at the Directorate-General for European Neighbourhood and Enlargement Negotiations Dirk Lange and Head of the EU Delegation to Montenegro H. E. Mitja Drobnič. Current political situation was the topic of the meeting. On this occasion, President Pajović stressed that the activities envisaged by the Agreement on Creating Conditions for Free and Fair Elections, and which fell under responsibilities of the Parliament, would be completely implemented, and that this was primarily related to the temporary committee that would monitor the application of laws and other regulations important for building trust in the election process.
- On 20 June, President of the Parliament of Montenegro Darko Pajović held a meeting with ambassadors of NATO member states. President of the Parliament of Montenegro Darko Pajović expressed his gratitude to NATO member states that have already ratified the NATO Accession Protocol for Montenegro, expressing hope that other members will follow their example. NATO ambassadors accredited in Montenegro praised Montenegro's progress in Euro-Atlantic integration, stating that the ratification of the Accession Protocol was a confirmation of that.
- On 21 June, President of the Parliament Darko Pajović met with the media representatives who follow the work of the Parliament. Mr Pajović said that he expected that part of the parliamentary obligations under the Agreement on conditions for fair and free elections between the government and the opposition, concerning the establishment of two parliamentary committees, will be realised soon. One of these will be the committee on monitoring the investigation of cases of endangering security of journalists and media outlet, therefore this is expected to improve the work in the media field. On the same day, President Pajović received in a farewell visit H.E. Elisabeth Gudrun Steinacker, Ambassador of the Federal Republic of Germany to Montenegro. The President thanked Ambassador Steinacker for the support of the German Federal Republic to Montenegro during her mandate, in particular for the projects related to environmental protection. The interlocutors also discussed the future purpose and sustainability of the solution for the Saltworks.
- On 24 June, President of the Parliament of Montenegro Darko Pajović received H.E. Constantinos Eliades, newly appointed Extraordinary and Plenipotentiary Ambassador of the Republic of Cyprus. The interlocutors discussed the importance of stronger political and economic integration of smaller European countries, in order to protect their national interests, and the Summit of Presidents of Parliaments of Small European Countries is an example of good practice in that respect. On the same day, President Pajović received H.E. Mohamed Bougamra, newly appointed Extraordinary and Plenipotentiary Ambassador of the Republic of Tunisia. The interlocutors also suggested that lead parliaments committees should consider opportunities for strengthening cooperation and exchange of experiences in the field of tourism and agriculture.



- On 29 June, President of the Parliament of Montenegro Darko Pajović received H.E. Serhat Galip, Ambassador of the Republic of Turkey to Montenegro. The President handed over a letter of condolence to Ambassador Galip concerning the terrorist attack on the Istanbul airport that took place the previous day and thanked Turkey for supporting the process of Euro-Atlantic integration.
- On 30 June, President Pajović received Ambassador of the Republic of France H.E. Ms Véronique Brumeaux. President of the Parliament Darko Pajović thanked the Ambassador for France's support to Montenegro's European and Euro-Atlantic Integration, while the Ambassador said that France was expected to begin the process of ratification of the NATO Accession Protocol for Montenegro.
- On 12 July, President of the Parliament Darko Pajović met Speaker of the Parliament of the Republic of Albania Ilir Meta, who was paying an official visit to Podgorica. The interlocutors noted that relations between Montenegro and Albania should serve as an example of good neighbourly relations relying on mutual respect, understanding, trust, support, and cooperation.

On the same day, President Pajović received Secretary General of the Organisation for Security and Cooperation in Europe (OSCE) Lamberto Zannier. President Pajović informed his interlocutor on the current political developments in the country, with a special reference to recently established Government of electoral trust, stressing that Montenegro had shown democratic maturity to resolve political challenges at the table. On the same day, President Pajović talked with Michael Carpenter, U.S. Deputy Assistant Secretary of Defense. President Pajović expressed gratitude for the support in Euro-Atlantic integration of Montenegro, emphasising as especially significant that the USA had recognised the significance of this historic moment, not only for Montenegro but also for the entire region.



- On 25 July, President of the Parliament of Montenegro Mr Darko Pajović received in a farewell visit Head of the EU Delegation to Montenegro Ambassador Mitja Drobnič. President Pajović expressed satisfaction over the fact that in these four years, during Ambassador Drobnič's term of office, relations of Montenegro and European Union have initiated better phase, which, institutionally as well as essentially, implied the highest possible level of relations between the EU and non-member states. Ambassador Drobnič stressed that these four years were a good opportunity to analyse track records. He said that decision of the EU to open negotiations with Montenegro by the end of 2012 proved to be right.
- On 27 July, President of the Parliament of Montenegro Darko Pajović received H.E. Sotirios Athanasiou, Ambassador of the Republic of Greece to Montenegro. The President thanked for the support to European and Euro-Atlantic integration of Montenegro. Ambassador Athanasiou informed the President that the Hellenic Parliament would soon ratify the NATO Accession Protocol for Montenegro and that it would have the support of all political parties in the Parliament.
- On 2 August, President of the Parliament of Montenegro Darko Pajović received H.E. Cui Zhiwei, Ambassador of the People's Republic of China to Montenegro. The interlocutors agreed that there was room for further strengthening of cooperation in the fields of common interest, in accordance with the needs of the state development of Montenegro.
- On 3 August, President of the Parliament of Montenegro Darko Pajović received new Ambassador of the Federal Republic of Germany in Podgorica H.E. Mr Hans Günther Mattern. President Pajović congratulated to the Ambassador on assuming the new position and expressed expectation that good cooperation will be continued and also strengthened in the following period, particularly in the field of economy. According to Ambassador Mattern, the process of ratification of the NATO Accession Protocol for Montenegro in the German Bundestag will not last long, because Germany wants to see Montenegro in NATO and EU.
- On 7 September, President of the Parliament of Montenegro Darko Pajović received in a farewell visit Ambassador of the Republic of France to Montenegro Ambassador Véronique Brumeaux. President Pajović thanked to Ambassador Brumeaux for the cooperation and support, particularly emphasising visibly improved relations of the two countries at the parliamentary level.
- On 19 September, President of the Parliament of Montenegro Darko Pajović received delegation of NATO's Supreme Allied Commander Transformation (SACT), led by General Denis Mercier.
- On 21 September, President of the Parliament of Montenegro Darko Pajović received OSCE/ODIHR Election Observation Mission for elections in Montenegro, led by Mr Roman Jakič, Head of the Mission. During the meeting, they talked about election process, conditions for election campaign as well as the role of the Mission in Montenegro.
- On 22 September, President of the Parliament of Montenegro Darko Pajović received in the Parliament Aivo Orav, new Head of the European Union Delegation to Montenegro and Plamena Halacheva, Head of Political, European Integration and Trade Section in the European Union Delegation to Montenegro.

- On 29 September, President of the Parliament of Montenegro Darko Pajović received Ambassador of France to Montenegro Ms Christine Toudic. President Pajović expressed satisfaction with the high level of relations between the two countries, as well as the need for more intensive cooperation between the parliaments of Montenegro and France.
- On 3 October, President of the Parliament of Montenegro Darko Pajović received in Villa Gorica Deputy Assistant Secretary for European and Eurasian Affairs Hoyt Brian Yee. The President of the Montenegrin Parliament expressed his gratitude to the United States of America for their engagement concerning the ratification of the NATO Accession Protocol for Montenegro.
- On 14 October, President of the Parliament of Montenegro Darko Pajović hosted a delegation of the OSCE Parliamentary Assembly for monitoring parliamentary elections in Montenegro, led by Head of the observation mission Azay Quliyev and special coordinator Margareta Cederfelt. The participants of the meeting talked about conditions for holding parliamentary elections on Sunday, 16 October. The President of the Parliament informed the OSCE delegation on the results achieved by the Parliament and its new leadership when it comes to preparation of free and fair elections,
- On 30 November, President of the Parliament of Montenegro Ivan Brajović received U.S. Ambassador H.E. Margaret Ann Uyehara. Ambassador Uyehara congratulated President Brajović on the election, wishing him success in the new office. During the meeting, they discussed the work of the new convocation of the Parliament, as well as the continuation of the European integration process. The interlocutors agreed that Montenegro should continue strengthening its democratic capacities on the progress path in integration processes.
- On 1 December, President of the Parliament of Montenegro Ivan Brajović received Ambassador of Slovakia to Montenegro Roman Hloben, who stressed the importance of leading the state parliament in the forthcoming key period of Euro-Atlantic integration of Montenegro. The interlocutors emphasised a very important role of Slovakia in respect of Montenegro, which presided of the European Union in the second half of 2016, as well as proved friendship of the two countries in the previous decade.
- On 2 December, President of the Parliament of Montenegro Ivan Brajović received Ambassador of Hungary to Montenegro H.E. Kristizian Posa, who presented to him a letter by Speaker of the Hungarian Parliament László Kövér with congratulatory message and expressions of the best wishes for successful work and cooperation of the two parliaments.



- On 6 December, President of the Parliament of Montenegro Ivan Brajović received Ambassador of the Republic of Slovenia to Montenegro Mitja Močnik, who delivered to him a congratulatory letter of his Slovenian counterpart Mr Milan Brglez.
- On 7 December, President of the Parliament of Montenegro Ivan Brajović met Genoveva Ruiz Calavera, Director for the Western Balkans at the Directorate-General for European Neighbourhood Policy and Enlargement Negotiations of the European Commission, Dirk Lange, Head of Unit for Montenegro in the Directorate General for Enlargement of the European Commission, and Aivo Orav, Ambassador of the European Union to Montenegro. The meeting also discussed the priorities of the Parliament in the upcoming period, especially with regard to completion of the Euro-Atlantic integration process. The interlocutors agreed that constructive political dialogue in the Parliament was of key importance for the country in the integration process
- On 8 December, President of the Parliament of Montenegro Ivan Brajović met European Commissioner for European Neighbourhood Policy and Enlargement Negotiations Johannes Hahn. The interlocutors agreed that a lot of obligations were before the Parliament, especially those from the European agenda, and that the commitment to the European perspective was proven, among other things, via parliamentary dialogue. On the same day, at the meeting with Ambassador of the Great Britain to Montenegro Ian Whitting, President Brajović thanked for the continuous support of the Great Britain to European and Euro-Atlantic integration of Montenegro, which was once again confirmed by a rapid ratification of the NATO Accession Protocol for Montenegro. On the same day, President Brajović met UN Resident Coordinator and UNDP Resident Representative for Montenegro Ms Fiona McCluney. At the meeting, they discussed the achievements of the Parliament of Montenegro in relation to gender equality. Also, they spoke about preparations for the upcoming conference "Advancing the Gender Equality Agenda in the Western Balkans and Turkey".

On 13 December, President of the Parliament of Montenegro Ivan Brajović had a meeting with Cihan Sultanoğlu, UN Assistant Secretary-General and UNDP Director of the Regional Bureau for Europe and the Commonwealth of Independent States. The interlocutors noted significant progress of Montenegro since its independence of 2006, particularly in the field of democratisation, reform of legislation and European integration processes. Those are the fields where UNDP and Montenegro have very active cooperation through numerous programmes, including the Parliament.

• On 16 December, President of the Parliament of Montenegro Ivan Brajović met with the ambassadors of the European Union member states to Montenegro. The gathering was hosted by Head of the EU Delegation to Montenegro Aivo Orav and Ambassador of the Republic of Slovakia, presiding EU country Roman Hloben. As Mr Hloben said, today's meeting is the last meeting with the ambassadors of the European Union in Podgorica during the Slovak presidency of the EU. The meeting was also attended by vice president of the Parliament Branimir Gvozdenović and Genci Nimanbegu.



- On 23 December, President of the Parliament of Montenegro Ivan Brajović received Ambassador of Turkey to Montenegro Mr Serhat Galip, and on that occasion he expressed gratitude for the continuous support of Turkey in the process of Euro-Atlantic integration of Montenegro. The best confirmation of that support is the early ratification of the NATO Accession Protocol to Montenegro in the Turkish Parliament. On the same day, President of the Parliament of Montenegro Ivan Brajović received Ambassador of the United Arab Emirates (UAE) to Montenegro Hafsa Al-Ulama. President Brajović emphasised that, owing to continuous engagement of Ambassador Ulama, relations between Montenegro and the Emirates had been significantly improved and their ties strengthened. At the meeting, they pointed out excellent cooperation on political, cultural, and economic levels, with stress on significant investments of the Emirates in our country.
- On 26 December, President of the Parliament Ivan Brajović received Ambassador of Kosovo to Montenegro Skender Durmishi. The significance of improvement of trust and mutual commitment to strengthening relations appropriate to neighbouring countries was emphasised at the meeting. On the same day, President of the Parliament Ivan Brajović met Ambassador of Palestine to Montenegro Rabii Al-Hantouli in the Parliament of Montenegro. Mr Brajović expressed pleasure over the opening of the Palestinian Embassy to Montenegro and stressed the importance of strengthening political dialogue at all levels. He reminded of the need for intensifying parliamentary cooperation and cooperation within parliamentary committees.

### ACTIVITIES OF THE VICE PRESIDENTS OF THE PARLIAMENT

- on 24 February, Vice President of the Parliament of Montenegro Suljo Mustafić met with Head of Political and Economic Section at the US Embassy Eric Holmgren. Mr Mustafić pointed out the significance of partnering relations and thanked for the support of the United States of America given to Montenegro in its integration to the EU and NATO Alliance.
- Within the official visit to Montenegro by Chairperson of the Committee for Foreign Policy of the Chamber of Deputies of the Romanian Parliament László Borbély on 8 and 9 March, meetings were held with the Friendship Group with the Romanian Parliament and the Committee on International Relations and Emigrants of the Parliament of Montenegro. On that occasion, Chair of the Friendship Group and Vice President of the Parliament of Montenegro Suljo Mustafić pointed out the continuity of very good cooperation between Montenegro and Romania, which was substantiated by intensive contacts at the highest political level.
- On 20 April, Vice President of the Parliament of Montenegro Milutin Simović received the delegation of the Republic of Malta, headed by Jose A. Herrera, Parliamentary Secretary for Competitiveness and Economic Development at the Ministry for the Economy, Investment and Small Business. The meeting between Vice President Simović and Jose A. Herrera went by in a constructive conversation, during which they agreed on the need for further intensifying political cooperation and cooperation in the area of our country's accession to the European Union.
- On 23 June, Vice President of the Parliament of Montenegro Milutin Simović met with members of the Working Group of the Council of the European Union on Enlargement (COELA), who are paying an official visit to Montenegro.



Addressing the attendees, Vice President Simović said that the meeting with members of the Working Group represented an excellent opportunity, in this year of special significance for Montenegro, to make a kind of review of the situation and analyse what had been done, emphasising that Montenegro certainly represented a stable, democratic country, committed to its further development and the EU and NATO integration, a country developing good neighbourly relations and regional cooperation.

- On 26 June in Podgorica, Vice President of the Parliament of Montenegro Suljo Mustafić spoke with Deputy of the Grand National Assembly of the Republic of Turkey Hüsnüye Erdoğan. They emphasised, at the meeting, that relations of the two countries were friendly, and that they had been increasingly improved in political, economic, cultural and educational field. It is necessary to intensify contacts via parliamentary friendship groups, particularly by holding joint meetings in Montenegro and Turkey.
- On 30 June, Vice President of the Parliament of Montenegro and Chair of the Parliamentary Friendship Group of Montenegro with Azerbaijan Suljo Mustafić received for farewell visit Deputy Head of the Diplomatic Mission of the Republic of Azerbaijan in Montenegro Seyran Mirzazadeh. They jointly noted that the relations between Montenegro and the Republic of Azerbaijan have been significantly improved in numerous social and political spheres and that diplomatic mission in Podgorica had an important role in that.

During the official visit paid by Speaker of the Albanian Parliament Ilir Meta, Vice President of the Parliament of Montenegro Suljo Mustafić hosted a working lunch also attended by MPs Goran Tuponja, Aleksandar Damjanović, Nikola Gegaj, Almer Kalač, and Nik Gjeloshaj. The meeting passed in a constructive conversation, during which the interlocutors agreed on the need for further intensifying political and overall cooperation of the two countries for which there was mutual interest.

• On 15 July, Vice President of the Parliament of Montenegro Suljo Mustafić met with European Commissioner for Health and Food Safety Vytenis Andriukaitis. Vice President Mustafić said that Montenegro was dedicated to meeting important strategic goals relating to further integration towards the European Union and the NATO Alliance. It was agreed that it was necessary to improve legislative regulation from Chapter 28 - Consumer and health protection, relating to the field of infectious diseases, tobacco products, and substances of human origin.

- On 27 July, Vice President of the Parliament of Montenegro Suljo Mustafić met with the Charge d'Affaires at the UAE Embassy. Political cooperation represents a very important part of the overall relations between Montenegro and the United Arab Emirates, and it is possible to strengthen them further through establishment of parliamentary friendship groups, the interlocutors concluded during today's meeting between Vice President of the Parliament of Montenegro Suljo Mustafić and Charge d'Affaires at the UAE Embassy to Montenegro Ibrahim Al Alawi. They noted that cooperation of the two countries in the field of economy and culture was good, with room for its further improvement.
- On 28 July, Vice President of the Parliament of Montenegro Suljo Mustafić met with Director of the Konrad Adenauer Foundation (KAS) for Serbia and Montenegro Norbert Beckmann-Dierkes. It was noted at the meeting that the Konrad Adenauer Foundation, with its project activities, contributed to development of democracy and social and political ambiance of Montenegro, in the fields such as: promotion of parliamentary democracy and strengthening of institutions, support to the process of European integration, and support to reforms in the field of the rule of law.
- On 12 September, Vice President of the Parliament of Montenegro Milutin Simović received Ms Plamena Halacheva, the newly appointed Head of Political, European Integration and Trade Section at the EU Delegation to Montenegro. Vice President Simović voiced his pleasure over the first official visit of Ms Halacheva and congratulated her on assuming office, with assessment that the meeting was a significant incentive to continuation of good cooperation between the Parliament of Montenegro and the EU Delegation. Head of Political, European Integration and Trade Section Plamena Halacheva pointed out that the Parliament of Montenegro was one of key interlocutors of the EU Delegation, with regard to the election process.
- On 22 September, Vice President of the Parliament of Montenegro Suljo Mustafić also received the newly appointed Head of the EU Delegation to Montenegro Aivo Orav. They jointly noted that the previous achievements obliged Montenegro to continue with its principled policy of fulfilling criteria for its full membership in the European Union.

### 4.3. VISITS ABROAD

### ACTIVITIES OF THE PRESIDENT OF THE PARLIAMENT

- On 8 June, during their official visit to Slovenia, President of the Parliament of Montenegro Darko Pajović and Chairperson of the Committee on International Relations and Emigrants Miodrag Vuković attended the Ceremonious Session of the National Assembly of the Republic of Slovenia, which was the first EU member state to ratify the Protocol to the North Atlantic Treaty on the Accession of Montenegro. During the meeting with President of the Republic of Slovenia Borut Pahor, Delegation of the Parliament of Montenegro thanked for the friendly support of Slovenia, which was pointing out the importance of Montenegro's membership in this moment at all important international addresses.
- On 23 June, within the official visit to the Republic of Albania, President of the Parliament of Montenegro Darko Pajović met with Speaker of the Parliament of the Republic of Albania Ilir Meta. President Pajović voiced gratitude to Albania for its continuous support in the process of Euro-Atlantic integration, as well as for the prompt procedure of ratifying the NATO Accession Protocol for Montenegro, thus becoming the first member state of the Alliance from our immediate neighbourhood to do so. Within the official visit, President of the Parliament of Montenegro Darko Pajović also held meetings with the Prime Minister Edi Rama, President of Albania Bujar Nishani, and representatives of the Association of Montenegrin Diaspora in Albania Doclea and Alba Montenegro.
- On 30 June, President of the Parliament of Montenegro Darko Pajović paid a visit to Sofia, where he attended the sitting of the National Assembly of the Republic of Bulgaria, where the NATO Accession Protocol for Montenegro was ratified by a vast majority. In the conversation with Bulgarian officials, President Pajović expressed gratitude for the continuous support of Bulgaria to the process of European and Euro-Atlantic integration of Montenegro.




- On 4 July, during his stay in Tbilisi, President of the Parliament of Montenegro Darko Pajović was officially received by President of Georgia Giorgi Margvelashvili. President Pajović thanked Georgia for its messages of support, following the invitation and signing of the NATO Accession Protocol for Montenegro.
- On 31 August, in Warsaw, President of the Parliament of Montenegro Darko Pajović met with Speaker of the Grand National Assembly of Turkey Ismail Kahraman, during the parliamentary meeting of the Central and Eastern European countries titled "Solidarity and Sovereignty". President of the Montenegrin Parliament voiced his gratitude for the ratification process of the NATO Accession Protocol for Montenegro, which Turkey had begun on 9 August. On the same day, President Pajović also met with his counterparts from neighbouring countries Trajko Veljanoski from Macedonia, Mladen Bosić from Bosnia and Herzegovina, and Maja Gojković from Serbia. All interlocutors expressed satisfaction with the good neighbourly relations as well as the desire to strengthen cooperation in all fields. They focused on parliamentary cooperation, particularly on the exchange of experiences related to the process of European integration of these countries.
- On 4 September, President of the Parliament of Montenegro Darko Pajović took part in the Interparliamentary Conference for the Common Foreign and Security Policy (CFSP) and Common Security and Defence Policy (CSDP), which was held in Bratislava. Mr Pajović had a presentation during the debate on the topic: "The EU as a global player: Looking for an Effective Multilateral diplomacy model". On the sidelines of the Conference, President Pajović met with Chairperson of the European Parliament's Committee on Foreign Affairs Elmar Brok and Minister of Foreign Affairs of Slovakia Miroslav Lajčak.
- On 15 September, President of the Parliament of Montenegro Darko Pajović took part in the European Conference of Presidents of Parliament of the Council of Europe member states, which was held in Strasbourg. Mr Pajović had a series of bilateral meetings with the highest officials of the Council of Europe. Mr Pajović informed his interlocutors on political developments in Montenegro ahead of parliamentary elections, having in mind the fact that opposition for the first time in history of Montenegro enters the election race from the positions of participating in the government and controlling the election process

- On 27 September, in Brussels, President of the Parliament of Montenegro Darko Pajović met with President of the Chamber of Representatives of the Federal Parliament of the Kingdom of Belgium Siegfried Bracke. The interlocutors voiced pleasure over the bilateral relations of the two states at the political level, agreeing that there was a lot of room for improvement of the cooperation at the economic level, especially in the fields of sustainable development and agriculture. They agreed to intensify cooperation of the Belgian and Montenegrin parliaments, with an emphasis on the working bodies in the field of European and Euro-Atlantic integration.
- On 4 October, President of the Parliament of Montenegro Darko Pajović paid an official visit to Romania. President Pajović voiced gratitude for rapid ratification which was of great significance not only for Montenegro but also for the region. President of the Montenegrin Parliament pointed out that friendly countries were sending a message to our citizens that Montenegro belonged in the West, with democratic, developed states and there was no more turning to the past and to destructive policies.
- On 6 October, President of the Parliament of Montenegro Darko Pajović was a guest of the Parliament of Latvia. On that occasion, President of the Parliament of Montenegro met with the delegation of the Parliament of Latvia, headed by Speaker of the Parliament Ināra Mūrniece. At the meeting they discussed the significance of Montenegro's accession to NATO and the EU, as well as the cooperation between the Parliament of Montenegro and Latvia. President Pajović has thanked for quick ratification of the Protocol, with which one step closer had been made to permanent peace and stability of Montenegro and the region.
- On 25 November, upon invitation by Speaker of the Croatian Parliament Božo Petrov, President of the Parliament of Montenegro Ivan Brajović attended the sitting of the Croatian Parliament where the Law on Ratification of the NATO Accession Protocol for Montenegro was adopted. During his meeting with the Speaker of the Croatian Parliament, President Brajović thanked Croatia for its strong support to European and Euro-Atlantic integration of Montenegro and expressed pleasure over the fact that Croatia was the first country he visited as President of the Parliament of Montenegro.
- On 14 December, President of the Parliament of Montenegro Ivan Brajović met with President of the Chamber of Deputies of Luxembourg and high officials of the NATO Parliamentary Assembly. President of the Parliament of Montenegro Ivan Brajović attended the vote on the NATO Accession Protocol for Montenegro, and prior to that, he met with President of the Chamber of Deputies of Luxembourg Mars Di Bartolomeo as well as with high officials of the NATO Parliamentary Assembly.

### ACTIVITIES OF THE VICE PRESIDENTS OF THE PARLIAMENT

- On 5 February, upon the invitation by members of the U.S. Congress, Vice President of the Parliament of Montenegro Suljo Mustafić attended the 64th National Prayer Breakfast, in Washington, whose host and main speaker was the American President Barack Obama. During the event gathering representatives of more than 160 states from all over the world, Mr Mustafić had meetings with representatives of parliaments of several states Austria, Germany, Serbia, BiH, Macedonia, Kosovo, and Albania.
- On 14 February, Vice President of the Parliament of Montenegro Suljo Mustafić paid a visit to Chicago. During the meeting with around one hundred members of the Association Culture Centre "Rumija" in Chicago, Mr Mustafić pointed out that the state, through its institutions, should devote more attention to all emigrants. He reminded of the diaspora's contribution to the renewal of independence and its help through numerous donor activities and financial assistance to families and relatives in the homeland.
- Upon the invitation by the Consulate General of Montenegro in Frankfurt, Vice President of the Parliament of Montenegro Suljo Mustafić and Chairperson of the Committee on International Relations and Emigrants Miodrag Vuković attended the celebration of 21 May, Independence Day of Montenegro, held on 7 May 2016 and titled "Montenegrin culture, literature and poetry".

### 4.4. PERMANENT DELEGATIONS

## Parliamentary Assembly of the Council of Europe (PACE)





During 2016, the Delegation of the Parliament of Montenegro to the PACE participated in ordinary sessions and numerous other activities of the Parliamentary Assembly, including meetings of the PACE committees and subcommittees and the PACE observation mission.

At the PACE Winter Session, held from 25 to 29 January, a new President and vice presidents of the Parliamentary Assembly were elected. Agenda of the session, among other things, included debates on: migrant and refugee crisis, fight against international terrorism, strengthening the protection and role of the protector of human rights, escalation of violence in Nagorno-Karabakh, situation in Kosovo, and corruption in the judiciary. The PACE also considered the request for granting the partner for democracy status, submitted to the Parliamentary Assembly by the Parliament of Jordan. An alternate member of the Delegation of the Parliament of Montenegro to the PACE Snežana Jonica took part in the session.

The PACE Spring Session, held in Strasbourg from 18 to 22 April 2016, was marked by debates on the refugee and migrant crisis in Europe, a stronger European response to the inflow of Syrian refugees, the human rights of refugees and migrants in the Western Balkans, as well as a new challenge of forced migration. Other items on the agenda included debates on assessing the impact of measures to enhance women's participation in politics, preventing the radicalisation of children, humanitarian concerns with regard to people captured during the war



in Ukraine, the key issues faced by the world regarding public health emergencies, and the fight against anti-Semitism in Europe. Head of Delegation Predrag Sekulić, member Marija Maja Ćatović, and alternate member Snežana Jonica took part in the session.

Key topics covered at the PACE Summer Session, held in Strasbourg from 20 to 24 June 2016, included the position of refugees in Greece, violence against migrants, functioning of democratic institutions in Turkey, transparency and openness in European institutions, and position of women in the armed forces. In addition to the above, MPs also debated on the culture and democracy, educational and cultural networks of emigrants, term of office and immunity of members of the Parliamentary Assembly, and the role of the Parliamentary Assembly as a pan-European forum for inter-parliamentary dialogue and cooperation. Head of Delegation Predrag Sekulić, member Goran Tuponja, and alternate member Snežana Jonica took part in the session.

The final ordinary Autumn PACE session in 2016 was held from 10 to 14 October in Strasbourg. Special interest was sparked by debates on the political consequences of the Ukraine conflict and on legal remedies for human rights violations in areas not under Ukrainian control, "Panama Papers", and fiscal and social justice, as well as cooperation with the International Criminal Court (ICC). The agenda of the session also included discussion on the protection of unaccompanied migrant minors, activities of the Organisation for Economic Co-operation and Development in the period 2015-2016 and the rights of the child with regard to surrogate mothers. Alternate member Snežana Jonica took part in the PACE Autumn Session.

In line with the Statute of the Council of Europe, Montenegro is entitled to a delegation consisting of three members and three alternate members in the Parliamentary Assembly. The Delegation of the 25th Parliament of Montenegro to the PACE in 2016 consisted of: Predrag Sekulić, Head of Delegation, Draginja Vuksanović, and Goran Tuponja, members of Delegation, as well as Marija Maja Ćatović, Rifat Rastoder, and Snežana Jonica, alternate members of Delegation.

## Parliamentary Assembly of the North Atlantic Alliance (NATO PA)



The Permanent Delegation of the Parliament of Montenegro to the Parliamentary Assembly of the North Atlantic Alliance (NATO PA) participated in several meetings and seminars held and organised by the NATO PA, including two annual sessions, held in Tirana and Istanbul.

Head of Delegation Mevludin Nuhodžić and member Obrad Mišo Stanišić participated in the visit to the Committee on the Civil Dimension of Security - Sub-Committee on Democratic Governance in Sarajevo, Bosnia and Herzegovina, and Belgrade, Republic of Serbia, in the period from 7 to 10 March, organised by the Parliamentary Assembly of Bosnia and Herzegovina and National Assembly of the Republic of Serbia. This visit was aimed at analysing the level of internal and external political development of Bosnia and Herzegovina and the Republic of Serbia and the related security challenges, with reference to European and Euro-Atlantic integration and development of geopolitical situation in the Western Balkan countries.

Member of the Permanent Delegation Obrad Mišo Stanišić took part in the Joint 91st Rose-Roth Seminar of the Mediterranean and Middle East Special Group and the Sub-Committee on Transatlantic Economic Relations, implemented in cooperation with the NATO Parliamentary Assembly and the Parliament of the Kingdom of Morocco, held on 20-22 April in Rabat, Kingdom of Morocco. The Joint Seminar was primarily devoted to the issues of internal and foreign policy priorities of the Kingdom of Morocco, common international strategy to combat the security challenges in the Middle East, fight against extremism: challenges and strategies thereof, security sector reform, situation in Libya and security in Sahel, as well as the issues relating to corruption, security, migration trends, and cooperation throughout the Mediterranean.



The Spring Session of the NATO Parliamentary Assembly (NATO PA) was held in the period from 27 to 30 May, in Tirana, Albania, and the host of this significant gathering was the Delegation of the Republic of Albania to the Parliamentary Assembly of the North Atlantic Alliance. On behalf of the Permanent Delegation of the Parliament of Montenegro, the session was attended by Obrad Mišo Stanišić. On 27 May, day one of the session, a meeting of the secretaries of delegations and a meeting of the Standing Committee were held. The meeting of the Standing Committee begun with warm words of welcome by the Chair addressed to the Permanent Delegation of the Parliament of Montenegro to the NATO Parliamentary Assembly, represented by Obrad Mišo Stanišić. After that, he addressed the participants in the sitting, and thanked for the invitation to attend the meeting, which resulted in Montenegro being given the opportunity to participate in it for the first time along with parliamentarians of the North Atlantic Alliance member states. In continuation of the meeting, the Draft Declaration on "A United and Resolute Agenda for NATO at the Warsaw Summit" was determined, presented by the Chairperson of the Defence and Security Committee Nicole Ameline, France, and Chairperson of the Political Committee Ojars Eriks Kalnins, Latvia, and they also presented the upcoming activities of this body and the NATO Parliamentary Assembly.

On 28 and 29 May, days two and three of the session, meetings of the following committees were held: Committee on the Civil Dimension of Security, Political Committee, Science and Technology Committee, and Science and Technology Committee.

On 30 May, day four of the session, Plenary Sitting was held, during which the participants were addressed by the following: Michael Turner, President of the NATO Parliamentary Assembly; Ilir Meta, Speaker of the Parliament of the Republic of Albania; Edi Rama, Prime Minister of the Republic of Albania; Milo Đukanović, Prime Minister of Montenegro, and Ambassador Alexander Wershbow, NATO Deputy Secretary General, followed by the time allocated for debate based on questions. In the final part of the Sitting, based on the discussion held, there was voting of participants on the draft Declaration "A United and Resolute Agenda for NATO at the Warsaw Summit".

On 2 June, members of the Permanent Delegation of the Parliament of Montenegro to the NATO PA met with the Delegation of the Committee on NATO of the Parliament of the Kingdom of Sweden, which was paying a working visit to Montenegro. Members of the Permanent Delegation of the Parliament to the NATO PA Obrad Mišo Stanišić and Ranko Krivokapić took part in the meeting, while the visiting delegation was composed of: Head of the Delegation of the Parliament of the Kingdom of Sweden to the NATO PA Björn von Sydow, Member of the Parliament Göran Petterson, Deputy Head of Mission of the Kingdom of Sweden at the Embassy in Belgrade Liselott Martynenko Agerlid, and Eva Hjelm International Affairs Adviser at the Parliament of the Kingdom of Sweden. The meeting was also attended by non-resident ambassador of Montenegro to Sweden Miroslav Šćepanović.

Member of the Permanent Delegation Obrad Mišo Stanišić attended the 92nd Joint Seminar Rose-Roth and Ukraine-NATO Interparliamentary Council (UNIC), Sub-Committee on NATO Partnerships, and Sub-Committee on Transition and Development, on the topic "Ukraine's Transformation in a Troubled Regional Context", held in Kyiv, Ukraine, from 14-16 June 2016, in cooperation with the Verkhovna Rada of Ukraine and with the support of the Kyiv based NATO Information and Documentation Centre.

The NATO Parliamentary Assembly, in cooperation with the Assembly of Kosovo, and with the support of the Swiss Government, organised the 93rd Rose-Roth Seminar on the topic "Assessing and Affirming Kosovo's Euro-Atlantic Perspective" in Prishtina, Kosovo, from 22-24 October. Member of the Delegation Obrad Mišo Stanišić participated on behalf of the Permanent Delegation to the NATO PA. The 93rd Rose-Roth Seminar of the NATO Parliamentary Assembly was devoted to the issues from among the challenges that Kosovo was facing, wider implications for regional and global security in this regard and other issues of concern for the Western Balkans and the Euro-Atlantic area.



Member of the Permanent Delegation Obrad Mišo Stanišić took part in the Joint Seminar of the Mediterranean and Middle East Special Group (GSM) and the Sub-Committee on NATO Partnerships (PCNP), implemented in cooperation with the NATO Parliamentary Assembly and the Parliament of the Republic of Italy, held in Rome, Italy, on 27-29 October. The gathering was mainly devoted to the issues dealing with the security situation in Libya and North Africa; management of migratory flows and border control; political consequences of the migration crisis in Europe and the United States; Western Balkans: a strategic nexus between the MENA Region and Europe; situation in Syria and Iraq, and radicalisation and terrorism in Europe. During his stay in Rome, Obrad Mišo Stanišić met with Ambassador of Montenegro to the Republic of Italy Anton Sbutega, and they considered current issues covered in the subject gathering and activities of the Permanent Delegation of the Parliament in the previous period.

The 62nd Annual Session of the NATO Parliamentary Assembly (NATO PA) was held in the period from 18 to 21 November, in Istanbul, Turkey, and the host of this gathering was the Delegation of the Republic of Turkey to the Parliamentary Assembly of the North Atlantic Alliance. On this occasion, the Parliament of Montenegro was represented by Head of Delegation Obrad Mišo Stanišić and member Ranko Krivokapić. The 62nd Annual Session of the NATO PA gathered the representatives of parliaments of 28 member states from the North America and Europe, associate and partner states, observer states, and other relevant representatives, with a goal of discussing common security issues of international nature.

Day one of the Session, 18 November, started off with the meeting of the secretaries of the delegations. On days two and three of the Session, 19 and 20 November, meetings of the following committees were held: Committee on the Civil Dimension of Security, Defence and Security Committee, Economics and Security Committee, Political Committee, Science and Technology Committee, and Standing Committee.

On day four of the session, 21 May, a Plenary Sitting was held, during which the participants were addressed by the following: NATO Parliamentary Assembly President Michael Turner; Speaker of the Grand National Assembly of Turkey Ismail Kahraman; President of the Republic of Turkey Recep Tayyip Erdoğan; President of the OSCE PA Christine Muttonen; NATO Secretary General and Chairman of the North Atlantic Council Jens Stoltenberg, followed by the Q&A.

In the context of the speech on NATO's open door policy and acceptance of new member states to full-fledged membership of the North Atlantic Alliance, NATO Secretary General and Chairman of the North Atlantic Council Jens Stoltenberg called for and urged the NATO member states which so far had not ratified the Accession Protocol for Montenegro to do so as soon as possible in order for Montenegro to become a full-fledged member by the following Spring Session of the NATO Parliamentary Assembly.

### **OSCE Parliamentary Assembly (OSCE PA)**



President Emeritus of the OSCE PA and President of the Parliament of Montenegro Ranko Krivokapić and MP Branko Čavor, as a substitute for the permanent member of the Delegation, participated on behalf of the Parliament of Montenegro in the 15th Winter Meeting of the OSCE Parliamentary Assembly, which gathered over 300 MPs from 57 member states. The Winter Meeting took place in Vienna, on 25 and 26 February.

The focus of the Winter Meeting, opened by Vice President of the OSCE PA Christine Muttonen, was migrant and refugee crisis and the forming of the platform for joint action of member states in order to overcome all challenges that stemmed from it.



Within bilateral meetings, President of the Parliament of Montenegro Ranko Krivokapić met with OSCE Secretary General Lamberto Zannier, and they discussed the current political developments in Montenegro and the region. The President informed him on the autumn protests and establishment of the parliamentary dialogue, with the support of the European Union. They mutually stated that free and fair elections were fundamental value that OSCE protected, and many separate institutions in the OSCE were devoted to this: OSCE Parliamentary Assembly, ODIHR, OSCE's Representative on Freedom of the Media and other. They stated that Montenegro was standing before a great challenge to provide all its citizens with their fundamental democratic right to freely express their will and obtain the government which was an undisputed expression of their votes. Without that, there are no basis conditions for democracy, permanent stability or prosperity of the state. The Delegation of the Parliament of Montenegro, which took part in the 25th Annual Session which took place in Tbilisi from 1 to 5 July 2016, consisted of President of the Parliament and Head of Delegation Darko Pajović, MP Slaven Radunović as a member of the Permanent Delegation and Branko Čavor as a substitute for a member.

The focus of the 25th Annual Session of the OSCE Parliamentary Assembly was the significance of parliamentary dialogue and promotion of cooperation among member states in order to combat all types of threats, primarily in the security sense, and the making of efforts with regard to de-escalation of the current conflicts.

President of the Parliament of Montenegro Darko Pajović addressed the attendees of the Plenary Sitting of the 25th Annual Session of the OSCE Parliamentary Assembly. During his address to MPs, President Pajović pointed out his pleasure over the fact that, despite many challenges, there was political stability and commitment towards improvement of the electoral process in Montenegro. Meetings of general committees were marked by considering resolutions, forwarded to the committees according to the issues they were in charge of, the election of new leadership, and presenting the reports by rapporteurs. Three resolutions of the committees became a part of the incorporated text of the Joint Declaration, which was adopted at the end of the Session. Emphasising the issues of building trust, the Declaration confirms the validity and historic role of guiding principles and common values of the Helsinki Final Act of 1975, including commitments in the political and military, economic, ecological, humanitarian dimension of security. During the discussion, member of the Parliament of Montenegro's delegation Slaven Radunović addressed the attendees. Emphasising the importance of the resolution by Margareta Cederfelt, which addressed the issues of fight against corruption and strengthening the rule of law, Mr Radunović emphasised that, at a global level, corruption was becoming one of pressing problems, representing a serious threat to society. Ms Cederfelt thanked for the pointing of out the resolution, while sharing the opinion on the negative effects of corruption, but she said that building trust and wide action represented a prerequisite for fight against this phenomena, which all member states have in common.

Following the adoption of the Declaration, there was voting on electing the President and vice presidents of the Parliamentary Assembly. After round two of votes, Christine Muttonen, member of the Parliament of Austria, was elected President of the OSCE PA, while the following were elected to a three-year term as vice presidents: Lithuanian MP Vilija Abramikienė, Azerbaijani Azay Guliyev, and Isabel Santos from Portugal. Member of the Romanian Parliament Viktor Dobre was elected to a one-year term as Vice President. The term of office of the President of the Assembly is one year, with the possibility of re-election to one more year.



## Parliamentary Assembly of the South-East European Cooperation Process (SEECP PA)

Member of the Permanent Delegation of the Parliament of Montenegro to the Parliamentary Assembly of the South-East European Cooperation Process Žana Filipović and substitute member Snežana Jonica took part in meetings of general committees, the Standing Committee, and the Third Plenary



Session of the SEECP PA, which took place in Sofia, on 10 and 11 June, within the presidency of the Republic of Bulgaria of this initiative.

The Third Plenary Session of the SEECP PA, chaired by Speaker of the National Assembly of the Republic of Bulgaria Tsetska Tsacheva, was devoted to the topic: "20 Years of SEECP - Region, New Reality, and Joint Perspective".

At the Plenary Session, through the participation of member states, the most important achievements of this organisation in the past two decades were emphasised, and in that regard, they particularly stressed that, with the establishment of the SEECP Parliamentary Assembly in May 2014, the cooperation of the countries in the region was elevated to a higher level. They also expressed the expectation that an agreement on the establishment of a permanent secretariat of the SEECP PA would be reached in the near future, which would give an additional impetus to the work of the Parliamentary Assembly. The Joint Declaration was adopted at the SEECP Plenary Session, as well as the Work Plan of the Parliamentary Assembly for the upcoming one-year period, during the presidency of the Republic of Croatia.

Member of the Parliament of Montenegro's Permanent Delegation to the South-East European Cooperation Process Parliamentary Assembly (SEECP PA) Dritan Abazović took part in the meeting of the General Committee on Economy, Infrastructure and Energy of the SEECP PA, which took place in Sofia, on 12 March, within the Bulgarian presidency of this initiative. During the meeting titled: "Improving infrastructure in the South-East Europe - accelerating the priority projects", the experiences of the SEECP member states in this field were considered, and the ideas aimed at improving traffic connectivity of the regional countries were presented. The Proposal for Resolution, established at the meeting, calls upon SEECP member states to promote inter-institutional cooperation aimed at the strengthening of expert capacities and sharing experiences and best practice, for the purpose of ensuring the inflow of investment in traffic infrastructure. The meeting recommended further development and implementation of "TEN-T", the comprehensive network in the South-East Europe, in accordance with relevant technical standards, and establishment of efficient traffic system, which would facilitate the full integration of the region in the EU transport system. Also, upon the proposal of MP Dritan Abazović, they agreed that the next meeting of the General Committee should be devoted to the topic: "Green energy, potentials and investments in the South-East region".

Substitute member of the Permanent Delegation of the Parliament of Montenegro to the Parliamentary Assembly of the South-East European Cooperation Process SEECP Genci Nimanbegu took part in the meeting of the General Committee on Social Development, Education, Research and Science of the SEECP PA, which took place in Tirana, on 9 April. During the meeting titled: "Protection of child rights in migration flows - call for protection of the under-age children in the South East European region - current issues regarding migration flows in the region" covered the issue preoccupying the region of the South East Europe, especially the SEECP member states, and those on the "Western Balkans route".



In the Proposal for the Resolution established in the meeting, the SEECP states were called to provide each child with access to more effective measures aimed at their international protection, that the case of each child should be regarded with special attention and approach, honouring reasonable deadlines, and all in the interest of the migrant children. All states were called to do more in order to avoid the unnecessary detention of children, with or without parents, in line with their immigrant status, but to use the least restrictive measures instead and adopt alternatives in detention which would be in the best interest of the children.

### **Central European Initiative Parliamentary Dimension (CEI-PD)**



Head of the Permanent Delegation of the Parliament of Montenegro to the Parliamentary Dimension of the Central European Initiative MP Miodrag Vuković took part in the Annual Meeting of the CEI Parliamentary Assembly and meetings of the general committees, which took place in Sarajevo, in the period 5-7 December, within the Bosnian presidency of the Initiative. The Session was dedicated to the topic: "The strategy for preventing and combating terrorism in the light of migration crisis". Within the main debate, the participants in the gathering were also addressed by MP Vuković who presented activities undertaken in Montenegro on solving problems caused by migrations and threatening terrorism. He emphasised that Montenegro would readily respond to all challenges, and that so far there had been no major problems with regard to migrants, considering that Montenegro was currently not on the direct migrant route. At the end of the Meeting, the Final Declaration was unanimously adopted, which summed up conclusions from the held Meeting of the Parliamentary Assembly of the Central European Initiative, calling for member states and EU institutions to continue close cooperation with the CEI member states aimed at continuation of assistance to the enlargement countries in reaching European standards and accelerating the EU enlargement process.

Chairperson of the Committee on International Relations and Emigrants and Head of Permanent Delegation of the Parliament of Montenegro to Parliamentary Dimension of the Central European Initiative (CEI-PD) Miodrag Vuković took part in the meeting of the General Committee on Political and Home Affairs of the CEI-PD, which took place in Ljubljana. This year's meeting was dedicated to the following topics: "EU prospects after Brexit", "Macro-regional EU strategies", "The Berlin Process – Paris-Balkan Summit" and "The refugee and migrant crisis". Addressing the participants in the meeting, Chairperson Vuković said that new times brought new challenges and unfortunately increasing, unknown until now, problems. Speaking of significance of the Berlin Process for the countries of the Western Balkans, Mr Vuković said that the initiative, which was primarily aimed at economic growth, social progress, establishing relations at the highest level, reconciliation through stimulating the youth exchange in educational projects, represented a new, additional value in the EU integration process and offered a new chance to the region to become economically stronger, safer and more secure.

MP Miodrag Vuković took part in the "Energy Union on the Way to Greater Self-Sufficiency: CEI Perspective on Trans-Adriatic and Trans-Alpine Energy Policies", organised by the Senate of the Republic of Italy and Veneto regional Government's Development and Energy Department, as a part of the activities of the Central European Initiative, on 11 November, in Venice. They emphasised that so for Montenegro has applied with a number of projects for the CEI funds, within its project activities, for whose implementation requested funds were approved, and with regard to that, they expressed pleasure that those funds were used. The total contribution of the CEI projects and activities in Montenegro is around four million euros, of which about 2.2 million euros were for regional projects including Montenegro, and 1.8 million directly related to Montenegro.



### 4.5. REGIONAL INITIATIVES

### **Adriatic-Ionian Initiative (AII)**



President of the Parliament of Montenegro Ranko Krivokapić took part in the XIV Conference of Speakers of Parliaments of the Adriatic-Ionian Initiative (AII), which took place in Split.

The conference was focused on challenges of migrations, particularly with regard to resolving numerous challenges of the states of the Adriatic-Ionian Initiative. They assessed that even though migrations were not caused by the states of the Adriatic-Ionian Initiative, this region must find a common answer and provide help to all in need, in line with European and international standards. Participants underlined that processes were humanitarian as well as security problem of Europe.

During the conference, President of the Parliament of Montenegro Ranko Krivokapić had meetings with his Croatian, Italian and Slovak counterparts.

At the end of the Conference, a Joint Statement was adopted.

# Conference of the Parliamentary Committees on European Integration/Affairs of the States Participating in the Stabilization and Association Process in South East Europe (COSAP)

The 12th meeting of the Conference of the Parliamentary Committees on European Integration/Affairs of the States Participating in the Stabilization and Association Process in South East Europe (COSAP) took place in Sarajevo, on 8 April 2016. The meeting was hosted by the Parliamentary Assembly of Bosnia and Herzegovina, and the agenda covered topics such as: more intensive economic development and progress towards the European Union, influence of refugee crisis on the region, and regional response to the global problem of terrorism. The Parliament of Montenegro was represented by members of the Committee on European Integration Azra Jasavić and Predrag Sekulić.

### 4.6. COOPERATION WITH FOREIGN AND INTERNATIONAL ORGANISATIONS

### **OSCE**

Montenegro has continued cooperating with the OSCE Mission to Montenegro in 2016.

In the framework of the mentioned cooperation, the OSCE Mission supported the work of the Gender Equality Committee regarding the preparation of the Action Plan for a Gender Responsible Parliament of Montenegro, hiring experts from the Office for Democratic Institutions and Human Rights (ODIHR), who drafted Guidelines that served as a guide to creating this plan. In cooperation with the OSCE Mission to Montenegro, the Committee organised several meetings and a workshop intended for drafting a plan. On 18 July, in accordance with the Action Plan for Strengthening the Legislative and Oversight Role of the Parliament of Montenegro, the Committee adopted the Action Plan for a Gender Responsible Parliament of Montenegro, for the period September 2016 - September 2018. In cooperation with the OSCE Mission, the Parliament of Montenegro hosted a two-day meeting of secretaries general of parliaments in the region "Strategic and annual planning in parliaments - challenges and results", held on 1 and 2 June 2016.



The panel covered topics such as "Challenges and opportunities in parliaments" and "Importance of communication in the strategic approach to parliamentary development", and the participants exchanged opinions on and experiences in the field of human resources development and ICT planning. Participants in the meeting were secretaries general and parliamentary staff from Albania, Bosnia and Herzegovina, Kosovo, Macedonia, Serbia, and Montenegro.

In September 2016, with the support of the OSCE, a working visit to the Parliament of Montenegro for officials of the Albanian Parliament was organised. On that occasion, ten employees of the Albanian Parliament visited the Parliament of Montenegro, from the Public Relations and Media Service, as well as the Library and Research Service. During the visit, the activities of the Parliamentary Institute and the Department for Public Relations and Protocol of the Parliament of Montenegro were presented, and a special attention was paid to the program of Democracy Workshops.

During the past year, a number of trainings for the parliamentary expert service was organised, which were structured in three modules: Management and Leadership, Communication and Successful Meeting and Conflict Management. The programs aimed to strengthen managerial knowledge and skills of the parliamentary service, with a focus on managerial staff, development of sustainable and modern structures, increasing professionalism and respecting good governance standards.

In May 2016, the Parliamentary Lexicon was printed as a product of close cooperation between the Parliament and the OSCE Mission, which financially supported its drafting. The Lexicon gives an overall review of more than 350 terms used in parliamentary life, as well as terms from related areas, in Montenegrin and English, including their definitions, wider use and application in the narrow context of the Parliament of Montenegro.

With the support of the OSCE Mission, the parliamentary Library Fund was enriched.

### **Westminster Foundation for Democracy (WFD)**

On 19 May 2016, the Parliament of Montenegro and the Westminster Foundation for Democracy (WFD) signed a memorandum of understanding with the aim of forming the Parliamentary Budget Office (PBO), as part of a two-year project implemented by the WFD with the support of the UK Embassy in Podgorica.

The Parliamentary Budget Office (PBO) started working on 16 September 2016, and two researches work there at the moment, in line with the abovementioned memorandum.

The work of this office is focused on providing support to MPs in carrying out the parliamentary budget control. According to the practice of the most developed parliaments, the project intends to create an expert core that will enable the Parliament of Montenegro to participate more significantly in the budget cycle, and MPs to have at their disposal support in analysing and discussing key budget documents and laws with significant fiscal impacts.



### **NDI**

During 2016, a cooperation with the National Democratic Institute (NDI) has been continued through the Western Balkans Legislative Strengthening Initiative (WBLSI), funded by the National Endowment for Democracy (NED).

As a part of this initiative a meeting of the Secretary General of the Western Balkans countries' parliaments was held in January in Riga in cooperation with the Latvian parliament. Focus of this meeting was on the public participation in the work of the parliament and implementation of new technologies aimed at raising the efficiency and transparency of the parliamentary work. Regional workshop "Open parliament - involved citizen" was held in February in Častá - Papiernička in cooperation with parliament of Chile and support of

the Slovak parliament within the Open Parliament Working Group (LOWG).



## V TRANSPARENCY OF WORK AND OPENNESS OF THE PARLIAMENT

In 2016, numerous and intensive activities of the Parliament of Montenegro with respect to transparency and openness of work were continued. In addition to the media regularly following parliamentary events and reporting on them, regular activities in this field include publishing of all relevant information on the work of the parliament and of documents created in the legislative process on the parliamentary website, and publishing of action plans, annual and other types of performance reports, reports on use of funds with the report on public procurement, as well as monthly newsletter "Open Parliament". Furthermore, live broadcasting of all sittings of the Parliament via online streaming is enabled, as well as following them via a YouTube channel. An important segment of openness of the parliament is providing unrestricted access to the building of the Parliament.

In addition to that, the Parliament of Montenegro strives to make the web pages of the Parliament accessible and easy to use for the broadest public.

In this group of activities, collective and individual visits of citizens to the Parliament are certainly significant. The Parliament also regularly responds to all requests for free access to information, in accordance with the law.Participation of representatives of the civil sector in meetings of the working bodies, as well as addressing the working bodies in writing, was also recorded in this reporting period, and the practice of answering all questions from the media has also been continued.

Students and teachers continue to show interest in participation in the educational programme Democracy Workshops "Barbara Prammer".

Below you can find more detailed information on several aspects of transparency of work of the Parliament, such as: Cooperation of the Parliament with the media, requests submitted to the Parliament in accordance with the Law on Free Access to Information, cooperation with the civil sector organisations, visits to the Parliament, exhibitions, newsletter "Open Parliament", activities within Democracy Workshops "Barbara Prammer" programme, as well as information on the session of Women's Parliament, and recodring and broadcasting of sittings, which ensures the principle of openness and transparency of parliamentary work.

### 5.1. PARLIAMENT AND MEDIA

In the period January - December 2016, the Department for Public Relations and Protocol of the Parliament of Montenegro issued 268 permanent

credentials for journalists and camera crews/photo-reporters, while a total of 270 daily credentials were issued.

In the same period, 100 individual questions by the journalists, regarding parliamentary activities, were processed and answered.

The citizens are able to ask questions via the website of the Parliament, and in the period from January to December 2016, 20 such requests were addressed to the Department for Public Relations and Protocol.

During the said period, a total of 26 press conferences were held in the Parliament of Montenegro.

3,518 pieces of information, announcements and statements illustrated with 5,475 photos were posted on the News page of the Parliament's website;



### 5.2. FREE ACCESS TO INFORMATION

The Parliament of Montenegro, in this reporting period as well, continued with the practice of regular responding to all requests for access to information, within deadline prescribed by the Law. Furthermore, the Parliament of Montenegro regularly publishes on its internet presentation decisions and other individual acts which are significant for rights, obligations, and interests of third persons, as well as information for which access was granted upon request. In 2016, as in the previous period, the requests for access to information were most frequently submitted by the NGOs. In the reporting period, a total of 88 requests for free access to information (with 94 items/sub-requests) were submitted to the Parliament of Montenegro, and they were answered to in the following manner:

- for 30 requests access was granted (for one of these requests, the access to a part of information was partially limited due to privacy protection, and for one of these requests access was partially denied in the interest of prevention, investigation and prosecution of perpetrators of criminal offences and performing official duties);
- for six requests the information was already available on the website of the Parliament of Montenegro (response by announcement);
- the submitters abandoned two requests;
- for three requests access was partially granted, mostly because of lack of possession of all the requested information:
- for 25 requests access was denied because the Parliament did not possess the requested information (for one of these information, the access was partially denied, because the submitter of the request was provided with the access to information in the previous six months).

Preparation of response to 22 requests, submitted after 21 December, is ongoing.

In the reporting period, more accurately in January 2016, one request, submitted at the end of 2015, was responded to.

The appendix of this Report contains a detailed tabular overview with data on submitters of requests for access to information, date of reception and of response, number of items, as well as the type of response.

### 5.3. COOPERATION WITH CIVIL SECTOR

On 29 and 30 October, upon the initiative of the Montenegrin Association of Political Science Students – MAPSS, the simulation of parliamentary practice was organised in the facilities of the Parliament.

The event gathered 40 students from all study years, where during two days they discussed the topic "Introducing Compulsory Military Service", simulating the work of parliament within parliamentary MP groups, negotiation between the groups, and finally, the work of the parliamentary session to discuss the proposal for the law.

The simulation was completed by delivering recognition for the best speaker, party delegate, negotiator and party leader.



### 5.4. VISITS, EXHIBITIONS AND OTHER EVENTS

During the year, multiple group and individual visits were organised to the Parliament of Montenegro, as well as visits by foreign delegations and visits by representatives of domestic and foreign organisations. Two exhibitions, one conference, and several separate events were organised.

- In January, a group of eleven students of the fifth and sixth grade of the Knightsbridge Schools International (KSI) Montenegro from Tivat visited the Parliament of Montenegro.
- Participants of the Montenegro international Model United Nations visited the Parliament in April, in the organisation of the SAMS (Student Association for International Cooperation at the Faculty of Political Sciences, University of Montenegro).
- •Tour of the Parliament for participants of the Conference of Secretaries General as well as tour for interested citizens.
- A visit to the Parliament of Montenegro was organised for the Franco-German Society in September, as well as the visit for staff of the Albanian Parliament.
- Members of the student organisation MAPSS (Montenegrin Association of Political Science Students) held a simulation of the parliamentary practice in the facilities of the Parliament of Montenegro (more information available in the part of the Report titled Cooperation with the Civil Sector)
- •The Conference "Freedom of expression and accountability of Media", organised by the Parliament of Montenegro in cooperation with the Council of Europe, and dedicated to the role of the public broadcasters, commercial media, and investigative journalism in providing conditions for protection and promotion of the freedom of expression and public debate, but also accountability of the media, pursuant to their strength and influence in society, was held on 22 February.
- Ahead of the special sitting devoted to the 10th anniversary of declaration of Montenegro's independence, a mini concert of piano and flute was held on 3 June

- On July 1, President of the Parliament of Montenegro Darko Pajović and President of the Union of Municipalities of Montenegro Slavoljub Stijepović signed the Agreement on Cooperation between the Parliament of Montenegro and the Union of Municipalities. The Agreement on Cooperation between the highest legislative body and the Union of Municipalities is primarily aimed at improving the system of local self-government through the strengthening of institutional dialogue between state and local authorities for the purpose of creating the conditions for more efficient and better provision of services to citizens and the economy by the local self-government.
- President of the Parliament of Montenegro Darko Pajović presented the 13th July Award for 2016. This year's winners of the 13th July Award are Miladin Šobić, Milorad Popović, Igor Đurović and Veljko Bulajić, while the lifetime achievement award is won by VeljkoBulajić.
- The exhibition of tapestries titled "The thread is a trail", whose authoress is MP Jelisava Kalezić, was opened in the Hall of the Parliament of Montenegro. The exhibition was organised with the support of the Gender Equality Committee, on the occasion of the 70th anniversary since women in Montenegro gained the right to vote, 75 years since women participated for the first time in the election of local authorities in Berane and 75th anniversary of the 13th July Uprising. The exhibition presented tapestries made in the period 1972-2016.

- On 29 July, President of the Parliament of Montenegro Darko Pajović signed the Cooperation Agreement with 57 non-governmental organisations. The Cooperation Agreement between the Parliament of Montenegro and non-governmental organisations in Montenegro is aimed at strengthening trust between the Parliament and non-governmental organisations as well as creating sustainable partnership based on the principles of transparency, openness and mutual respect.
- At the ceremony in villa "Gorica" of 13 September, President of the Parliament of Montenegro Darko Pajović presented a total of 2,593 certificates of attendance at the educational programme Democracy Workshops "Barbara Prammer" of the Montenegrin Parliament to 54 representatives of Montenegrin primary schools from 17 municipalities.
- Exhibition of artworks from the art collection of the Parliament of Montenegro on the occasion of Parliamentarism Day was held on 31 October. The exhibition contains only a part of the artworks selected from the parliamentary collection which contains 45 artworks by 32 painters, mostly from Montenegro. In addition to the artworks of professional artists, the collection also contains works of autodidacts who achieved international recognition for their works. At the opening of the exhibition, a mini concert of flute and violin was held.



• On 29 December, President of the Parliament of Montenegro Ivan Brajović presented awards to the best employees of the Parliament of Montenegro in 2016. In his opening statement, President Brajović expressed deep belief in parliamentary success, which would come as a result of devotion and joint work of MPs and staff of the Parliament of Montenegro. During the ceremony of presenting awards, students of music school "Vasa Pavić" Jana Božović, violin, and Vedran Galičić, guitar, presented themselves to the employees

### 5.5. DEMOCRACY WORKSHOPS



In 2016, a total of 213 workshops were organised within parliamentary programme Democracy Workshops "Barbara Prammer", attended by 4,622 students, as well as 279 teachers from 75 primary schools from all over Montenegro. In the course of 139 workshops on the topic "Democracy and Parliament", 29 workshops on the topic "European Union", 41 workshops on the topic "Human Rights", and four pilot workshops on the topic "Participation", a total of 124 children's newspapers were created as well as 54 radio features and 35 TV features. In 2016, eleven mobile workshops were held, in eight Montenegrin primary

schools, in the territory of five Montenegrin municipalities (Bar, Budva, Cetinje, Nikšić and Mojkovac).

Leslie Freriksen, Political and Economic Chief of the U.S. Embassy in Podgorica, visited the Democracy Workshops.

A workshop was held with Upton Court Grammar School students from the town of Slough, United Kingdom of Great Britain and Northern Ireland, on the topic "Democracy and Parliament", as well as a workshop with attendees of the English Access Microscolarship Program, who also attended a workshop on this topic.

### **5.6. WOMEN'S PARLIAMENT**

On 8 March, President of the Parliament of Montenegro Ranko Krivokapić opened the fifth session of the "Women's Parliament", and pointed out that a woman was the foundation of a Montenegrin house, the foundation of the state of Montenegro, and that both in peace and war times women were the bravest part of society, which preserved the belief that Montenegro was invincible. In her introductory speech, Chairperson of the Gender Equality Committee Nada Drobnjak said, among other things, that this was an important year marking 70 years since women in Montenegro obtained full suffrage, but she also invited everyone to work more on exercising women's human rights at all levels.

### 5.7. RECORDING AND BROADCASTING OF SITTINGS

The Parliament continues the practice of broadcasting the sittings of the Parliament using its own capacities.

In the reporting period, a total of 91 days of sittings of the Parliament have been covered, and 352 events such as committee meetings or other meetings, as well as press conferences. Among other things, the Fifth Session of the "Women's Parliament" was held and meeting of the SAPC. Sittings of the Parliament are broadcasted live via the Internet, and they remain available on a YouTube channel.

In order for the Parliament of Montenegro to keep up with new technologies, the outdated conference systems in the Blue Room and the Small Blue Room have been replaced by a modern conference system and accompanying multimedia content, such as a presentational LED display and simultaneous translation.

The Section carries out recording and editing of audio/video materials about the activities of the President of the Parliament of Montenegro and makes the material available to the media and the public through the cloud archive and YouTube channel.



## VI ADMINISTRATIVE CAPACITIES

### 6.1. HUMAN RESOURCES

In 2016, a new Human Resources Development Strategy was revised, which meant analysing implemented activities and achieved results. After the revision, we have a document defining the goals and activities that, apart from the standard ones, repeated from year to year, are mainly focused on establishing internationally recognised standards in quality of management and work, and on creation of conditions for taking over and performing new tasks after obtaining the status of a member of the European Union. In addition to revision of the Strategy, the 2016 Programme for Professional and Special Training and Development was also adopted, defining specific trainings needed for the employees of the Parliamentary Service in order to further enhance their knowledge and skills and thus improve their work performance. Furthermore, the Human Resources Plan of the Parliamentary Service was adopted, which is obligation stemming from Article 149 of the Law on Civil Servants and State Employees. Human Resources Plan of the Parliamentary Service presents individual data on employees of the Service of the Parliament of Montenegro, and the requirements for new hiring in 2016. On 31 December 2016, there were 155 employees in the Parliamentary Service. That number also covers the following: Secretary General, Head of the Cabinet of the President, one assistant Secretary General, 5 advisors to the President of the Parliament of Montenegro, and 147 civil servants and state employees. The total number of employees does not include 2 employees with suspended employment in the parliamentary service.

The total number of employees does not include 17 advisors to the President and vice presidents of the Parliament of Montenegro, and one assistant Secretary General, who are exercising their right upon termination of office.

As in the previous years, great attention was paid to training and professional development of employees. In March, the 2016 Training Plan was adopted, as an integral part of the 2016 Special Programme for Professional Training and Development, together with the new Human Resources Development Strategy for the period 2016-2018. The Training Plan envisages 13 trainings for employees in the Parliament of Montenegro, and for each of them the following was clearly determined: target group, purpose of the training, time of implementation, as well as partner for implementation of the training, if the training is organised in cooperation with other organisations. In the reporting period, a large number of trainings were held, on which the Human Resources Management Bureau continuously keeps records. In the period from 1 January to 31 December 2016, 62 trainings were held, attended by a total of 180 attendees. Out of this number, eight trainings were implemented from the 2016 Training Plan. The employees attended 16 trainings organised by the Human Resources Administration, while additional 38 trainings were provided through cooperation with other domestic, foreign, and international organisations.



The practice of awarding the best civil servants and state employees of the Parliament also continued in 2016. At the awarding ceremony, President of the Parliament of Montenegro Ranko Krivokapić thanked the employees on their contribution of dedicated work and efforts and presented awards to the best civil servants in 2016: Marija Vulić, Demir Mujević and Nela Škatarić. A fitting gift was presented to Nađa Vukićević, due to retirement.

### 6.2. LIBRARY AND RESEARCH

In 2016, the Research Centre prepared nine research papers, containing a total of 200 pages, responding to all the submitted requests in accordance with the prescribed procedures, including: six papers at the request of MPs, two at the request of the Secretary General and one request at the initiative of the Centre. The research papers are available on the website of the Parliament of Montenegro, and an appendix of the Report lists all research papers written in 2016.

In the reporting period, the Research Centre continued to actively cooperate with the European Centre for Parliamentary Research and Documentation (ECPRD), and it drafted and sent replies, in the form of brief information drafted in English, to 75 requests sent by parliaments - members of the ECPRD network.

### 6.3. INFORMATION TECHNOLOGY

In addition to its regular activities in maintaining the information and communication system of the Parliament of Montenegro, during 2016 the IT Section continued to carry out activities to improve the information and communication infrastructure of the Parliament. During 2016, the following activities were carried out: a new Wi-Fi system has been introduced in all facilities of the Parliament of Montenegro, virtualization of the complete server infrastructure has been carried out, the new parliamentary domain skupstina.local has been introduced with all the accompanying services and migration of all computers, the parliamentary site has been redesigned, an independent internet link has been established, the degree of protection of the information system of the Parliament has been increased, by renewing licenses and upgrading of the security software, the electronic information management system has been implemented, as well as other software solutions, softwares for blind and partially sighted persons were bought as well as other activities.

Also, during 2016, the Section worked on preparation of projects, whose implementation would significantly improve the work of the information and communication system of the Parliament.

Due to the inadequate administrative capacity of the State Election Commission, the IT Section of the Parliament of Montenegro provided IT support to the State Election Commission during the organisation of the electoral process in 2016.




## VII FINANCES

Planned Budget of Montenegro amounts to 2,125,615,876.83€, of which 771,892,740.40€ belongs to the operating Budget.

The Budget of the Parliament amounting 9,656,645.78€ amounts to 1.25 % of the operating Budget of Montenegro or 0,45% of the total Budget of Montenegro. The funds planned by the 2016 Budget Law of Montenegro were allocated for three programmes:

- Programme Enhancing Legislative Infrastructure 4,880,981.46€
- Programme Administration 4,675,664.32€
- Programme Funding of the weekly "Koha Javore" 100,000.00€




### Programme - Enhancing Legislative Infrastructure




Overview 3: Comparative spending on the Enhancing Legislative Infrastructure Programme by positions for 2014, 2015 and 2016.




### <u>Programme – Administration</u>
