I would like thank you and the Office for Democratic Institutions and Human Rights (ODIHR) for continuous support provided to the Parliament of Montenegro in the previous period. Cooperation between Montenegro and ODIHR represent a model of mutual understanding and I am convinced that our continuing efforts to improve electoral legislation will additionally reinforce our relations.
